

**SR NAGAR CRIME TEAM ARRESTED ONE CHAIN SNATCHER AND HIS
CO-ACCUSED, DETECTED (10) CASES OF HYDERBAD & RACHAKONDA
COMMISSIONERATES AND RECOVERED (4.5) TULAS GOLD ORNAMENTS AND THREE
BIKES – ALL W/RS. 3,00,000/-**

On 30.06.2017 at 1730hrs the Crime team of SR Nagar P.S. under the head of Mr. P. Sateesh, Detective Inspr. of Police, Mr. G. Srinivas, Sub-Inspr. of Police(Crimes) of SR Nagar P.S with the help of M. Eswar, N. Purnachandar Rao, N. Kiran Kumar, G. Bhaskar and J.V. Nageswara Rao apprehended the below two accused persons at Food World, Ameerpet while conducting vehicle checking, who was moving under suspicious circumstances.

DETAILS OF THE ACCUSED PERSONS:

1. **Dasari Surender** s/o late. D. Sambaiah, age 28-years, Car Driver, ST-Yerukala, r/o near Perla Darga, Bhupeeshguptha Nagar, Nandanavanam, Meerpet, Saroor Nagar, Hyderabad, n/o Nagaram(Village), Nekkonda(Mandalam), Warangal Dist. (**Chain Snatcher**)
2. **Rasoori Vijaya Krishna** s/o R. Kotaiah, age about 20-years, Catering Worker, SC-Mala, r/o FF-2, Block No. 90, Nandanavanam, Saroor Nagar, Ranga Reddy Dist, n/o Oorlapalem(Vilage), Singarai Konda(Mandalam), Prakasham (Dist), A.P. (**Motor Vehicles lifter**)

MODUS OPERAND:

The accused A-1 is a habitual cum notorious Chain Snatching offender and also commits bodily offences like murders, hurts, kidnaps. Earlier he taken supari for murders, involved in chain snatchings and Two Wheeler Offences in both Hyderabad and Rachaonda Commissionerates. The A-2 is one of the associate of A-1 who commits Bike and cell phones thefts.

PREVIOUS HISTORY:

A-1 is a native of Warangal Dist and he was addicted bad habits. Due to these bad habits/ addictions he started bodily offences by taking supari for commits murders. In the month of December, 2008 he was committed one murder to one Apparao who eloped daughter of one Saree Centre owner, in the limits of Chikkadpally P.S, by taking Rs. 75,000/-. In the year 2014 he was involved in one Kidnap case of one Hostel owner from Ayyappa Society by taking Rs. 50,000/- in the limits of Madhapur P.S. In the year 2014 he conspired in a murder of one B.J.P. leader Gopal in the limits of Kukatpally vide Cr.No.886/2014 of PS Kukatpally. Earlier he was also involved in chain snatching cases of Chikkadpally P.S., Musheerabad P.S., Mailardevpally P.S., Samshabad P.S. due to his dangerous activities on 16.02.2016 he was detained under PD Act by Chikkadpally P.S. and he was released on 16.02.2017 from Jail and after released from PD Act again he started the present offences.

PRESENTLY A-1 INVOLVED CASES:

1. In the month of May 2017, A-1 along with his associates involved in one attempt to murder case who stabbed three persons under Saroor Nagar P.S. limits, vide Cr.No.320/2017 U/Sec.147, 148, 324, 307 r/w 149 IPC of PS Saroornagar.

2. In the month of May 2017, A-1 came on bike at Madhura Nagar and misbehaved with one lady and stolen her gold chain from her neck, vide Cr.No.378/2017 U/Sec.354, 379 IPC of PS SR Nagar.
3. In the month of June-2017, A-1 along with one Salman committed gold chain Snatching in Nallakunta P.S. limits and snatched away 4-tulas gold, vide Cr.No.109/2017 U/s.392 IPC of PS Nallakunta. In this case A-2 was arrested by Nallakunta P.S. also committed one gold chain in RTC Bus under S.R. Nagar P.S. limits, vide Cr.No.438/2017 U/S.379 IPC of PS SR Nagar.
4. Apart from this he along with A-2 committed (03) two wheelers from S.R. Nagar limits.(Sl.No.1 to 3 mentioned below)

A-2 INVOLVED CASES:

1. A-2 involved in (03) cases from Meerpet P.S. limits.(Sl.No.8 to 10 mentioned below)
2. Apart from this, he has been involved (03) two wheelers from S.R. Nagar limits along with A-1.(Sl.No.1 to 3 mentioned below)

On 30-06-2017 at about 1730 hours A-1 along with A-2 roaming on Mastro Bike at food World with intention to commit snatching at Ameerpet meanwhile both were apprehended by S.R. Nagar crime team.

The accused person **Nagaraju** and he addicted for bad vices like drinking alcohol and smoking cigarettes due to bad friend ship. He wants to roam freely here and there so they hatched a plan to commit theft so that he can fulfill for his lavishly needs. In that process he met with his friends namely **Shiva** and **Yesu** they used to lingering with each other and used to move very closely. Then Shiva and Yesu hatched a plan to commit any theft and simultaneously informed to same Immediately he expressed his willingness to commit theft. As per their plan they came to JBS on 11-06-2017 at 11:00 PM and waiting for opportunity, in mean time they found the complainant Sri M Vijay Kumar by walking came to Secunderabad Club and asked his phone to make a call urgently. He gave his Motorola E3 Power, numbers in the phone - 7981547725, 8184821894 and they fled away

To that effect a case in Cr. No. 185/2017 has been registered at Marredpally Police Station on 11-06-2017 & the other two offenders **Shiva** and **Yesu are in absconding**.

On 30-06-2017 at 20:20 hrs the accused person **Nagaraju** arrested and remanded to judicial custody on 01-07-2017.

HISTORY

The accused A-1 residing at H.no. 9-103, Gandhi maisamma, Medchal Dist and working as Astrologer since 20 yrs. The accused A-1 having possession of antique Kalabhairava idol the same was expressed with A-2 Manne Ravi & A-3 Raman Goud. The accused A-2, A-3 informed the A-1 that they also possessing one Ganesh pancha loha idol and Durga matha idol with A-3 and shown their willingness to sale the fake panchaloha idols. For which the A-1 told them that if the idols sold to needy customers they can earn high prices by cheating the innocent people. The accused persons A-1 to A-3 hatched a plan to sale the idols by believing the customers as the idols are Gold/Antique idols and informed the same to their friend A-4 Gangadhar, A-5 Siddeshwar. On 30-06-2017 the accused persons A-1 to A-7 came to cantonment park, near JBS in one car and on bike. While they are waiting in park to deliver the idols to unknown buyer in the mean time suddenly the police have surrounded them and taken them into custody.

To that effect a case in Cr.No. 203/2017 has been registered at Marredpally Police Station on 01-07-2017.

The Modus Operandi of the accused persons A-1 to A-7 is to cheat the innocent people by believing the customers as the idols are Gold/Antique idols.

A wide manhunt was organized for apprehending the accused persons A-1 to A-7 on credible information on 30-06-2017 at 21:00 hrs at Cantonment park near Jubilee Bus Stop, Secunderabad apprehended the accused persons A-1 to A-7. After recording the confessional statements of A-1 to A-7 seized the above mentioned property.

On 01-07-2017 at 0030 hours the accused persons A-1 to A-7 were arrested and being produced them before the Hon'ble court for judicial custody.
