

**APPREHENSION OF TWO PERSONS WHO WERE IN  
POSSESSION OF NARCOTIC DRUG – SEIZED (21.5) KGs  
OF GANJA FROM THEIR POSSESSION**

On 01-07-2018, the sleuths of Commissioner's Task Force, West Zone team, Hyderabad, apprehended (2) accused persons at backside of Prakash Theatre, Seetarampet, Mangalhat, Hyderabad who were indulged in possession of "Ganja" a Narcotic substance and trying to sell the same to the needy customers. **Seized (21.5) KGs of Ganja, (1) Bajaj Pulsar bike B.No.AP24 AS 3862 (Black colour) and (1) Cell phone** from their possession.

**Details of the Accused:**

1. Sagar Naresh S/o Sagar Nukaraju, aged 25 yrs, Occ: Working as labour in Sri Laxmi Kaju Company, Tuni, East Godavari, R/o Kothapally(V), Kotavatla(M), Vishakapatnam, N/o H.No.4-10, Guduru(V), Bibi Nagar(M), Yadadri.
2. Sagar Karthik S/o Sagar Nukaraju, aged 22 yrs, Occ: Pvt. Employee in APEPDCL, R/o Narsipatnam(V), Goligonda(M), Vishakapatnam, N/o H.No.4-10, Guduru(V), Bibi Nagar(M), Yadadri.

**Brief History of Accused:-**

The accused Sagar Naresh is native of Gairampeta(V), Goligonda(M), Vishakapatnam District. About 30 years back his parents shifted to Guduru(V), Bibi Nagar(M), Yadadri for livelihood and settled at the same place. He studied upto SSC at Guduru. He is having two brothers. In the year 2016 he got married with one Narsa @ Nandini and blessed with one son. At present he is staying with his wife and son at his father-in-law's house at Kothapally(V), Kotavatla(M), Vishakapatnam and working as labour in Sri Laxmi Kaju Company, Tuni, East Godavari.

The accused Sagar Karthik is younger brother of accused Sagar Naresh. He completed his B.Tech studies at Guduru. At present he is working in APEPDCL at Narsipatnam(V), Goligonda(M), Vishakapatnam..

**Modus operandi:-**

The accused Sagar Naresh used to go to his native place regularly i.e. Gairampeta(V), Goligonda(M), Vishakapatnam District to meet his friends. About one year back one of his friends by name Bala R/o Gairampeta(V), Goligonda(M), Vishakapatnam informed him that by selling of Ganja in Hyderabad will get huge money and asked to come with him to purchase Ganja from agency area of Vishakapatnam on lowest price and to sell the same in Mangalhat area of Hyderabad on higher price and agreed to give him Rs.5000/-. On which the accused Sagar Naresh agreed with him. The Bala introduced one Benna Swamy, R/o Gairampeta(V), Goligonda(M), Vishakapatnam, to the accused Sagar Naresh by informed him that he is supplying Ganja to him. About six months back the accused Sagar Naresh along with Bala called to Benna Swamy and asked to sell Ganja to them. On which the said Benna Swamy handed over Ganja to them at a bus stop at Vishakapatnam. Later they both came to Hyderabad along with Ganja and sold the same in Mangalhat area and went to their native place. In this manner the accused Sagar Naresh came to Hyderabad for two times to sell the Ganja in Mangalhat area. About three months back the said Bala was arrested by Narsipatnam Police in Ganja case and the Police remanded him to judicial custody.

Later the accused Sagar Naresh hatched a plan to purchase Ganja from Benna Swamy on lowest price and used to sell the same in Mangalhat area of Hyderabad on higher price to earn easy and illegal money. About one month back the accused Sagar Naresh purchased 5 KGs Ganja (Rs.2000/- per 1 KG) from Benna Swamy and came to Mangalhat area and sold the Ganja to the needy persons for Rs.5000/- per 1 KG. After selling Ganja the accused went to his native place.

About one week back the again the accused called to Benna Swamy and asked to sell huge quantity of Ganja to him. On which the said Benna Swamy sold (21.5) KGs Ganja to him at a bus stop at Vishakapatnam. Later the accused went to his residence at Guduru(V), Bibi Nagar(M), Yadadri and kept the Ganja in his residence. Today i.e. on 01-07-2018 the accused Sagar Naresh along with his brother Sagar Karthik came to back side of Prakash Theatre, Seetarampet, Mangalhat, Hyderabad on Bajaj Pulsar Bike B.No.AP24 AS 3862 along with (21.5) KGs Ganja and trying to sell the same to needy customers, in the meantime we apprehended them along with Ganja.

The accused persons along with the seized material were handed over to SHO, Mangalhat PS, Hyderabad for further investigation.

**CONDUCTED RAID AT MASSAGE CENTRE – APPREHENDED ONE ORGANISER, RECEPTIONIST AND (02) WOMEN WORKERS**

On 30-06-2018, the sleuths of Commissioner's Task Force, Central Zone Team along with Team Abids Police conducted raid at one Massage Centre Parlour M/s S.S. Natural Family Spa and Saloon, Near Chiragali Lane, Abids, Hyderabad in which they are arranging cross massage illegally to their customers and apprehended one organizer, receptionist and two woman workers.

2. Mohd Arif S/o Mohd Zahid age 22 years Occ: Manager R/o Near Pakeeza Hotel, Kishanbagh, Hyderabad.
3. Sony D/o Narayana age 28 years Occ; Beautician r/o Backside, Yashoda Hospital, Somajiguda, Hyderabad.
4. Bandhana Roy D/o Narayana age 26 years Occ: Beautician R/o Somajiguda, Hyderabad.

**BRIEF FACTS :**

The facts of the case are that in 2015 one woman by name N. Radhamma @ Jyothi @ Radha Reddy, she previously running one massage center styled name as Splash Beauty Saloon Spa at YMCA circle, Narayanguda, Hyderabad and two cases booked against her in the limits Narayanguda PS. Then she could not get any suitable business, then she again opened a massage center in Abids, Hyderabad from last one month and taken one M/s S.S. Natural Family Spa and Saloon, Near Chiragali Lane, Abids, Hyderabad on rent basis and again she started and attracting to known /unknown customers by providing cross massage in the guise of Saloon and Spa by engage two beautician namely Sony and Bandhana Roy and earning huge amount illegally. She collects Rs. 2000/- for each person to cross massage. The cases registered against her in Narayanaguda PS were ended in conviction by imposing fine.

On reliable information, Central Zone Task Force Team along with Narayanaguda Police conducted raided on M/s S.S. Natural Family Spa and Saloon situated at Near Chiragali Lane, Abids, Hyderabad and apprehended one organizer, One Receptionist along with two woman workers.

The accused persons were handed over to the SHO Abids PS for further investigation.
