The Police of Division-D, C.C.S., D.D., Hyderabad arrested the accused person A-2 Muddayya Amarayya Hiremath @ Muddayya @ Hiremath on 31.8.2017, who indulged in Cheating, Criminal breach of Trust and criminal intimidation.

DETAILS OF THE ACCUSED WHO IS ARRESTED :

A-2 Muddayya Amarayya Hiremath @ Muddayya @ Hiremath s/o Amarayya Hiremath, age 38 years, Occ: Contractor, R/o Eta Star, the Garden Apartment, A Block, Flat No. 1805, Magadi Road, Bangalore. 560023.

BRIEF FACTS OF THE CASE :

Brief facts of the case are that on 9-03-2017 at 18:20 hours received a Court referred complaint filed by Sri Malta Praveenchandra Reddy, S/o. M. Rama Krishna Reddy, aged 50 Years, Occ.: Business, R/o. H.No. 7-1-28/1/A/23-24 Park Avenue Colony, Ameerpet, Hyderabad, wherein he alleged that the accused A-2 & A-3 are class-1 Contractors and working on the name of A-1 M/s. M.A. Hiremath Class-1 Contractor, who gave the Govt. Civil work in Karnataka State to the Complainant on Sub-contract basis after entering into M.O.U. at Ameerpet, Hyd. He have procured some money from his friends and given Rs. 5 Crores to the accused A-2 & A-3 to invest the same in the said Contract. After complete the contract work by Complainant, the accused raised the Bills from Govt. of Karnataka, but he did not repay to the Complainant. On repeated requests made by the Complainant, the accused has given some Cheques and subsequently the cheques were bounced. All the efforts made by Complainant to collect the money from the accused are went invain.

As per the contents of above complaint, a case in **Cr. No. 44/2017 U/s 420, 406, 506 IPC** has been registered and took-up investigation by Sri Mohd. Nayeemuddin, S.I. of Division-D, C.C.S., D.D., Hyderabad.

MODUS OPERANDI OF ACCUSED:

The accused proprietor of M/s M.A. Hiremath Class-1, who used to execute Civil Contract works, who got contract of the project of modernization of canal for execution work which may incurs about Rs. 5 Crores. In execution of their evil activities, they have given the above project to the Mr. M.Praveen Chandra Reddy on sub-contract basis which may extend to Rs. 5 Crores. The accused assured the complainant that they would return invested money with profits as and when the bills are released from the Govt. of Karnataka. All the agreements and MOU were executed at Ameerpet, Hyderabad on 5-11-2009. Then he had procured money from his friends and he had given net Cash to the accused and some money through RTGS and cheques. After completion of the above project work, the accused raised the bills from the Karnataka Government and dodged matter to refunding the amount invested by the Complainant and others, and dragged the matter of repayment on one pretext or other stating that the bills are not still cleared from the Govt.. In the month of June, 2012, the accused A2 agreed to pay an amount and issued post-dated cheques. When the cheques were presented, he was shock to know that the cheques were dishonoured.

BUSTED BOGUS VIGILANCE & ENFORCEMENT FOR INDIAN COPY RIGHTS-
(04) FRAUDSTERS NABBED.

On 01-09-2017 the Commissioner's Task Force, North Zone Team in joint operation with Trimulgherry Police busted **bogus department stayed as Vigilance & Enforcement for Indian Copyrights**, situated at Plot no. 7-12-021, Surya Enclave, Road no.3, Trimulgherry, Secunderabad and nabbed **(04) fraudsters** by name **1.Ch.Rathnakar, 2.Aravind Josefh 3.P.Ramesh Reddy, 4.Ch.Satyanarayana** who established bogus office and cheating the innocent unemployed youth with false promises of provide job in Vigilance and Enforcement for Indian Copy Rights as Jr. Investigators and the department is genuine & authentication of Government of India under Ministry of HRD thereby by cheating & collecting huge amounts from the job aspirants on the pretext of provide job in the said department. So for they have cheated about three Crore rupees from 100 to 120 candidates. **Seized Rs. 14,82,000/-, Appointment letters pads-53, Empty letter pads-50, Bio-data forms-130, walkie talkie -4, Computer systems-3, Printers -02, Rubber stamps-10, Cars-04** and other incriminating material from their possession.

➤ **BRIEF FACTS OF THE CASE:-**

The accused Ch.Rathnakar earlier taken the Copy Rights from Film distributors of Telugu Movies right for telecast. He used to give the copy right to the Local Cable Operators, whenever the Cable operators telecast the copy right movies without his permission then he used to lodge complaint against the Cable operators at Concerned Police Stations to gain royalty. In this process he got some knowledge in Copy Right Act. and closed the business last year. After that he is facing financial problems, to get money in easy manner while searching partners to run illegal business to gain easy money, he came into contact one of his friend by name Aravind Josefh N/o. Karim Nagar, and they both have planned to run bogus establishment on the name of **Vigilance & Enforcement for Indian Copyrights** (Protection for Copy rights & Trademark- against of Piracy) while searching places to open business in Secunderabad six months back they took the portion situated at Plot no. (SCB) 7-12-021, Surya Enclaves, Trimulghery, Secunderabad. In the month of February -2017 they established a office on the name of Vigilance & Enforcement For Indian Copyrights. Their main aspect is that they shall take

the authorization licence from the concerned companies and raid the establishment if anyone is sell or manufacture the duplicate products on the name of Copy right products and inform the Copy right authorities, but they did not follow the rules and regulations. Meanwhile the accused persons P.Ramesh Reddy, R/o. Old Bowenpally, Secunderabad & Ch.Satyanarayana R/o. Pensionpura, Langerhouse, Hyderabad joined with them in the illegal business. Due to financial problems to get money in easy manner they have planned to cheat the innocent job aspirant on the guise of providing jobs in their Vigilance & Enforcement For Indian Copyright (VEIC) as the department is authenticated by Government of India under Ministry of HRD) against of Piracy, Copyright & Trademark. They posted email ID: arvind042930@gmail.com, and the website name is www.veic.in. When the unemployed candidates approach them and shows interest in procuring a job, they use to collect the study certificates of candidates and bio-data and demand Rs.3 Lakhs to 8 Laksh for the post of Sr. Investigator. After received amount from candidates they are prepare fake appointment letters and handing over the same to the candidates. The above fraudsters are use to conduct interviews and select the graduates who are having some technical knowledge. After selection they conduct training for one month they appoint as Junior Investigator. As per the instructions of the above accused they candidates are use to serve the Noticed to the various establishments about violation of Copy Rights, Trade mark, Piracy games net zone etc. So far they have appointed 20 to 30 members as Jr-Investigator and designed Safari Dress code and deputed them to serve the Caution notice on the name of Vigilance & Enforcement for Indian Copy rights to the establishment , if any one violate the Copy right they will take action as per Copy Right Act 1957 illegally. The accused persons cheated about Rs. 3,00,00,000/- from 100 to 120 candidates on the pretext of recruit as Jr. Investigator in the said bogus Vigilance & Enforcement for Indian Copyrights.

To day on credible information conducted raid at bogus department styled as Vigilance & Enforcement for Indian Copyrights situated at Plot no. 7-12-021, Surya Enclave, Road no.3, Trimulgherry, Secunderabad and **Seized Rs. 14,82,000/-, Appointment letters pads-53, Empty letter pads-50, Bio-data forms-130, walkie talkie -4, Computer systems-3, Printers -02, Rubber stamps-10, Cars-04** and other incriminating material from their possession.

The accused persons along with seized material handed over to SHO, Trimulgherry PS for further necessary action. Further investigation is on to find out the other agents involved in the cheating case.
