## **SEIZURE OF BANNED GUTKHA, CIGARETTES AND CHEWING TOBACCO**

**ALL W/Rs.1,00,000/-.**

On 02-03-2018 the sleuths of Commissioner's Task Force, East Zone Team, Hyderabad, apprehended two persons namely **1) Anwar Ali** and **2) A.Sai Goud**, who are indulging in selling and supplying of banned different types of Gutkha, Cigarettes and chewing Tobacco products to the known and needy persons and earning easy money illegally. **Seized different types of Gutkha, Cigarettes and chewing Tobacco products, all W/Rs.1,00,000/-** from their possession.

### **DETAILS OF ACCUSED PERSONS:-**

**1) Anwar Ali**, age 54 yrs, occ: Owner of Royal Chalia store at MJ Market, R/o Aghapura, Nampally, Hyderabad.

**2) A.Sai Goud**, age 28 yrs, Occ: Pvt. Job, R/o New Osmangunj, Afzalgunj, Hyd.

### **Details of Seized property: -**

Different types of Gutkha, Tobacco, cigarettes and other pan shop products all W/Rs.1,00,000/-.

### **Brief facts of the case:-**

During the interrogation the accused Sai Goud confessed that, he is selling Gutkha, Tobacco and cigarettes in his Pan shop situated at Mothi Market to eak out his livelihood. Since the Government banned the Gutka and chewing Tobacco products, he started selling Chalias, Sounf Sweets Masalas and also other Pan Shop products to needy customers. In this business he did not get expected profits due to insufficient income, and then Sai Goud planned to sell banned Tobacco Products in the market to gain easy profits. Meantime he came into contact with one Anwar Ali, who is the owner of Royal Chalia store at M.J. Market, Abids, Hyd and requested him to supply the prohibited Gutkha, Cigarettes and other tobacco products and he agreed to supply the same to him. From then onwards the accused Sai Goud has been purchasing the prohibited Gutkha, Pan Masala, Cigarettes and Tobacco from Anwar Ali and selling the same to the known and needy customers clandestinely and earning easy money illegally. Further a raid was also conducted at Royal Chalia store at M.J. Market and seized huge quantity of different types of Gutkha, Chewing Tobacco, foreign cigarettes, etc.

On 02-03-2018 on credible information the East Zone Task Force Team apprehended the above said accused persons namely A.Sai Goud and Anwar Ali and seized different types of Gutkha, Cigarettes and chewing Tobacco products all W/Rs.1 Lakh, from their possession.

The arrested accused persons along with seized material were handed over to SHO, Afzalgunj PS, for further investigation.
