Some news papers published articles that MLA Sri Raja Singh Lodh visited under the limits of Kalapathar, Bhavani nagar, Santosh Nagar, Chandrayangutta, Bhadurpura, Malakapet and chadarghat and found cow slaughter took place in old city of Hyderabad and police failed in implementation of prohibition of cow slaughter.

In response to the above article published in daily news paper on 2/09/2017, the following is the rejoinder.

Since last one month Hyderabad city police striving hard to conduct Bakrid festival in peaceful manner and to implement the prohibition of cow slaughter act with zero tolerance in the city.

In view of the bakrid festival Hyderabad police conducted several meetings from SHO level to CP Hyderabad level with Muslim religious elders and with Qureshi community members regarding implementation of prohibition of cow slaughter in old city.

Muslim religious elders along with qureshi community members given assurance that they will not do cow slaughter.

Regarding visit of Sri Raja Singh Lodh, MLA., Gosha Mahal in old city under the limits of Kalapathar, Bhavani nagar, Santosh Nagar, Chandrayangutta, Bhadurpura, Malakapet and chadarghat and found slaughter in the above areas is totally false and baseless.

He did not visit the areas of Kalapathar, Bhavani nagar, Santosh Nagar, Chandrayangutta, Bhadurpura, Malakapet and Chadarghat. He has not made any visit but only given representation.

MLA has sent is party worker with representation that in some places cow slaughter took place. 5 teams were deployed to check the menace. Police has thoroughly checked places as alleged by the MLA and also other places in the old city but nothing found as alleged by the MLA.

There is no single cow slaughter took place in the old city of South and East zones. Prohibition of Cow slaughter act has been successfully implemented in the city. Qureshi community members were stick on to their promise and have not done any cow slaughters.

FAKE ACB OFFICIAL HELD – SEIZED NET CASH AND GOLD ORNAMENTS ALL W/RS.8 LAKHS

The sleuths of Commissioner's Task Force, West Zone team along with Saifabad Police apprehended one person near Secretariat, Hyderabad who was extorting money from the Government Officials by introducing himself as "N.S.Reddy, OSD to DG, ACB". Seized net cash of **Rs.4 Lakhs, 11 Tulas of Gold ornaments and (2) Cell Phones** from his possession.

Details of Accused:-

1. Gotthala Sreenivasulu @ Vasu S/o Late G.Venkata Subbaiah, aged 50 years, Occ: Painting Contractor, Caste: Yadava, R/o H.No.8-2-684/100/A, NBT Nagar Road No.12, Banjara Hills, Hyderabad, N/o Chillakuru (V), Gudur (M), Nellore District, A.P.

Brief about the Accused:-

The accused Gotthala Sreenivasulu is native of Chillakuru(V), Gudur(M), Nellore District, A.P. He is having one brother and two sisters. He completed SSC at his native place. In the year and 1990 he got married and blessed with two children. After the marriage he came to Hyderabad along with his family and residing at NBT Nagar, Road No.12, Banjara Hills, Hyderabad. At present he is working as painting contractor in Hyderabad.

Modus Operandi:-

The accused Gotthala Sreenivasulu is working as painting contractor in Hyderabad and also he is doing real estate business. he had incurred heavy loss in land dealing and due to his heavy financial problems, he decided to earn money in an easier way and hatched a plan of extorting money from the Government Officials under threat of ACB enquiry against them and thereby settling the matter by collecting money. In the year 2013 he along with his friend Aleti Kiran Kishore cheated the Government officials by introducing themselves as OSD to DG, ACB and extorted money from them. In this process in the month of October-2013 he along with his friend Aleti Kiran Kishore were arrested by Chanda Nagar Police in Cr.No.721/2013 U/s 419, 420, 384, 170 r/w 34 IPC and remanded to judicial custody.

After releasing from jail again he started working as painting contractor in various places in the city. But his earnings are not sufficient to meet his family expenses. From last six months he is facing financial problems. With the previous experience again he hatched a plan to extort money from the Government Officials under threat of ACB enquiry against them.

In the month of July-2017 he called Mandal Surveyor, Sherilingampally to his phone and introduced himself as N.S.Reddy, OSD to DG, ACB and informed him that ACB Officials are focusing you and I cautioned him to be careful and extorted money of Rs.12 Lakhs from him.

In the month of August-2017 he called one Ch.Srinivasu, OSD to Minister of Health and introduced himself as N.S.Reddy, OSD to DG ACB and informed him that one file is pending against you with DG ACB, seeking permission from Chief Secretary to proceed further and told him to be careful. Also he demanded certain works will be entrusted him to be done. For that the said Ch.Srinivasu replied that any work or file is to be requested with Hon'ble Health Minister, as per his direction works or files will be carried out and will be cleared. Again he warned him to be cautions in view of file with DG, ACB and put off his phone. But due to fear he did not continue this matter with him.

Basing on the complaint of Ch.Srinivasu, OSD to Minister of Health a case was registered vide Cr.No.363/2017 U/s 419, 385, 507 IPC by Saifabad PS.

Today i.e. on 02-09-2017 the accused Gotthala Sreenivasulu @ Vasu came near Secretariat, Hyderabad and trying to call some Government officials, on credible information we apprehended him.

Please don't believe, if anybody calls by posing himself as ACB Officer and asks money to settle the allegations and the same time inform to ACB office to the Toll free No.1064.
