

**CONDUCTED RAIDS ON MASSAGE CENTRES - APPREHENDED  
TWO ORGANISERS ALONG WITH THREE CUSTOMERS AND FOUR  
WOMEN WORKERS**

On 02-07-2018, the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad along with Banjara Hills and Panjagutta Police conducted raid at two Massage Centres by name "**Imperial Family Saloon Spa**" situated at Care Towers, Road No.12, Banjara Hills, Hyderabad and "**Heals Beauty & Spa**" situated at Flat No.405, 2<sup>nd</sup> Floor, Right wing, Amrutha villa, Somajiguda, Panjagutta, Hyderabad which they arranging "**Cross massage**" illegally to their customers and also running brothel house. Apprehended two organizers along with two customers and four women workers and seized **Net cash of Rs.10,000/-**, **(6) Un used Condoms, (1) Used Condom and (1) Cell phone** from their possession.

**BRIEF FACTS :**

Facts of the case are that, on 02-07-2018 found Syed Jahangir who is manager/incharge of "**Imperial Family Saloon Spa**" is running brothel house in the name of "Imperial Family Saloon Spa" situated at Care Towers, Road No.12, Banjara Hills, Hyderabad with female sex workers and also attracting known/unknown customers by providing Cross massage in the guise of Saloon by engaging one beautician Mohd.Sana.

The accused Ramavath Swathi who is Manager of "Heals Beauty & Spa" is engaging young girls & doing Cross Massage at "**Heals Beauty & Spa**", situated at Flat No.405, 2<sup>nd</sup> Floor, Right wing, Amrutha villa, Somajiguda, Panjagutta, Hyderabad. She is attracting known/unknown customers by providing Cross massage in the guise of Saloon by engaging four Beauticians namely Swathi, Sunitha, Sima Ramdas Koptar and R.Rajeshwari and earning huge amount illegally.

On reliable information, West Zone Task Force Team along with Banjara Hills Police and Panjagutta Police conducted raids on Spa's and apprehended the above accused persons and seized the above property.

The accused persons along with seized material were handed over to the **SHO, Banjara Hills PS and SHO, Panjagutta PS**, for further investigation.

The arrests were made under the supervision of **Sri P.Radha Kishan Rao**, Dy.Commissioner of Police, Commissioner's Task Force, by **Sri B.Gattu Mallu**, Inspector of Police, West Zone Task Force, with the assistance of SIs Sri V.Kishore, Sri L.Bhaskar Reddy, Sri M.Prabhakar Reddy, Sri P.Mallikarjun and staff of West Zone Team, Commissioner's Task Force, Hyderabad.

**SHE Teams, Hyderabad City nabs red-handed 7 persons while they were stalking (6) in Sanjeevaiah Park and (1) man at Dilsukhnagar Bus stop**

1. As per the instructions of the Asst. Commissioner of Police, She Teams, a team went to Indira Park at 07:00 AM for observation. Meanwhile on physical surveillance, the She Team found (6) six young men who were following women and passing comments at 12:30 PM. The respondents were caught red handed with evidence. An enquiry was made and they were brought to the She Teams office and produced before the Asst. Commissioner of Police. The respondents admitted their guilt and disclosed their names as 1). Mohd Zhooruddin, S/o.Mohd Masooduddin aged 18 yrs r/o.Badurpura 2). Md.Salam S/o.Md Mustafa age.17 yrs, r/o.Amberpet 3). Md.Imran S/o.md Shareed age.17yrs r/o.Chaderghat 4). Syed Ismail s/o.Syed Mobin age.17 yrs r/o.Chandrayangutta, Hyderabad 5). Syed Jaffar S/o.Syed Raheem age.17 yrs r/o.Chaderghat, Hyderabad 6). Md Shoub Shereef S/o.md Omer Shareef (Late) age.16 yrs r/o.Yakutpura, Hyderaad.

All the respondents were in the age group of 17 yrs and are minors. Their parents were also called to She Teams and were counselled. They were warned not to repeat such mistakes in future.

2. Another case of eve teasing and misbehaviour in public was caught red handed by the She Teams while the team were doing surveillance as per the instructions of ACP. The team was doing their task at Dilsukhnagar Bus Stop at 18:00 hrs and observed one person who was sitting on a bench and misbehaving with women in the bus stop and teasing them.

The SHE teams recorded his doings and caught him red handed and brought him to the She Teams Office and was produced before the Asst. Commissioner of Police. On enquiry, the respondent disclosed his identity as Mohd Nayeem, S/o.Md Kasim aged.40 yrs r/o.North Lalaguda, Hyderabad.

The respondent accepted his guilt and he is liable for punishment U/s.70 (C) of CP Act wherein a case is filed in CCS PS for further necessary action. He is being produced in the Hon'ble Court.

**RAID ON HOOKAH CENTER UNDER THE LIMITS OF  
HUMAYUNNAGAR PS - (02) PERSONS HELD - SEIZED HOOKAH  
POTS (12), FLAVOUR (12 BOXES), (18) HOOKAH PIPES AND  
(02) CELL PHONES**

On the 02-07-2018 the sleuths of Commissioner's Task force, Central Zone Team, Hyderabad received credible information, on that raided Hookah Center styled as M/s "BETA HOUSE", situated at Pent house, Silver Oaks Apartments, Opp Khaja Mansion Function Hall, Masab Tank, Hyderabad and apprehended two workers of the Hookah Center who are providing and serving Hookah to the Customers without following rules and regulations mentioned in the Notification of Central Government, Ministry of Health and Family Welfare.

**DETAILS OF THE ACCUSED:**

1. Arbas Sarfaraj S/o Sarfaraj, aged 21 years, Occ:Manager of Hookah Center, R/o Near Gowtham college, Mehdiapatnam, Hyderabad,
2. Abhiter S/o Agunadas, aged 19 years, Occ: Works in Hookah center, R/o Mehdiapatnam, Hyderabad
3. Hassan Waseem, owner of "BETA HOUSE", Hookah Center, Silver Oaks Apts, Opp Khaja Mansion Function Hall, Masab Tank, Hyd **(Absconding)**

The management of M/s "**Beta House**", situated at Pent house, Silver Oaks Apartments, Opp Khaja Mansion Function hall, Masab tank, Hyderabad, running Hookah center since last (6) months without obtaining specific license to run the Hookah Center from the competent authorities, while serving Hookah to minors/ teenaged boys, on the information Task Force team raided at the premises and found Nine customers enjoying Hookah served by the Management of Hookah center and they spoiling their health. The management is not maintaining any entry register even there are No precautionary sign boards are displayed in the premises, there is no system for sending the exhausted air from smoke to outside and air cleaning system is not available. However there is notification Gazette of India from the Ministry of Health and Family Welfare that No Service shall be allowed in any smoking area or space provided for Smoking. The owner of the "**Beta House**", violated all the rules and regulations of the Notification and serving Hookah to the Minors and Customers.

In this case **seized (12) Hookah Pots, (12 Boxes) Hookah Flavor and (18) Hookah Pipes, (02) Cell Phones and cash of Rs.3320/-**. The above (02) respondents along with seized property were handed over to SHO, Humayunnagar Police Station for necessary action.

The raid and apprehension made under the supervision of **Sri. P. Radha Kishan Rao, Deputy Commissioner of Police, Commissioner's Task Force** by Sri Sayini Srinivasa Rao, Inspector of Police, Central Zone Task Force team, SIs Sri. B. Kantha Reddy and G.Thimmappa along with the staff of Central Zone Team, Commissioner's Task Force, Hyderabad.

One Altaf Hussain is Founder/Chairman of Karwane Syed-Us-Sajidin (AS) Umrah & Ziyarath Tours established at Kadapa and opened one more branch at Dabeerpura, Hyderabad in the year, 2017 and he appointed the Mirza Asadullah Baig @ Taqi as the Branch manager for Hyderabad Branch. Mirza Asadullah Baig @ Taqi along with others With a malafide intention induced the innocent people, made wide publicity through public addressing system by moving in the old City about the packages for Umrah and Ziyarat sending them on low price i.e., Rs.25,000/-, 30,000/- and 36,000/- for Umrah and Rs.18,000/-, Rs.25,000/- for Ziyarat and umrah from Hyderabad to holy places and return to Hyderabad, attracted the innocent public and induced them and collected amount nearly Rs. 5 Crores from 1500-1600 pilgrims as per the package and cheated them dishonestly

The accused Mirza Asadullah Baig @ Taqi was arrested on 02.07.2018 at CCS, DD, Hyderabad and he is being produced before the Hon'ble Court to remand for judicial custody.

The case is being investigated by Sri. K.Srinivasa Rao, Inspector of Police, Team-IX, CCS, DD, Hyderabad under the able guidance and supervision of Sri K.N.Vijay Kumar, ACP Div-D, CCS and Sri G.Jogaiah, Addl.DCP, EOW & CCS, DD, Hyderabad.
