Job Connect is a unique **Process** that connects and matches the skill set of unemployed youth to employment opportunities in the Micro, small and medium enterprises in Private Sector on a daily basis round the year under the auspices of **A Joint Partnership of Hyderabad City Police and TMI**.

Job Connect uses a first of its kind state of art **employment-vehicle** equipped with state-of-the-art technology necessary to build a database of information of jobseekers and skill set requirements of employers that would help connect these talented youth of Hyderabad & Telangana to job opportunities.

Job Connect is a unique **Process** which facilitates each and every unemployed youth to explore the required skill set demand in Job Market and offer their own skill set by facilitating the Interview Process without the need for any intermediary or known acquaintances in the concerned company or industry. It opens up unlimited opportunities for unemployed youth from the poor and downtrodden sections of the society.

Target Population:

Many job seekers from low income and socially backward families do not have computers at home and are not savvy in English and hence are unable to use job boards and other job search options effectively. **Job Connect** is an employer connect van which takes the job information to where job seekers are - at bus stands, railway stations, colleges etc - and encourages them to register for free and access the latest jobs available locally and regionally.

Advantage:

The biggest value addition and advantage of the **Job Connect** is aggregation of all the jobs locally available in real time to the unemployed youth. Every day and every hour a team of executives from TMI situated in the van will approach employers nearby and register their vacancies with the offer of free shortlist. This Van will also play a crucial part in creating social awareness amongst the citizens of Hyderabad about employment opportunities.

Why Hyderabad City has taken up this Initiative:

Hyderabad City Police, being a law enforcement agency requires community support in law enforcement as a part of its daily policing operations. In order win the hearts and minds of the Community, Hyderabad City Police as a part of the people friendly policing Initiatives & in order to create a positive social impact on the society has come forward to undertake **Job Connect Program** on a daily basis round the year in different police station areas by connecting the skill set of unemployed youth with the Job Opportunities in the market and thereby help the unemployed youth in facilitating job interview process without the need for any known acquaintances in any company or industry. This will facilitate to bring awareness among the

community/ unemployed youth about the employable skill sets which are in demand in Job Market so that they can focus on development of such skill sets.

TMI group, a leading employment and skilling organization is providing the job Connect services in Hyderabad and has come forward to partnership with Hyderabad City Police to take the initiative forward and to provide the required services to the Community under CSR Activity.

State-of-the-art technology in the van:

The new and improved digital employment van is a state-of-the-art technology employment van having computers, page screen TV, public address system and seating arrangement to enable youth to register and also get the latest information on jobs available in Hyderabad & neighboring Districts. The youth can discuss about Job information like qualification required, salary offered by talking to job counselors present in the Van.

Job seekers can download a mobile android App called HAWKEYE which facilitates the job registration through the mobile phones. A local Hotspot is also being created around the van by installation of data wifi routers in the van. The jobs matching to the individuals criteria will be visible through the mobile App in their mobile. This will really bring the jobs to the unemployed youth instead of the youth going all over the city in search of the jobs. Local unemployed youth will get connected to jobs and will get interview passes without paying any money.

On the night of 02-08-2017, the Police East Zone, Hyderabad has conducted Cordon & Search operation in the localities of Laxmaiah huts, Chandraiah huts, Hanumanthu huts and Saleem Nagar under the limits of P.S Malakpet with 250 Civil Police and 50 TSSP Police under supervision of Sri Satyanarayana, IPS., I/c DCP, East Zone, Sri Ch. Ganga Reddy, Inspector, PS Malakpet and Inspectors/ SI of East Zone on demand of public in view of public safe and security to keep close watch on un-social elements to avoid any untoward incidents.

During the search the police seized (62) two wheelers, which has no proper documents, identified five suspects and brought them to Police station, besides (70) foreigners i.e., Somalia, Nigeria, Uganda, Yamane nations were checked in Saleem Nagar locality, out of them two persons were identified as overstay.

TUKARAMAGATE POLICE ARRESTED A NOTORIOUS SNATCHER IN CR.NO. 72/2016
U/SEC. 392 IPC AND RECOVERED 1/2 KG GOLD & 8 TWO WHEELER BIKES.

Details Of The Accused.

Devaka Maruthi Prashanth Goud @ Dunna Prashanth Goud @ Maruthi @ Prashanth Rao S/o Devaki Narsing Rao, Age: 43 years, Education Qualifications: Intermediate, R/o H No: 1-50, Lingapur (V), Narsapur (M), Medak (D) N/o Beside Shivalayam, Chinna Jamgi, Narayanked Mandal, Medak Dist. Ph 9676443378.

History: In the year 1993 Maruthi committed thefts and was sent to Juvenile home where he got acquaintance with one Byri Srihari (HB Offender) N/o Bara Imam Darga, Siddipet and both committed about 84 cases of House Breaking by Night and Snatching offences between 1994 and 2011 at Hyderabad, Cyberabad, Nalgonda, Nizamabad and Warangal limits.

Modus Operandi: In the year 2015, due to financial hardship, Maruthi planned to commit snatching offences all alone. As per plan he decided to commit theft of two wheeler vehicles from Secunderabad by lanes in the nights and on the theft vehicles Maruthi committed snatchings at Warangal and Karimnagar Districts. Due to well-built CCTV Cameras Surveillance System in Hyderabad, Maruthi decided not to commit snatchings in the limits of Hyderabad City.

Previous Arrests:

Earlier arrested in more than 89 cases of House braking and Chain Snatching from Police Stations Kukkatpally, L.B. Nagar, Hiyathnagar, Kushaiguda, Balnagar, Narredmet, Alwal, Chandanagar, Jeedmetla, Rajendranagar, Sanathnagar, Gopalpuram, Bollarum, Hanumakonda, Nizamabad, Nalgonda Districts.

On the complaint of Sri G. Srihari Babu of Vadderabashti, a case in Cr. No. 72/2016 u/sec 392 IPC of Tukaramgate Police Station was registered on 15-04-2016. On 02-08-2017, at about 1700 Hrs Tukaramgate Police with the **technical assistance of the Zonal Analysis Team** apprehended the accused Devaka Maruthi Prashanth Goud at St. John's Church back side road.

Property Recovered:

Recovered total **1/2 Kg of gold ornaments** and **08 two wheeler bikes** pertaining to **16 chain snatching and 08 auto mobile theft cases** of Warangal, Karimnagar and Hyderabad.

ROWDY SHEETS OPENED AGAINST CHINTAPATLA DEEKSHITH CHARY, BALA KRISHNAN VIMAL RAJ AND SAMALA RAJU @ KARATE RAJU IN CRIME NO. 392/2017 U/S 307, 448 R/W 34 IPC OF CHILAKALAGUDA PS, NORTH ZONE, HYDERABAD CITY.

HISTORY OF THE CASE:

The complainant family is having disputes with A-1 Chintapatla Deekshith Chary & A-2 Smt Chintaptla Manjula regarding possession of the property and some civil cases are also pending between them. Both the parties are having enmity and grudges. While the matter stood thus, on 03.07.2017 at about 2330 hours, the injured G. Veera Swamy was standing inside his premises by smoking and the (A-1)Chintapatla Deekshith Chary, (A2) Smt Chintaptla Manjula, (A3)Bala Krishnan Vimal Raj and (A4) Samala Raju @ Karate Raju came into the premises of complainant party and started abusing them in filthy language. At that time on the instigation of A-2 & A-3, the A-1 jumped the compound wall and attacked the injured with hands with an intention to eliminate him. At that time, A-2 called to A-4 over phone and the A-4 came to spot and provided safe house for the accused to perpetrate gruesome attack on the injured and also warned the locality people not to approach the scene of offence with dire consequences and A-2 to A-4 all together instigated the A-1 to eliminate the injured. The A-1 gave fist blows on the face of injured due to which the injured sustained severe bleeding injuries to his both eyes. After medical check up at Sarojini Devi Eye Hospital the duty doctor declared that the right eye of the injured was totally damaged and left eye is to be examined. The injured got admitted at Sarojini Devi Eye Hospital as in patient and undergoing treatment.

The accused persons A-1 to A-4 were arrested on 04-07-2017 in the above referred case by Sri K. Kiran Kumar, Addl. Inspector of Police, Gopalapuram PS, HAC.

On 27.7.2017 the Police Chilalguda opened three rowdy-sheets against 1) Chintapatla Deekshith Chary, 2) Bala Krishnan Vimal Raj and 3) Samala Raju @ Karate Raju who actively engaging in attempt to murders, crimes against women and criminal tress-passing cases in the limits of PS Chilalguda and rest of city. The maintaining of sheets against them is a key function in controlling their criminal activities and need 24/7 surveillance on their movements.
