RAID ON BLACK MAGICIAN DEN (KALA JADU) - 02 HELD

SEIZED BLACK MAGIC ARTICLES, NET CASH Rs.7000/- & (03) PHONES.

On 02-10-2017, the Commissioner's Task Force, North Zone Team in joint operation with Mahankali Police on credible information conducted raid on black magician den situated at 4th floor, Minerva Complex, SD Road, Secunderbad and apprehended **(02) Black Magicians** by name **1).** Nawab Malik and his associate **2).** Mohd Khalid who are indulging in sorcery through black magical occult and trap the innocent people "psychologically", extracting money by claiming that they have extraordinary powers with them and cheating huge amount from victims. **Seized Black magic items, net cash Rs. 7000/-**, (03) Cell phones from their possession.

1.Nuts, 2.Steel Mug, 3.Steel plate, 4.Lemons, 5.Taveez-15 (Silver paper rolled), 6.Taveez white papers, 7.Plastic tins 8.Oil tin, 9. Bottle with black thread 10.Copper mug, 11.Paper add pamphlets, 12. Plastic beads garland, Agarbathi sachets other incremented materials.

MODUS OPERANDI :-

The accused persons are publish add in news papers, Local Channel that they can solve all type of problems 100% guarantee with Black magic through spiritual powers and indulge in sorcery through black magic, extracting money from innocent people, cheating huge money from victims to gain easy profit for their luxurious life.

BRIEF FACT OF THE CASE:-

The accused persons 1).Nawab Malik 2). Mohd Khalid are native Merut, Uttar Pradesh State. Few months back they came to Hyderabad and took a portion at 4th floor, Minerva Complex, SD Road, Secunderabad on rental and started Black magic. The accused persons published adds in news papers, Local TV channel that they can solve all type of physical/Mental, financial problems with 100% guarantee with their Black magic through spiritual powers and indulge in sorcery through black magic, extracting money from innocent people. More often than not, the victims would approach the 'black magicians' to solve problems such as those of marital discord and sickness and even warding off the evil eye. The accused would give them amulet(Lucky charm) which they claimed had healing powers and cheat huge amount from victims.

On tip off the Commissioner's Task Force Team apprehended (02)accused persons and seized above Black magic material from the instance above accused at 4th floor, Minerva Complex, SD Road, Secunderabad. The accused persons along with seized material were handed over to SHO Mahankali PS for further investigation.

The arrest was made under the supervision of **Sri. C.Shashidhar Raju, Addl. Dy.Commissioner of Police, Commissioner's Task Force**, Hyderabad by Sri K.Nageswar Rao, Inspector of Police, Commissioner's Task Force, North Zone, and SIs Sri.K.Srikanth, P.Chandrasekhar Reddy, B.Sravan Kumar and North Zone Task Force Team, Hyderabad.

APPEALED TO THE CITIZENS:- In this connection it is to appeal to the citizens that not to trust such nefarious individuals /Black Magicians. If any victim trapped by the black magicians, You may please inform the same to us to enable us to take stringent action against those deceivers. The names of the people giving information about Black Magicians will be kept confidential.
