It is to inform that in view of **Jubilee Hills Road No.5 Metro Rail Station Entry & Exit and Civil Works** from 05-04-2017. The Traffic in this route will be diverted to ease traffic congestion from **05-04-2017 to 04-06-2017**.

- **:TRAFFIC DIVERSION: -**

1. Traffic coming from Yousufguda Check Post, Krishnanagar, Srinagar Colony and Indira Nagar towards Venkatagiri 'T' Junction Jubilee Hills Check Post, Road No.10, will not be allowed towards Road No.5. Jubilee Hills and will be diverted towards 7 acres back side road - Banjara Basthi – GHMC Park then joins in normal route.

TRAFFIC ADVISORY

The following restrictions are imposed on 05-04-2017 in connection with “Sri Babu Jagjeevan Ram Birthday Celebrations” at B.J.R.Statue near Lal Bahadur Stadium from 0500 hrs to 2200 hrs.

Traffic diversions and restrictions.

1. Traffic coming from Chapel road, Nampally and intending to proceed towards B.J.R.Statue will not be allowed and will be diverted at A.R Petrol pump towards P.C.R.
2. Traffic coming from SBI Gunfoundry side and intending to proceed towards Press Club/Basheerbagh Fly over will not be allowed and will be diverted towards Chapel Road at S.B.I.Gunfoundry.
3. Traffic coming from Ravindra Bharathi and Hill Fort road and intending to proceed towards B.J.R.Statue will not be allowed and will be diverted towards Sujatha High School at K.L.K. Building, Fateh Maidan.
4. Traffic coming from Basheerbagh Flyover side will not be allowed to take right turn at B.J.R.Statue and proceed upto S.B.I. Gunfoundry and take right turn for onward journey.

GOPALAPURAM POLICE NABBED LADY PICK POCKETING GANG IN CRIME NO. 96/2017 U/Sec 379 IPC OF GOPALAPURAM PS

On 04.04.2017, the Crime staff of PS Gopalapuram apprehended habitual lady offenders namely (1) Bodollu Laxmi W/o Prasada Rao and A-2) Bodollu Laxmi W/o Kumar involved in stealing valuables from the handbags of lady passengers in RTC buses.

ACCUSED

A-1) Bodollu Laxmi W/o Prasada Rao, age 53 years, Occ: Garments business, presently R/o H. No. 20/02, Rajiv Gruhakalpa – 1, Laxmiguda, Katendan, Rajendranagar, Ranga Reddy district, N/o Mangalavaripeta, Rajamahendravaram, East Godavari district, Andhra Pradesh state

A-2) Bodollu Laxmi W/o Kumar, age 20 years, Occ: Nil, R/o H. No. 20/02, Rajiv Gruhakalpa – 1, Laxmiguda, Katendan, Rajendranagar, Ranga Reddy district

History

The A-1 is native of Rajahmundry, East Godavari and A-2 is residing at Laxmiguda, Rajendra Nagar and they both are relatives. A-1 is previously arrested by Mahankali police in the year 2015 vide Cr. No's 16/15, 24/15 and released on bail and also arrested by Nalgonda police. After releasing from jail, again A-1 again hatched planned to commit thefts in the crowded buses and joined her relative into his gang.

M.O.

The accused targets the ladies at crowded bus stops and in the buses. By taking advantage of huge rush in the bus, B. Laxmi W/o Prasada Rao commits thefts of valuables from the handbags of the ladies by opening its zip.

The accused A-1 so far confessed the following cases and the recovery as follows, A-2 is involved in only one case vide Sl. No. 3.

- 1) Cr. No. 413/2016 U/s 379 IPC of PS Gopalapuram - Recovery ₹15000/-
- 2) Cr. No. 86/2017 U/s 379 IPC of PS Gopalapuram - Recovery Blackbeads Gold chain wg 2.5 Tulas
- 3) Cr. No. 96/2017 U/s 379 IPC of PS Gopalapuram - Recovery Gold chain wg 2 Tulas

Total Recovery: GOLD ORNAMENTS WG 4.5 TULAS AND NET CASH ₹ 15000/-.
