**HELD TWO ACCUSED PERSONS – SEIZED (24) QUINTALS PDS
RICE AND MINI ASHOK LEYLAND VEHICLE**

On 04-05-2018, on credible information Commissioner's Task Force, Central Zone Team along with Civil Supply Officials of Circle No.9 Hyderabad intercepted one Mini Ashok Leyland vehicle at Habshiguda X Road Hyderabad and apprehended two accused persons and seized (26) Quintals of PDS Rice and One Mini Ashok Leyland vehicle.

Names of the accused:

1. Mohammed Imran @ Imran s/o Mohammed Yousuf aged 22 years Occ:Light Motor Vehicle driver R/o H.No.2-2-54, Phukatnagar, Pedda Cherlapally, Ranga Reddy District.
2. Medaram Shiva s/o M.Ramakrishna aged about 22 years Occ:Driver of Ashok Mini Leyland r/o Beside H.No.2-2-54, Phukatnagar, Pedda Cherlapally Ranga Reddy District.

Brief Facts of the case:

The accused person Mohammed Imran @ Imran of Cherlapally, Hyderabad was doing light motor driving and he was not getting sufficient income in driving, then he started PDS Rice business by collecting PDS rice from the known and unknown card holders in Musheerabad, Hyderabad for Rs.8/- per Kg and diverting the same to Zaheerabad by Mini Ashok Leyland vehicle and selling the same at Zaheerabad Market for Rs.12/- per Kg to the needy customers and earning illegal profit from last six months.

As usual today afternoon, while he was transporting the PDS Rice in Ashok Mini Leyland vehicle bearing No.TS-08 UA-8796. On credible information Central Zone, Task Force Team, along with Civil Supply Officials intercepted the above vehicle at Habshiguda X Road and apprehended the accused persons Mohammed Imran @ Imran and Medaram Shiva and **seized (24) Quintal of PDS Rice and one Ashok Mini Leyland vehicle bearing No.TS-08 UA-8796.** The accused persons are illegally transporting the PDS rice and cheating the Government and gaining illegal money.

In this case total (24) Quintals of PDS Rice and one Ashok Mini Leyland vehicle were seized and apprehended two accused persons.

The accused persons along with seized property handed over to Civil Supply officials of Circle No.9 Hyderabad for further necessary action.

The above apprehension is made under the supervision of **Sri. P. Radha Kishan Rao, Deputy Commissioner of Police, Commissioner's Task Force** by Sri. Sayini Srinivasa Rao, Inspector of Police, Central Zone Team Task Force and SIs Sri. B. Kantha Reddy and G.Thimmappa along with the staff of Central Zone Team, Commissioner's Task Force, Hyderabad.
