PD ACT INVOKED AGAINST ABDULLAH BIN MAHFOOZ @ ABDULLAH @ ABBU S/O AWAD BIN MAHFOOZ @ AWAD BIN CHAOUSE, ROWDY SHEETER OF BHAVANINGAR POLICE STATION, SOUTH ZONE, HYDERABAD.

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued P.D. Orders against Abdullah Bin Mahfooz @ Abdullah @ Abbu S/o Awad Bin Mahfooz @ Awad Bin Chaouse, rowdy sheeter of Bhavaningar Police Station on 27.11.2018.

Abdullah Bin Mahfooz @ Abdullah @ Abbu S/o Awad Bin Mahfooz @ Awad Bin Chaouse, aged about 23 years, Occ: Auto driver, R/o H.No.18-7-426/B/97/C, Talabkatta, Bhavaninagar, Hyderabad has committed **offences of murder and extortion in the limits of Hyderabad Police Commissionerate** to make easy money and lead a lavish life.

The accused/detenu has committed 2 offences in the recent past **including murder and extortion** under the limits of Hyderabad Police Commissionerate and has been creating large scale fear and panic among the general public, thereby adversely affecting the public order, apart from disturbing the peace, tranquillity and social harmony in the society.

Bhavaninagar Police made sincere efforts and arrested the accused/detenu Abdullah Bin Mahfooz @ Abdullah @ Abbu S/o Awad Bin Mahfooz @ Awad Bin Chaouse on 7.9.2018 in Cr.No.112/2018 U/s 302 r/w 34 IPC of Bhavaninagar PS and remanded him to judicial custody. The Preventive Detention Order was executed on him on 29.11.2018 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

Special Team-II of CCS, DD, Hyderabad have apprehended notorious accused person at M.L.A. Colony, Road No. 12, Banjara Hills, Hyd for cheating innocent un-employed youth on the pretext of providing Jobs in the Indian Railway as Group C & D Cadre, Station Master & TC and cheated the complainant and other victims, duped them crores of rupees on the pretext of Railway Job for his wrongful gain and cheating the innocent people causing financial loss. The accused is a habitual offender, number of cases pending various Police stations in Vijayawada and Hyderabad.

FACTS OF THE CASE:

On 15-11-2018 at 1530 hrs received a complaint from Sri B.Venkat Rao, age 32 yrs, Occ: Student, R/o. Allapadu (V), Bonakal (M), Khammam Dist, T.S. and (14) others stating that a person by name Pammidi Durga Prasad Rao and his wife P.Padmini R/o Road No.12, MLA Colony, Banjarahills, Hyd have collected Rs.1,00,00,000/- (Rupees one crore only) from the complainant and others by way of cheques on the pretext of arranging Group-C and Group-D Jobs in Railways and Home Guard Jobs in Police Dept. about 2 years back. For this Railway recruitment, they carried out Medical Test-like blood, Urine tests and taken signatures on duplicate papers. The accused took victims even to Rail Nilayam and assured that they would be given appointment letters soon and had them tested at Railway hospital, Lalaguda.

The accused is involved in 5 cases of similar type at various Police Stations and in directly involved in 7 other cases in Police Stations of else where in AP & Telangana.

Thus, the accused duped more than 100 victims and collected huge amounts, which run into crores.

Accused by committing criminal breach of trust to cheat the complainant/another 14 victims on the pretext of providing jobs in Railways, for the post of Group-C, Group-D, TC and Home Guard in Police Department and collected Rs. 5 to 10 Lakhs from all the victims taken by the alleged accused Pammidi Durga Prasad Rao and his wife Smt. P. Leela Padmini

LAKE POLICE RESCUED 2 PERSONS FROM COMMITTING SUICIDE

In the inverting nights of 04th December 2018, P S Lake officials have rescued **Two persons** in two different timing and situation. Were all rescued, while they were about to commit suicide by jumping into the Hussain Sagar Lake. The Details of the victims are as follows:-

First incident: Occurred on 04/12/2018 at 0120 hours tried to jump into water near Pooja stal, immediately our patrolling Lake Police noticed him and brought to Lake P.S.

Details of Victim: One man, age:- 43 yrs, occ:- business, r/o:- saroor nagar, R.R. dist.

Reason: On enquiry victim revealed that he is a married person and leading conjugal life happily. Due to some personal family issues his wife staying at her maternal house since one year. By that issue he got addicted to alcohol. Yesterday in the midnight hours after consuming alcohol he went into depression about his wife and decided to end his life. I counselled victim promptly, after that handed over to his brother.

Second incident: It occurred on 04/11/2018 at around 0530 hour's tankbund near Bademiya kababs one man came in a fully drunken condition and tried to jump into water immediately our patrolling police noticed him and saved his life and brought to Lake Police Station.

Details of Victim:- One man, age:- 48 yrs, occ:- daily labour, r/o:- domalguda, Hyderabad.

Reason: On enquiry with the victim it came to know that he is an alcoholic, after consuming alcohol he starts quarrelling with the his family and abuses them in a most filthy language. His family members requested him many times to stop alcohol and to look after his children, but he never heed to their words. As usually last night he went to home in a fully drunken condition and starred abusing his wife and children in a most filthy and unparliamentarily language. His family fed up on his worst behaviour and necked him out from their house. Due to which he went into depression and decided to end his life and came. I counselled him promptly, after that handed over to wife and children.

As such Lake Police played a vital role in saving them spontaneously without giving any scope for untoward incidents for which they could save the lives of people. These two incidents were occurred on 04-12-2018. I counselled them promptly and they were safely handed over to their relatives and concerned by taking their assurances that they will not repeat such things in near & future.

Thus, the patrolling Blue Colts of Lake PS viz., PC 4295, C. Sai kiran, HG 6849, Jaganath bhai, HG 2309, B. Krishna yadav have tactfully identified the above persons in a suspicious manner and rescued them from committing suicide.
