

NABBED NOTORIOUS SNATCHER - RECOVERED GOLD CHAIN WG. ABOUT 30 GRAMS AND HONDA SHINE VEHICLE ALL WORTH ABOUT 1.4 LAKHS.

On 04-04-2018, the sleuths of Commissioner's Task Force, South Zone Team, Hyderabad apprehended one habitual snatcher by name Mohd. Ameer @ Amer @ Prince and detected **(01) snatching and (01) two wheeler theft** in Hyderabad Commissionerate and recovered **gold chain wg. about 30 grams and Honda shine vehicle** all worth **about 1.4 lakhs** at the instance of accused person.

Details of accused person:-

Mohd. Ameer @ Amer @ Prince S/o Late Mohd. Khadeer, age: 28 yrs, Occ: Auto Driver, R/o Errakunta, Shaheen Nagar, Hyderabad.

Brief History of accused:-

The accused Mohd. Ameer @ Amer @ Prince, who is born and brought up in Papaiah Basti, Chaderghat area of Hyderabad city is a notorious/habitual snatcher. He is involved in **more than 60 cases** of snatchings in **Tri-Commissionerates**. He got addicted to drugs and to meet his lavish expenses he started committing crime while he was a juvenile. He has been committing crimes since 2009. Several times he was sent to jail, but he never changed his criminal attitude. In the year 2015, PD Act was initiated against Mohd. Ameer by Chikkadpally PS. After releasing from PD Act, he again committed about **25 snatchings cases** in Hyderabad, Rachakonda and Cyberabad Commissionerates within a few months. Lastly he was arrested by Tukaramgate P.S on 11.12.2016 and released from Jail on 30.03.18.

Immediately, after releasing from Jail he again planned to commit snatchings. In pursuance of his plan, he first committed theft of a Honda Shine motor cycle by using a duplicate key on the **Mid night of 01st April** under the limits of Chatrinaka P.S for execution of snatchings. On **03rd April**, in the morning he committed snatching of a gold mangalsutram chain from a lady under Malakpet Police Station limits.

On a specific input, the South Zone Task Force team apprehended the above snatcher within 24 hours after the commission of crime. But for the above timely arrest, he would have been a menace. By this quick action, a possibility of series of chain snatchings could be stopped.

The apprehended offender Mohd. Ameer @ Amer @ Prince along with recovered property is handed over to the SHO Malakpet Police Station for taking further action against him.

NABBED 3 PERSONS, POSSESSION OF DUEL/TRIPLE INDIAN PASSPPORTS.

To day i.e on 05-04-2018, on credible information the sleuths of Commissioner's Task Force, North Zone Team and local Police conducted simultaneous raids at Abids. Trimulgherry & Humayun Nagar PS limits and apprehended (03) Accused persons by name 1) Hyder Ali Lalani R/o. Abids, 2) Bhandra Khada Narsing Rao R/o. Trimulgherry & 3) Mohammed Abdul Salam R/o. Humayun Nagar, wherein the accused persons obtained Multiple /Triple & duel Indian passport on different names by submitted fake and forged documents of Voter ID card, Aadhar Card, Ration card as genuine documents for their illegal benefits illegally. Seized 07 Indian Passports, Aadhar cards, Voter ID card, Ration card, etc from the instance of above accused persons.

1. Hyder Ali Lalani S/o. late Lalani Badruddin, age. 60 yrs, Occ. Footwear Business, R/o. Yuwan Apts, Abid Road , Hyderabad
(He obtained duel Indian passports on different name of 1)Lalani Hyder Ali & 2)Venkat Sharma)
2. Bhandra Khada Narsing Rao S/o. Narsing Rao, aged about 69 yrs, Occ. Car driver R/o. Kubera Towers, near Trimulghery X road, Secunderabad
(He obtained triple Indian passports on different name of 1)Bala Narsing Rao, 2) Benny Narsing Rao & 3) Bhandra Khada Narsing Rao)
3. Mohammed Abdul Salam S/o. late Mohammed Jan, aged 53 yrs Occ. Contract business R/o. Banjara Elegant inside Patel Residency, Masab Tank, Asif nagar, Humayun Nagar, Hyderabad (He obtained duel Indian passport on different name of 1)Mohammed Abdul Salam & 2) Mohammed Saleem)

BRIEF FACTS OF THE CASE:-

1. Cr.No.71/2018, U/Sec. 420, 417, 419, 468, 471, 474 IPC and Sec. 12(1)(b) of Passport Act-1967 of Abids Road PS:-

The accused by name Hyder Ali Lalani S/o. late Lalani Badruddin, aged 60 yrs, is residing at Yuwan Apts, Abid Road , Hyderabad. He is running footwear business. In the year 1997 he obtained First Indian passport number A3018243 on genuine name of **Hyder Ali Lalani** and renewed the same and availed UK Visa.

Later In the year 2000 he decided to work at USA on work B1/B2-Visa, if Visa cancelled on the first passport, it is difficult to get USA visa, he planned to get another passport accordingly in the year 2000 with fake & forged Ration Card & Board of Secondary Education certificate of Govt Boys High School, on the name of Venkat Sharma, obtained second passport number B2131929 at RPO, Hyderabad on the name of **Venkat Sharma** S/o. Anand Sharma, Mother name-Sunitha Sharma, Spouse name- Sujata Kumari, Date of Birth:- 01/02/1960, Address details:- Chelapura, Jubilee, Hyderabad, date of issued:- 07-06-2000 after obtained fake passport he applied for Visa of USA at Chennai, but the consulate authorities rejected the Visa due to insufficient documents. After that on his genuine passport availed UK VISA and USA Visa and availed the same. Again in month of Dec-2017 he applied for B1/B2 Visa of USA, the concerned authorities rejected the same.

2. Cr.No.47/2018, U/Sec. 420, 417, 419, 468, 471, 474 IPC and Sec. 12(1)(b) of Passport Act-1967 of Trimulgherry PS :-

The accused Bhandra Khada Narsing Rao S/o. Narsing Rao, aged about 69 yrs, R/o. Trimulghery X road, Secunderabad, He is doing as a Car driver for his livelihood. He intended to goto USA on work permit VISA In the year 2000, he obtained Indian passport number 1)B2003495, on the name of **Bala Narsing Rao**. On this passport he applied for B1&B2-VISA of USA at Deli but it was rejected.

Again In the year 2001 he got fake & forged Ration Card, ration card, Affidavit copy Form of TC of VII class of Zilla Parishad High School, Mudford, on the name of B.Narsing Rao and obtained second passport number 2)B3746847, on different name as **Benny Narsing Rao** with fake date of Birth 03-11-1954 and applied for USA Visa at Delhi, but the concerned authorities rejected his VISA.

After that third time with the fake and forged Voter ID & Aadhar card obtained another passport no. M6311945, on the name of **Bhandra Khada Narsing Rao**, Address :- H.No.26-95/6/14, Seetaram Nagar, Safilguda, Ranga Reddy and applied for B1&B2 USA VISA, at US Consulate, Begumpet in the month of Sep-2017 but the concerned authorities rejected USA VISA due to insufficient information.

3. Cr.No.86/2018, U/Sec. 420, 417, 419, 468, 471, 474 IPC and Sec. 12(1)(b) of Passport Act-1967 of Humayun Nagar PS:-

The accused Mohammed Abdul Salam S/o. late Mohammed Jan, aged 53 yrs Occ. Contract business R/o. Banjara Elegant inside Patel Residency, Masab Tank, Asif nagar, Humayun Nagar, Hyderabad. While doing business he intended to get Indian passport on genuine name in the year 1998, obtained Indian Passport number E841026, on the name of **Mohammed Abdul Salam** and renewed the same .

Later he planed that get B1&B2 VISA of USA, on another passport on different name to get Visa of USA he got fake and forged documents i.e Aadhar Card, Voter ID card in the year 1999 he obtained another passport number B0871013 at RPO, Hyderabad on the name of **Mohammed Saleem** S/o. Mohammed Jani. After obtained the passport in the same year he applied for B1&B2 USA Visa at Chennai , but the concerned authorities rejected his Visa due to insufficient information. Later again with his original Passport he applied for USA visa in the year 2000 at Chennai, but the concerned authorities rejected the VISA of USA. Then he destroyed fake passport number B0871013 which was obtained on the name of Mohammed Saleem to conceal evidence and kept the fake passport Photostat document for further usage. Again with his genuine passport he applied for B1/B2 USA Visa at US Consulate, Begumpet , the concerned authorities rejected his VISA.

Arrest :-

To day on 05-04-2018 on tip off information the Commissioner's Task Force, North Zone team conducted simultaneous raids in the limits of Abids Road PS, Trimulghery PS & Humayun Nagar PS and apprehended (03) Accused persons by name 1)Hyder Ali Lalani R/o. Abid Road, 2) Bhandra Khada Narsing Rao R/o. Trimulghery X road, & 3) Mohammed Abdul Salam R/o. Humayun Nagar, Hyderabad and seized above material from the instance of accused persons.

The apprehended accused persons handed over to the concerned Police Station of SHOs along with seized Material for further investigation.

The arrest was made under the supervision of Sri. **P.Radhakishan Rao, Dy.Commissioner of Police**, Commissioner's Task Force, Hyderabad by Sri K.Nageswar Rao, Inspector of Police, Commissioner's Task Force, North Zone, and SIs Sri.
