Whereas detention order was issued on 28.3.2018 against Saraab Keshava Chari @ Chinna @ Kittu, S/o Nagarjuna Chary, aged about 24 years, R/o Servant quarters, Smile Dental Hospital, Hi-Tech City, Shaikpet, Hyderabad, N/o H.No.8-192/A, Main Bazar, Tadipatri (M), Ananthapur District, Immoral Traffic Offender of Saidabad Police Station, under the provision of Preventive Detention Act and it has been returned un-served stating that the said detention order could not be executed as the offender could not be traced/found despite all possible efforts. Whereas, I am satisfied that the said Saraab Keshava Chari @ Chinna @ Kittu has been willfully absconding and is concealing himself to avoid the service of the said detention order, thereby obstructing the process of law.

Therefore, by invoking the provisions of Sec.7 of the said Act, the proclamation is hereby made that the said Saraab Keshava Chari @ Chinna @ Kittu is required to appear before me at the Office of the Commissioner of Police, Basheerbagh, Hyderabad within 30 days from the date of publication of proclamation to answer/execute the said orders.

**PD ACT INVOKED AGAINST AHMED BIN GUMESH AL JABRI @ AHMED JABRI,
GOONDA OF CHANDRAYANGUTTA POLICE STATION, SOUTH ZONE,
HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City invoked P.D.Act against Ahmed Bin Gumesh Al Jabri @ Ahmed Jabri, Goonda of Chandrayangutta Police Station on 30-5-2018.

Chandrayangutta police executed the preventive detention order on Ahmed Bin Gumesh Al Jabri r/o Maqbool Nagar, Barkas, Chandrayangutta, Hyderabad on 31-5-2018 in Central Prison, Chanchalguda, Hyderabad.

Ahmed Bin Gumesh Al Jabri is a "Goonda" and has been habitually committing offences including dacoity, snatchings, robberies and causing hurts in the limits of Hyderabad Police Commissionerate since 2013. He has been creating large scale fear and panic among the general public by committing such offences in public places.

With a view to prevent Ahmed Bin Gumesh Al Jabri from acting in a manner prejudicial to the maintenance of public order, he was detained and lodged in Central Prison, Chanchalguda, Hyderabad.
