

HELD - ONE NOTORIOUS ROWDY SHEETER

On 05-07-2017 The sleuths of Commissioner's Task Force, Central Zone, Hyderabad City apprehended one notorious/potential rowdy sheeter of Musheerabad PS namely Akaram Anjaneyulu @ Anji who is wanted in bodily offence registered in Saidabad PS and also (02) Non Bailable Warrants are also pending against him in Madannapet PS and Gandhinagar PS.

Name of the accused person:-

Akaram Anjaneyulu @ Anji S/o Late Akaram Lingam, age: 26 years, Occ: Vegetable vendor @ Subramaniam Colony, Champapet X Road, R/o. H. No. 1-1-652/41, Sabarmati Nagar, Musheerabad, Hyderabad N/o Dhobigath 'X' Roads, Madannapet, Hyderabad

DETAILS OF THE CASE: -

On 02-07-2017 in the night hours accused Akaram Anji (rowdy sheeter) with his two associates have beaten Punnada Saidulu with beer bottles at dhobighat graveyard, Saidabad on a petty issue due to which he received head injury and they all sped away from there. Subsequently a case was registered against them in Saidabad police station. Since the commission of offence accused rowdy sheeter Akaram Anji was absconding.

Previously he is involved in so many cases in different police stations in Hyderabad and Cyberabad limits since 2008 and possibility of PD Act may be considered against him. Today he is being handed over to SHO Saidabad for taking necessary action.

APPREHENDED ONE HOUSE BURGLAR - RECOVERED Rs. 11.20 LAKHS CASH.

On 05-07-2017, the sleuths of Commissioner's Task Force, South Zone Team, Hyderabad apprehended one House Burglar by name Yousuf Ali resident of Tadban, Hyderabad within three days and recovered **Rs. 11.20 Lakhs cash** at the instance of accused persons.

Details of accused :-

1. Mohd. Yousuf Khan S/o Mohd. Shabbir. age: 20 yrs, Occ: Asst. Cook R/o Near Madina Function Hall, Tadban, Hyderabad.
2. Naseeb Begum W/o Mohd. Shabbir. age: 45 yrs, Occ: Asst. Cook R/o Near Madina Function Hall, Tadban, Hyderabad

Brief facts :-

The accused Yousuf Ali is working as a cook. His marriage is fixed and being performed within one month. He requested his employer for providing money to meet marriage expenditure, but he refused. He got worried about the marriage expenditure, as his earnings are very meager. So he decided to commit Theft in his locality and committed theft of Cash of Rs. 13,00,000/- from the house of the complainant (**Abdul Faheem S/o Abdul Saleem R/o New ITI Colony, Kalapathar, Hyd**) and sped away from the spot.

South Zone Task Force fished out clues and apprehended the accused within three days and detected the case and recovered cash of Rs. 11.20 lakhs at the instance of accused person.

M.O.:-

On the early morning hours of 02.07.2017, the accused person returned home from work and decided to commit offence in his locality. The accused initially scaled over the house roof of complainant's neighbor through staircase. As the inmates in that house had already woken up and were alert, he crossed/jumped over to the roof of complainant's house. The accused came down stairs through the open terrace door and bolted the main door from outside. Later he reached/went to the first floor of complainant's house, which is still under construction and further reached ground floor portion of the house where the complainant resides along with his family members through the open duct by climbing down the water pipe. This duct is adjacent to bathroom. After reaching ground floor, the accused removed the glass panes of the ventilator of the bathroom and entered into the bathroom through that ventilator opening. Later he reached the master bedroom adjacent to bathroom and committed theft of cash from one of the wardrobes. At that moment the complainant was sleeping in the adjacent room. After committing theft of cash the accused again climbed over to first floor by using water pipe. At that time complainant heard some

noise and reached the duct area and noticed accused climbing/going up. Complainant raised alarm and tried to nab the accused, but invain as the doors were bolted from outside.

The accused thereafter went to his house and handed over the stolen cash to his mother, who hid cash in the house. The stolen cash of Rs. 11.20 lakhs was recovered at the instance of both accused persons.

The apprehended accused persons along with recovered cash are being handed over to SHO Kalapathar P.S. for taking further action.
