

PRESS RELEASE
HELD (03) ACCUSED – SEIZED (50) QUINTALS OF PDS RICE AND (01) MINI
GOODS TROLLEY.

On 05-10-2017, on credible information the Commissioner's Task Force, Central Zone team worked out on PDS Ration scam and conducted raid at Musheerabad and also intercepted the vehicle at RTC X roads along with the Civil Supply Officials and apprehended (03) accused, in (02) cases who were found indulged in procuring PDS rice on lower price illegally and black marketing the same on higher price to the needy persons for illegal gains and **seized (50) Quintals** of PDS Rice and one Tata Super Ace vehicle No. TS13UA5219 from their possession.

Details of the accused:

1. Mohammed Muzafar Hussain, S/o. Md. Rayeesuddin, age 24 years, Occ. Business, R/o. H.No. 1-4-877/35/A, Near Omer Mosque, Gulshan Nagar, Musheerabad, Bholakpur, Hyderabad.
2. Mohammed Salahuddin, S/o. Late Khaja Moinuddin, age 23 years, Occ. Scrape Business, R/o. Near Anjuman High School, Musheerabad, Bholakpur, Hyderabad.
3. Mohammed Fareed Ali, S/o. Late Md. Yousuf Ali, age 28 years, Occ. Business, R/o. H.No. 1-3-175, Near Registrar Office, Khan Street, Zaheerabad, Sanga Reddy Dist.

Brief Facts of the case:

The accused Mohammed Muzafar Hussain resident of Bholakpur, Hyderabad is procuring PDS rice from the known and unknown PDS rice beneficiaries of Musheerabad and other local places of Hyderabad @ Rs.8/- per KG and diverting the same PDS rice from Musheerabad to Zaheerabad, Sanga Reddy Dist. @ Rs. 12/- per KG to Mohammed Fareed Ali with the help of his own mini trolley vehicle Tata Super Ace vide No. TS13UA5219 and transporting the same PDS rice to Zaheerabad and making huge money. The both the accused while transporting the PDS rice in a vehicle the Central Zone Task Force team along with the Civil Supply Officials intercepted the vehicle near Bajaj Electronics, RTC X roads and seized the PDS rice and apprehended both the accused. The arrested accused persons along with seized material were handed over to SHO, Chikkadapally PS, for taking necessary action.

In another case the accused Mohammed Salahuddin resident of Musheerabad, Hyderabad is procuring PDS rice from the PDS rice beneficiaries of his local area and also with the help of some mediators from other places of Hyderabad @ Rs. 8/- per KG and dumped the PDS rice in his relative residence near Omer Mosque, Gulshan Nagar, Musheerabad, Bholakpur, Hyderabad and selling the same PDS rice to one Mohammed Fareed Ali resident of Zaheerabad @ Rs. 12/- per KG and earning huge profits. On a credible information the Central Zone Task Force team along with the Civil Supply Officials apprehended Mohammed Salahuddin near Omer Mosque, Gulshan Nagar, Musheerabad, Bholakpur, Hyderabad along with the PDS rice. The arrested accused along with the seized PDS rice were handed over to SHO, Musheerabad PS, for taking necessary action.

The accused Mohammed Fareed Ali resident of Zaheerabad collects the PDS rice from Mohammed Muzafar Hussain and Mohammed Salahuddin and export them to Maharashtra and Karnataka @ Rs. 18/- per KG and earning illegal profits.

**CONDUCTED RAID AT BROTHEL - ONE ORGANIZER AND TWO COUSTOMERS
HELD & RESCUED TWO VICTIM WOMEN**

On 04-10-2017, the Sleuths of Commissioner's Task Force, Central Zone Team along with Musheerabad Police conducted raid at one brothel house situated at **Flat No. 407, Prashanth Towers, Musheerabad Main Road, Hyderabad** and apprehended one brothel organizer along with two Customers and rescued two victim women and seized (04) cell phones, 07 No's un used Condoms and net cash Rs 44,500/- from the possession of organizer.

BRIEF FACTS:

The accused Smt. Kalpana Goswamy @ Kalpana is native of Guntur Town and few months back she came to Hyderabad and taken one flat for rent at Musheerabad for running the brothel at Flat No. 407, Prashanth Towers, Musheerabad Main Road, Hyderabad and paying rent of Rs 10,000/- per month. The accused collected sex workers from Districts of Telangana and keeping them in the above said premises, for known customers and collecting an amount of Rs. 3,000/- to Rs. 4,000/- from each customer by giving commission to sex workers. On reliable information, Central Zone Task Force team conducted raid on the brothel house situated at Flat No. 407, Prashanth Towers, Musheerabad Main Road, Hyderabad and apprehended one brothel organizer, two Customers and rescued two victim women and seized (04) cell phones, 07 No's un used Condoms and net cash Rs. 44,500/- from the possession of organizer.

The accused person along with seized material was handed over to the **SHO, Musheerabad PS** for further investigation.
