

**NABBED DOCOITY GANG – 08 HELD
DETECTED DOCITY CASE OF TRIMULGHERRY PS.**

The sleuths of Commissioner's Task Force, North Zone team nabbed **DACOITY Gang** consisting Eight accused persons in which one female, wherein the dacoit gang have conspired together, five accused persons in which three persons wearing masks & one female wearing burkha, entered into the house of complainant Smt. Shamsunnisa W/o. Shahnawaz, Age: 35 yrs, R/o. H.No. 3-10-38, near Football ground, Trimulgherry, Secunderabad by knocking the door, they enquired about her husband Shahnawaz, closed their mouth with plastic tape and tied hands and legs of complainant and her Mother-In-Law by name Iqbal Begum, aged about 65 yrs with the cell tape, they robbed gold & silver ornaments from them and also searched the house, decamped with property i.e 3 tulas gold, 45 tulas silver ornaments on 01-10-2018.

BRIEF FACTS OF THE CASE:-

01-10-2018 at about 1100 hrs five accused persons in which three persons wearing masks & one female wearing burkha, entered into the house of complainant Smt, Shamsunnisa W/o. Shahnawaz, Age: 35 yrs, R/o. H.No. 3-10-38, near Football ground, Trimulgherry, Secunderabad by knocking the door, they enquired about her husband Shahnawaz, closed their mouth with plastic tape and tied hands and legs of complainant and her Mother-In-Law by name Iqbal Begum, aged about 65 yrs with the cell tape, they robbed gold & silver ornaments from them and also searched the house, decamped with property i.e 3 tulas gold, 45 tulas silver ornaments.

On 02-10-2018 the victim by name Iqbal Begum, Age 65 yrs expired.

MODUS OPERANDI:-

The accused A1 Syed Jameel is son in law of deceased. He is an Auto driver, resident of Chilalguda, having huge debts, facing financial problems to clear his debts and to spend lavish life hatched a plan to gain easy money to commit theft of Gold, silver and net cash from his Mother-In-Law's (Smt. Iqbal Begum, Age 65 yrs) residence, situated at Trimulgherry where predicting that his mother- in- law's family having huge money and gold in their house. Few days back the main accused explained dacoity plan to his younger brother Syed Mujeeb(A2) R/o. Bachupally who is having previous criminal record (Murder case of Sanath Nagar PS, Cyberabad) then he accepted to execute their plan.

Then the A2 Syed Mujeeb contacted his associates by name A3. Shaik Abdul Saleem @ Sami (Cab driver) R/o. Banjara Hills, A4. Mohd Imran R/o. Sanga Reddy, A5. Mohd. Ismail R/o. Sanga Reddy, A6. Mohammed Adnan R/o. Mehidipatnam, A7. Mohammed Zameer R/o. Sanga Reddy and A8. Smt. Bibi Begum @ Reshma R/o. Sanga Reddy and explained their plan to commit theft in his relatives house at Trimulgherry Hyderabad, they accepted to commit offence. The accused Syed Mujeeb(A2) along with his associates gathered at his residence at Bachupally and procured three face cover masks, rope, cello tape, three daggers to use in the commission of offence. A3 Shaik Abdul Saleem @ Sameer arranged his Mahindra verito Car Reg no. TS09UA-9855 for transportation.

EXECUTED DACOITY PLAN:-

On 01-10-2018 at about 0930 hrs all the eight accused persons reached near the house of victim/complainant at Trimulgherry. As per their

plan at about 1100 hrs the A4 to A8 Mohd Imran, Mohd Ismail, Mohammed Adnan, Mohammed Zameer & Smt. Bibi Begum entered in to the house of Complainant, **A1 to A3** Syed Jameel, Syed Mujeeb, Shaik Abdul Saleem surveillance the area at a distance of house along with their car in order to escape quickly.

Three accused persons covered their faces with mask to hide their identity, entered into house of complainant Smt. Shamsunnisa, W/o. Shahnawaz, Age: 35 yrs and her Mother-in-law by name Iqbal Begum, Age 65 yrs and threatened them and beat them with hands, closing their mouth with plastic tape tying their hands and legs with cello tape and chunni, when the victims started shouting, the accused persons bolted the doors from inside and robbed Gold Mangalasutram, ear studs, Silver ankles from them, forcibly took the almirah keys from victim, searched in the almiarh and decamped with **gold ornaments weighing 3 tulas & Silver Anklets - 45 tulas.**

Previously the A2 Syed Mujeeb was arrested in Murder case in the limits of Sanath Nagar vide Cr.No. 171/2018, U/Sec.302, 201, 120(B) IPC of Sanath Nagar PS. (U.I)

ARREST:-

Today i.e on 05-10-2018 on tip off the Commissioner's Task Force, North Zone team laid a trap and apprehended (8) accused persons while disposing the gold & silver ornaments.

Seized **Gold Mangalasutram with black pusalu Weg 20 Grams, 2. Gold ear studs two pairs Weg 10 grams, 3. Silver Anklets two pairs Weg 450 grams, 4. Car Reg no. TS09UA-9855 (Mahindra Verito), 5. Cell phones -11, 6. Daggers-03 etc** from the possession of accused persons.

The accused person along with seized material being handed over to SHO, Trimulgherry PS for further investigation.

The accused Vemula Vinay S/o Bala Swamy, aged about 19 years, Occ: Labour, R/o 3rd floor, H.No.8-2-19/373, behind L.V. Prasad Eye Institute, Indira Nagar, Road No.2, Banjara Hills, Hyderabad, N/o D.No.11-2-316, Ward No.28, Macharla, Guntur District, Andhra Pradesh State has been **indulging in a series of theft of two wheeler vehicles in the limits of Hyderabad Police Commissionerate and Nalgonda District** to make easy money and to lead lavish life.

He has committed 9 offences and has been creating large scale fear and panic among the general public and acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Banjara Hills Police made strenuous efforts and arrested the accused Vemula Vinay S/o Bala Swamy on 29.1.2018 in Cr.No.13/2018 U/s 379 IPC of Banjara Hills PS and remanded him to judicial custody. The preventive detention order was executed on him on 30.9.2018 and was lodged him in Central Prison, Chanchalguda, Hyderabad.

Brief Facts

In the evening of 04.10.2018 at about 1800 hrs. Mahankali Police received credible information that two persons moving under suspicious circumstances carrying airbags containing unaccountable Indian currency in the commercial area of Hill Street. Immediately, the Mahankali Inspector Sri. V. Jayapal Reddy and his counter-part Sri. T. Purushotham with the available rushed to the spot and on seeing the Police advancing them, they tried to escape from the spot. But, they were chased and apprehended and on meticulous interrogation by the Police, they revealed their names as 1. Bhavesh Patel s/o Naveen Patel, 36-years, Submersible Machine Fitting r/o H.No. 432/2, Gandhi Nagar, Near Ganesh Temple, Secunderabad Native of Kadi village, Mahesana District, State of Gujarat and 2. Suresh Kumar Dayabai Patel s/o Dayabai Patel, 47-years, Auto Electrician r/o H.No. 6-6-465, Ganesh Temple, Gandhi Nagar, Native of Sankalpur village, Becharaji Taluq, Mahesana District, State of Gujarat and further admitted that they are doing 'Hawala Business' under the directions of their Boss Mr. Ankit Patel and Amit N Mehta of Gujarat State respectively. They further confessed that previously they have delivered the Hawala amount in Hyderabad about three months back and they are working on commission basis on the directions of the above persons. The following unaccountable Hawala Indian Currency has been seized at their instance and possession.

They came in contact with their Boss through one Amith, who was staying in Hyderabad earlier and they adopted this trade for earning money by adopting easy means to lead luxurious life.

Details of the case:

The accused is resident of Hyderabad, his brother is in USA, colluded with criminal conspiracy on the pretext of providing Masters Seat in BPP University at U.K. with the assistance of others and collected huge total amount of Rs.92 Lakhs.

Accused instigated complainant and his father to provide cash of Rs.50 Lakhs to another accused for developing business. The other accused inturn collected Rs.26 Lakhs from the father of complainant and also collected Rs.26 Lakhs from the complainant in the presence of the arrested accused. Accused entered into an Agreement of M.O.U. with the father of complainant and mother of complainant for Rs. 25 Lakhs each and apart from the above amount he took Rs.42 Lakhs on various occasion from complainant and provided Fake Offer letter and CAS receipts.

The accused person along with seized fake documents was arrested by Sub- Inspector of Police, CCS for further investigation and being produced before the Hon`ble Court.

Efforts are continued to trace out the remaining accused persons in this case.

The respondent is native of Hyderabad and organizer of Satta gambling, running in the limits of Police Station Panjagutta and SR Nagar since last ten years, today i.e., on 04-10-2018 while he was accepting the satta betting of Madhur, Kalyan and Mumbai at H.No. 8-4-548/4, near Oxford School, Shankarlal Nagar, Erragadda, Hyderabad with the help of his Sub-Organizer from the known and unknown punters they were apprehended and on search, they were found in possession of net cash of Rs. 30,150/-, (15) Satta Chits and two Cell Phones. The above respondent Mohd Rafeeq is habitual offender and previously three times he was arrested by S.R. Nagar PS and cases were registered against him in the year 2014, 2015 & 2016. Even after arrested for three times, he has not changed his attitude and continuing Satta Betting.

In this case **seized net cash of Rs. 30,150/-, (15) Satta Chits and (02) mobile phones** from the possession of respondent. The above respondent along with seized property is handed over to SHO S.R. Nagar PS for taking necessary action.
