APPREHENSION OF FOUR ACCUSED PERSONS WHO WERE IN POSSESSION OF NARCOTIC DRUG – SEIZED (32) KGs OF GANJA.

On 06-01-2017, the sleuths of Commissioner's Task Force, West Zone team, Hyderabad in a joint operation with Mangalhat Police, apprehended (4) accused persons near Gangabowli, Mangalhat, Hyderabad who were indulged in possession of "Ganja" a Narcotic substance. **Seized (32) KGs of Ganja, (3) Cell Phones, and Rs.35,000/-** from their possession.

Details of the Accused:

1. J.Trinadh @ Arjun S/o Pratap, aged 21 yrs, Occ: Agriculture, R/o Goppalapelem(V), G.Madugula(M), Vishakapatnam Dist, A.P.,
2. Sunil Singh S/o Late Bheem Singh, aged 22 yrs, Occ: Ganesh Idols maker, R/o Ganga bowli, Mangalhat, Hyderabad.,
3. C.Vicky Singh S/o Late C.Rajesh Singh, aged 25 yrs, Occ: Business on the name of Jail Tulja Bhavani Washing Service Center & Ganesh Idols maker, R/o H.No.13-1-1236/283, Upper Dhoolpet, Ganga bowli, Mangalhat, Hyderabad,
4. Ganapathi Singh S/o Rajesh Singh, aged 22 yrs, Occ: Working in Cloths shop styled as "Ramesh & Company" at Begum Bazar, R/o H.No.13-1-1236/434/B, Indra Nagar, Mangalhat, Hyderabad,
5. Balaji, R/o Pardi wada, Fathe Nagar, Sanath Nagar, Hyderabad – **Absconding.**

Details of the case:

The accused J.Trinadh @ Arjun is native of Goppalapelem(V), G.Madugula(M), Vishakapatnam Dist, A.P., He is doing Agriculture work at his native place. From past one year is cultivating Ganja in his Agriculture land and selling to the needy customers for Rs.5000/- per 2 KGs and also purchasing Ganja from villagers who were cultivating Ganja and selling the same to needy persons on higher rates on time being.

The accused Sunil Singh is native of Mangalhat, Hyderabad. He is regularly purchasing Ganja from Goppalapelem(V), G.Madugula(M), Vishakapatnam Dist for Rs.5000/- per 2 KG from J.Trinadh @ Arjun and selling the same in Hyderabad for Rs.10,000/- per 2 KG. In this process he came into contact with the accused Balaji R/o Pardi wada, Fathe Nagar, Sanath Nagar, Hyderabad and both developed friendship with each other. And regularly he is selling Ganja to accused Balaji for Rs.10,000/- per 2 KGs.

The accused Sunil Singh informed the accused C.Vicky Singh about the profits in purchasing and selling of Ganja and asked to join with him to earn money illegally. On which the accused C.Vicky Singh agreed him. Sunil Singh asked his friend Ganapathi Singh to help in transport of Ganja for Rs.5000/-. For which Ganapathi Singh agreed with Sunil Singh.

About one week back the accused persons Sunil Singh, C.Vicky Singh and Ganapathi Singh went to Goppalapelem(V), G.Madugula(M), Vishakapatnam Dist by bus and met with J.Trinadh @ Arjun and purchased Ganja about 40 KGs for Rs.5000/- per 2 KG and brought the same to Hyderabad and sold 18 KGs Ganja to Balaji and remaining 10 KGs kept with the accused C.Vicky Singh and 12 KGs kept with accused Sunil Singh.

Later the accused Sunil Singh informed the accused J.Trinadh to sell 10 KGs Ganja to him. On which today i.e. on 06-01-2017 the accused J.Trinadh came to Hyderabad along with 10 KGs Ganja and while delivering the Ganja at the house of Sunil Singh, Task Force Police apprehended them along with Ganja.

The accused persons along with the seized material were handed over to SHO, Mangalhat PS, Hyderabad for further investigation.
