LSD DRUG PEDDLERS HELD: SEIZED (75) STAMPS OF LSD DRUG, (30) GRAM OF CHARAS, (01) GRAM HEROIN AND (30) GRAMS GANJA

Today i.e. on 06-02-2018, on the joint operation of Commissioner's Task Force, Central Zone Team with Narayanaguda Police, apprehended Three persons, who were selling LSD (Lysergic acid diethylamide) drug to the users and **seized (75) stamps of LSD Drug, (30) gram of Charas (01) Gram Heroin, (03) Ganja packets (weighing about 40 Gram),(04) cell phones and one Ford Endeavour Car from their possession.**

Details of Accused:

1. Agala Alumah Friday S/o Agala, age: 30 years, OCc: Drugs Business, R/o near Morgim Beach, Goa, MH N/o No.20 LIMPOPO Street, Maitama Abuja, Eunugu State, Nigeria Country.
2. Abid Nazir @ Abid @ Tiger S/o Nazir Ahmad Mir age: 27 years, Occ: business R/o near Sony Gust House, Ajuna Beach, Goa, MH N/o H.No. 4, Rainawari, Srinagar, Jammu Kashmir.
3. Yash Sunkara @ Yash S/o Rajashekar Sunkara, age: 19 years, Occ: B.B.A II nd year Student- St. Pauls Degree College R/o H.No. 2-2-186/20, Ramakrishana Nagar, Baghamberpet, Hyderabad.

Brief about the Accused

The accused Yash Sunkara @ Yash r/o Bagh Amberpet. He is pursuing Graduation in BBA from St. Pauls Degree college, Himayathnagar. He visits Goa frequently. Once his visits Goa last year his friend asked him to bring LSD from one known person peddler called Abid Nazir @ Abid @ Tiger a resident of Goa N/o Srinagar, Jammu and Kashmir, like wise he made friendship with the peddler Abid @ Tiger and started business with him, whenever he visits Goa he update his status over "SNAP SHOT" application and notify to his friends and known customers about his visit to Goa. Whoever requires drugs i.e. LSD/Herion/Charas they will order him. He purchases Drugs for Low price from Peddler Abid @ Tiger and sell the same to his friends and known customers for Higher price. Yash Sunkara in the above manner purchased the LSD drugs several times from Abid @ Tiger and brought them to Hyderabad along with him and sold them to his friends and known customers. Yash purchases one LSD drug stamp from Abid Nazir @ Abid @ Tiger for Rs. 1000/- to Rs. 1500/- per stamp in Goa and sell them to his friends for Rs. 2000/- to Rs. 3000/- per stamp to needy students/customers. In turn the Abid Nazir @ Abid @ Tiger purchases drugs from one Nigerian Drug peddler Agala Alumah Friday R/o Goa.

Few days back Yash Sunkara asked Abid Nazir @ Abid @ Tiger to bring LSD Stamps and Charas to Hyderabad as there is much demand in city. As such today Abid Nazir @ Abid @ Tiger along with One Nigerian Drug peddler Friday Agala Aluma came to Hyderabad along with LSD Stamps and charas and waiting near Madhushala Bar & Restaurant, Hyderguda, Hyderabad. On credible information, today Central Zone Task Force team apprehended Abid Nazir @ Abid @

Tiger, Friday Agala Aluma and Yash Sunkara while they are trying to handover the drugs to Yash Sunkara near Madhushala Bar & Restaurant, Hyderguda, Hyderabad and seized drugs.

During the investigation it is also came to know that the Nigerian drug peddler Friday Agala Alumah came to India on his Tourist Visa for two months i.e., 20.05.13 to 19.07.13 and did not return to his country even after his Visa expired and over staying in INDIA and also doing illegal drugs selling business.

LSD (Lysergic acid diethylamide) Drug:

It is also known as lysergide and colloquially as acid. LSD is most potent, mood changing chemical such as anxiety, paranoia, and delusions are possible. The LSD is commonly added to absorbent paper and divided in to small squares. LSD is extremely poisonous ergot fungus its effects are un predictable. A small amount can produced 12 hrs of effects. The selling price will be ranged between Rs.2,000/- to Rs. 3,000/- per stamp depending upon customers and their urgency.

The accused persons along with the seized drugs being handed over to SHO, Narayanaguda PS for further investigation.

Kantha Reddy, Sri G. Thimmappa and staff of Commissioner's Task Force, Central Zone team.

After completion of his work he did not return to home so far. Today i.e. 05-02-2018 her wife enquired at his work place & the owner said that he was not coming to work from 01-02-2018. And also stated that her husband frequently saying his salary is not enough to maintain the family so would like to change the work place within 10days as he said. In this regard she tried to all possible places and relatives about her Husband but no fruitful information is received about her husband till today. Hence FIR.

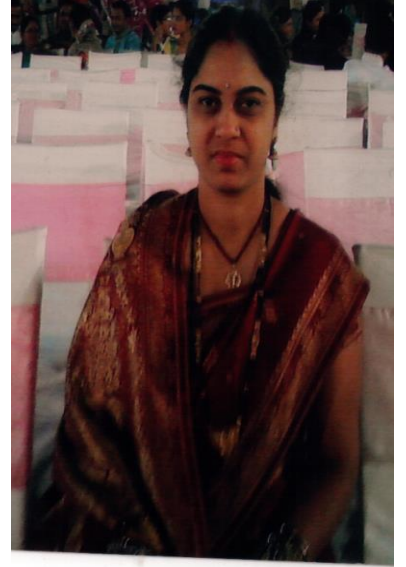
