PRESS RELEASE

The Cyber Crime PS, Hyderabad City apprehended a notorious conman involved in befriending girls through social media (facebook) chats & collected their nude pictures in the guise of love and blackmailing the victim & her father saying he would upload the said nude pics on the internet.

Details of the accused:

Devendra Singh S/o Om Prakash Singh, Age" 25yrs, R/o Gurugoa, Haryana State N/o Jaipur Rajasthan.

Facts of the case:

The brief facts of the case are that on 02-04-2018 received a complaint that on 27.03.2018 the complainant received Whatsapp calls and messages from mobile no 7014834253 to his mobile. These messages contained life threats to himself, his family members and his brother and also included blackmailing tactics. On 28-03-2018 he received message from the same number threatening him with dire consequences and also pressurizing and blackmailing the complainant to send his Daughter to Delhi otherwise he will send her personal photographs to their relatives and friends and also post the same in social media i.e., face book etc. and also threatening to kill their children and still continuing the threatening calls as well as Ugly messages and photographs.

Based on the complaint, a case vide FIR No. 82/2018 was registered and is investigated into. The cybercrime police obtained the required details of the accused and tracked him at Gurugoa, Haryana State and apprehended him.

The accused Devendra Singh had completed his graduation at Jaipur, Rajasthan state and worked in Genpact Company at Jaipur. His facebook profile ID is DevanBareth. He came across the facebook profile of the victim while browsing facebook randomly. He sent friend request to her and she accepted it. Initially he started to wish her & chat politely and gained her confidence and used to chat regularly and made her believe that he would marry her. He lured her to send nude/porn or seminude pictures online. He saved all her pictures and subsequently started forcing her to come to Delhi or Haryana to meet him. Recently as he came to know that she got engaged with another person. He started blackmailing her to come to Delhi or else, he would post her nude pictures in social media/internet.

The general public is warned not to make friendship with strangers on social media or matrimonial sites and should not share their personal details or photographs with anyone online and also set their profile security settings to private so that outsiders cannot access their personal data.

Brief details of the case ar tthat:-

“The NINE accused persons, 4 others (absconded accused persons) and a boy juvenile are close friends. A-2]. **Shah Noor Gazi @ Shanoor @ Iffu** is the Rowdy Sheeter of P.S. Kalpattar and he has been addicted to consume Toddy (Kallu), Liquor & Ganja, Cigarettes and inhale of whitener (correction fluid) since long time.

One Shaik Imam had conducted an engagement function of his daughter Saba Begum in Tarikat Manzil function hall, Hussaini Alam, Shah Gunj, Hyderabad in the intervening night of 1/2-04-2018. For the function he has invited his friends and relatives. The boy juvenile Shaik Azam @ Farhan is the son of Shaik Imam and a close friend of A-2. Boy juvenile invited the A-2 and his associates for the function. After the celebration of the engagement function, the complainant Sri Mohd Sohail and the deceased Sri Anwar Khan @ Annu Ba was making arrangements for dinner. The A-2 along with his friends had dinner and left the place at about 00:30 hours. At about 01:00 hours A-1 along with his friends including boy juvenile sat at the table just right to the main gate and started nuisance alleging that the suppliers did not supply them enough mutton, chicken and shouted at the pitch of their voice. Meantime the complainant and the deceased went to A-1 and tried to pacify the issue. But instead of heeding, he has attacked the food catering suppliers. In order to avoid further nuisance, the deceased slapped A-1 and the complainant reprimanded him to maintain decency. On that he grew wild and challenged to kill them within no time and searched for his friends, since they were not there. He went outside and called them on phone to come with knives immediately as he wanted and prepared to kill the complainant and deceased. Within few minutes the accused persons A-2, A3 and others rushed to the function hall with knives and asked the A-1 to show the deceased and complainant. Meantime while A-1, A-2, A-3, A-6 to A-13, boy juvenile and others started chasing the deceased. By knowing the deceased, all the accused persons caught hold him, beat him with hands and kicked. Meantime A-2 attacked on him with knife, stabbed him on the left ribs and other parts of the body, resultdign which he collapsed on the ground with the stav injuries. A-1 pointed out the complainant and encouraged other accused to kill him. All the accused caught hold the complainant, beat him with hands and kicked, A-3 attacked on him with a knife, as a result he also collapsed on the ground with the stab injuries. Afterwards all the accused persons escaped from the spot.

In this case there is no negligence by the Police. Soon after receiving information about the incident Police receached scene of the offence immediately. In a shot time Police arrested 9 accused persons.

A special police team have been formed to apprehend the absconded accused persons and theory on the job.

LAKE POLICE RESCUED THREE PERSONS FROM COMMITTING SUICIDE

On 05th & 6th of April 2018, P S Lake officials has rescued **Three persons** in different timing and situation i.e., One male & two female. Were all rescued, while they were about to commit suicide by jumping into the Hussain Sagar Lake. The Details of the victims are as follows:-

First incident: Occurred on 05/04/2018 at 2100 hours tried to jump into water near Old LOVE HYD statue.

Details of Victim: one man, age:- 54yrs, occ:- retired railway employee r/o:- Boudh nagar, warasiguda, secunderabad.

Reason: on enquiry it came to know that he is a married person and blessed with three sons. He quarrelled with his two younger sons in a petty family issue. Due to which he went into depression and came. I counselled him promptly and after counselling handed over to his elder son & family members.

Second incident: It occurred on 05&06/04/2018 at around 2310 hours upper tankbund opp Bademiya kabab.

Details of Victim:- one women, age:- 38yrs, occ:- housewife, r/o:- Gowlipur, Sultan sahi, hyd.

Reason: on enquiry it came to know that she is a married person and blessed with three children. Due to some petty family issues she went into depression and came. I counselled her promptly, after counselling handed over to her husband.

Third incident: It occurred on 06/04/2018 at around 1815 hours upper tankbund old LOVE HYD statue.

Details of Victim:- one women, age:- 35yrs, occ:- housewife, r/o:- Anjaiah nagar, Gachi bowli, hyd.

Reason: on enquiry it came to know that she is a married person and blessed with three sons. Victim's husband doesn't do any job and he is an alcoholic. Victim also said that her husband starts quarrelling regularly after having alcohol and abuses her in a most filthy language by suspecting her character. Even after victim asked him many times to stop consuming alcohol and go for job and to look after his family but he never heed to her words. Today in the morning hours after having alcohol he started quarrelling with victim and abused her in a most filthy language. Due to which she fedup on her husband behaviour and decided to end her life and came. I counselled both the victim and her husband promptly, after counselling handed over to her father.

As such Lake Police played a vital role in saving them spontaneously without giving any scope for untoward incidents for which they could save the

lives of people. These three incidents were occurred on 05/06-03-2018. I counselled them promptly and they were safely handed over to their relatives and concerned by taking their assurances that they will not repeat such things in near & future.

Thus, the patrolling Blue Colts of Lake PS viz., HC 7622, Bhaskar reddy, WHC 8499, Jayapradha, PC 4295 – C. Sai kiran, HG 2039 – B. Krishna, have tactfully identified the above persons in a suspicious manner and rescued them from committing suicide.
