

## **PRESS RELEASE**

The Marketing Intelligence Team of Cyber Crimes PS, CCS, DD, Hyd City have arrested two accused A-1) Methari Praneeth, A-2) Thakur Krishna Kishore Singh who had cheated the complainant to the tune of Rs. 4,000/- on the pretext of providing services for getting Police Clearance Certificate by registering their Priyanka Consultants in Justdial and contacted over phone in Cr. No. 166/2017, U/s 419,406,420 IPC & Sec 66 (D) of ITA Act of PS Cyber Crimes.

### **FACTS OF THE CASE:**

Facts of the case are that on 01-07-2017, received a complaint from Sri B. Narasinga Rao, Age: 34 yrs, Occ: Software Employee, R/o Seethaphalmandi, Sec in which he stated that he had approached Justdial for police clearance agents in Hyderabad. The same day he got a SMS from Just Dial regarding consultancy Phone number. The next he got a call from Priyanka Consultants at BHEL Hyderabad. One Praneeth has spoken him from 9393931932, when he explained his requirement of getting Police Clearance certificate, Mr. Praneeth asked him to send 7000/- to SABBANI GANGADHAR account :- 302510100006719 and Praneeth also asked him to send the documents, like passport, photo, Aadhaar card to mail ID: [bkhero2037@gmail.com](mailto:bkhero2037@gmail.com). he had sent all the documents from his mail ID and the same day he has transfer an amount of total Rs. 4,000/- from his account to above account. After fund transfer, they are not responding the calls as well as SMSs when he enquired in google they are lot of negative remarks against the Priyanka Consultants. He requested to take necessary action.

### **Details of the arrested persons**

**A-1)** Methari Praneeth S/o M. Balaraj, age: 19 years, Occ: Polytechnic 2<sup>nd</sup> Year, R/o H. No. 1121, MIG, Phase – I, BHEL, Sherlingampally, Hyderabad-32, N/o Andol (V), Jugipet (M), Medak, T.S.

**A-2)** Thakur Krishna Kishore Singh S/o T. Jaidev Singh, age: 38 yrs, Occ: MR Shiva's Consultancy, R/o H. No. 123, MIG, Ramchandra Puram, B.H.E.L., T.S.

### **MO. OF THE OFFENDER**

The accused A-1 had procured the ATM card of his friend and SIM card from other friend by requesting them. The accused A-1 with the help of A-2 had registered a consultancy by name M/s Priyanka Consultants, BHEL in Justdial saying he would provide the services of Marriage Certificate, Police Clearance Certificate, Firm Registration Etc. Thereafter, the accused has been collecting service charges from the customers who approach him through Justdial. After collecting money, he would never give response to the calls of the clients. The A-1's phone numbers are 9393931932, 8897109105 and email Id: [bkhero2037@gmail.com](mailto:bkhero2037@gmail.com). In the same way, the complainant had approached the accused A-1 through Justdial in the month of June, 2017 asking the services of Police Clearance Certificate. The A-1 had collected Rs. 4,000/- through online transfer and never answered his calls or SMSs. The amount was shared by A-1 & A-2.

The team headed by Inspector of Police Sri. G. Shanker Raju consisting of team members S.I. Sri Lachi Reddy, SI Sri Ramesh, HC Sri K. Thakur, Chandra Shekar and PC Sunil, Qamar under the direct supervision of ACP Cyber Crimes Sri. K. C. S. Raghu Vir has cracked the said case.
