South Zone Police arrested the gang of the following accused persons involved in a brutal murder of one Mohd Akram resident of Amannagar, Yakuthpura, Hyderabad in crime no.204/2017 U/s 302 R/w 34 IPC of Reinabazar PS, Hyderabad.

Complainant: Sri Mohd Moulana S/o late Pashu Miya, age:50 years, Occ:Auto Driver, R/o H.No.18-7-418/248, near Saba Hotel, Amannagar-A, Yakuthpura, Hyderabad

Deceased Name : Mohd Akram S/o__Mohd Moulana, age: age:24 years, Occ:Electrician, R/o H.No.18-7-418/248, near Saba Hotel, Amannagar-A, Yakuthpura, Hyderabad

Accused Persons

A1) Mir Akber Ali S/o Mir Murtuza Ali, age 22 years, Occ DCM driver, R/o H No 17-3-433/116, Ganga Nagar Nala, Yakuthpura, Hyderabad.

A2) Mohd Majeed @ Abbu S/o Mohd Sadiq, age: 21 years, Occ:Cook, R/o H.No.18-7-425/432/50, Bhavani Nagar, Road No.10A, Talabkatta, Yakuthpura, Hyderabad.

A3) Mohd Azher S/o Mohd Arif Hussain, age:19 years, Occ:Auto Driver, R/o Opposite to Madina Hardware galli, Reinbazar Chaman, Beside Medium Hotel, Yakuthpura, Hyderabad.

A4) Shaik Ahmed S/o Shaik Shoukath, age: 20 years, Occ:Cook, R/o H.No.18-7-425/432/80, Amannagar-B, Talabkatta, Bhavaninagar, Hyderabad.

A5) Habeeb Sikander S/o Mohd Javeed, age:19 years, Occ:Labour in furniture shop, R/o H.No.18-7-408/57/2, Rahamath Nagar, Yakuthpura, Hyderabad.

A6) Shaik Arif S/o Shaik Mohammed, age: 27 years, Occ:Auto Driver, R/o H.No. 4-102/4, Errakunta, near omer farooq mosque, Shaheennagar, Barkas, Hyderabad(**Absconded**)

The facts of the case are that on 05-10-2017 at about 6:00 am Sri Mohd Moulana S/o late Pashu Miya, age:50 years, Occ:Auto Driver, R/o H.No.18-7-418/248, near Saba Hotel, Amannagar-A, Yakuthpura, Hyderabad came to police station and lodged a complaint stating that on the intervening night of 04/05/10-2017 at about 2:30 am the accused persons Mohd Azher, Shaik Ahmed @ Ajju and Habeeb Sikander came to his house and took to his son Mohd Akram on pretext there is some personal

urgent work. The complainant asked one Rasool who is family friend to accompanied to the Akram. After some time Rasool returned back and informed that A1)Akbar, A2)Majeed, A3)Mohd Azher, A4)Shaik Ahmed @ Ajju and A5)Habeeb Sikander attacked and killed to his son Mohd Akram at Ganga Nagar graveyard. Basing on this complaint a case was registered.

The A1 to A5 has been apprehended on 06-10-2017 at 9:30 am at Dabeerpura Railway station while they are trying to disappear through train to avoid their arrest. On interrogation the accused persons admitted their guilt for committing this offence due to previous enmity and suspect the deceased as police informer.

CHARACTER: The A1 to A5 are having bad habits for consuming liquor, smoking ganja and taking Nitrosum 10 mg tablets regularly and they used for moving in the locality in the night hours and they used to threaten to the innocent people and extort money from them, but nobody coming forward to complaint against them, due to fear The A1 to A5 are involved in number of cases including murder, attempt murder, hurt, extortion and theft cases.

Nitrosum Tablet works by affecting the way certain brain chemicals transmit messages, resulting in sleepiness and relaxation.

MOTIVE: The accused persons used to extort amount from the deceased. Since few days he has not given the amount to them and refused. Since then the accused persons became in bore and grudge. In the month of June 2017, the A3 Azher was arrested in four automobile theft cases and he suspected that, the deceased passed the information to the police and acted as police informant. Basing on the above reasons the enmity developed between accused and deceased, resulting which they hatched a plan and murdered the deceased on the intervening night of 04/05-10-2017.

In this case the A6 Shaik Arif who is absconded had given assurance to A1 to A5 for moral help after commission of the offence and he well known the enmity between deceased and A1 to A5 and also having knowledge about the planning for murder to the deceased.

Before for committing this offence the A1 Mir Akbar Ali extorted an amount of Rs.5,000/-, one cell phone from Mohd Raheem at meraj Hotel, Yakuthpura on 04-10-

2017 at 1920 hours. In this connection a separate case has been registered at PS Reinbazar in crime no.203/2017 U/s 386, 324 IPC.

RECOVERY:

- 1) One dagger/Knife recover from the position of A1 Mir Akbar Ali as which is used in the commission of offence.
- 2) One Stone having blood stains seized from the scene of offence.

All the accused persons being produce before the Hon'ble VIII ACMM, Nampally,
Hyderabad and send them to judicial remand.

In this case, the investigation done by Sri M.A. Javeed, Inspector of Police, Reinabazar Police Station with the assistance of the Sri Balu Chowhan, Addl. Inspector of Police, Reinbazar PS, Hyderabad, Sri G. Srinivas Reddy and Sri Govind Swamy Sub-Inspectors of Police of Reinbazar Police Station under the supervision of Sri Ashoka Chakravarthy, Asst. Commissioner of Police, I/C Mirchowk Division, Sri K. Babu Rao Addl. Dy. Commissioner of Police, South Zone, Hyderabad.

P.D Act Proposals: Since all accused involved in the various criminal cases and normal cases under law for time being enforced are not having deterrent effect on them prevent the further offences , Hence proposals are being submitted to detained them under P.D. Act.
