

**PD ACT INVOKED AGAINST PETLA MAHESH S/O ADIMAIAH, PROPERTY
OFFENDER OF BANJARA HILLS PS, WEST ZONE, HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued a preventive detention order under the Act No.1 of 1986 against Petla Mahesh S/o Adimaiah, property offender of Banjara Hills PS on 19.9.2018.

The accused Petla Mahesh S/o Adimaiah, aged about 21 years, Occ: Labour, R/o Krishna Nagar, Opp: Priyanka Wines, Yousufguda, Hyderabad, N/o D.No.12-2-338, Ward No.21, Macharla, Guntur District, Andhra Pradesh State has been **indulging in a series of theft of two wheeler vehicles in the limits of Hyderabad Police Commissionerate and Nalgonda District** to make easy money and to lead lavish life.

He has committed 9 offences and has been creating large scale fear and panic among the general public and acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Banjara Hills Police made strenuous efforts and arrested the accused Petla Mahesh on 29.1.2018 in Cr.No.13/2018 U/s 379 IPC of Banjara Hills PS and remanded him to judicial custody. The preventive detention order was executed on him on 30.9.2018 and was lodged him in Central Prison, Chanchalguda, Hyderabad.

CRACKED ONLINE ATM CARDS CHEATING AND NABBED AN INTERSTATE GANG - 02-HELD

On 05.10.2018, the Commissioner's Task Force, East Zone Team, Hyderabad, apprehended two persons namely 1) Mohd Afrozuddin @ Ali and 2) Pankaj Sachadeva H.No.18-12-418/A/74, Hafeezbaba Nagar, Kanchanbagh, Hyderabad, Who were indulged in manipulating the ATM Cards magnetic strips by erasing its data through one MSR Data Reader and writer swiping machines and entering the data obtained by one software named ICQ and earning easy money illegally.

BRIEF FACTS OF CASE: -

Acting on a tip off, the Commissioner's Task Force, East Zone Team, Hyderabad, apprehended an interstate gang consisting of two persons namely 1) Mohd Afrozuddin @ Ali and 2) Pankaj Sachadeva.

During the interrogation, the accused Mohd Afrozuddin @ Ali and Pankaj Sachadeva confessed that, they both came into contact through one of their common friend and developed friendship. Accused persons hatched a plan to earn easy money illegally. In this process they downloaded one app which provides the ATM Card holders data along with PIN. The said accused persons purchased the ATM Card holders data along with their PIN numbers from the prospective seller by paying the amount through bitcoin. The accused persons by using MSR equipment erased the old data on old ATM cards and insert the new data in same Cards and committed offences by withdrawing the amount in ATMs. Seized 02-Compaq laptops, one swiping machine (MSR Data Reader and writer), 02-cell phones, ATM Cards and from their possession. The accused persons along with seized property were handed over to SHO Kanchanbagh.

On 05-10-2018, on the tip off, the East Zone Task Force team apprehended two accused persons namely 1) Mohd Afrozuddin @ Ali and 2) Pankaj Sachadeva at H.No.18-12-418/A/74, Hafeezbaba Nagar, Kanchanbagh, Hyderabad and seized 02-Compaq laptops, one swiping machind (MSR Data Reader and writer), ATM Cards and 02-cell phone from their possession.

The above said arrested accused persons and seized property were handed over to SHO, Kanchanbagh PS, for taking further action.
