

**COCK FIGHTS BETTING BUSTED - APPREHENDED TWENTY NINE PERSONS
& SEIZED 17-FIGHT COCKS, 60-SHORT KNIFES, 26-MOBILE PHONES, ONE
BOOK (KUKKUTA SHASTRAM) AND NET CASH OF RS.80,150/-**

The sleuths of Commissioner's Task Force, West Zone Team, Hyderabad On 07-01-2018, generated actionable information after making sustained efforts and apprehended 2 Organizers of Cock fight betting and 27 Cock fights betting Punters in the limits of Jubilee hills Police Station **Seized Fight Cocks- 17, 60-Short Knives, 26-Mobile Phones, One book (Kukkuta Shastram), Net cash of Rs. 80,150/-**

Particulars of the Accused:-

1) Malle Venkata Krishna S/o M.Venkataiah, aged 39, Occ: Building material supplier, R/o H.No.8-3-231/C/20, Sri Krishna nagar, Jubilee Hills, Hyderabad, N/o Vaikuntapuram, Kavali NelloreDist, A.P

2) Thanneru Venkata Prasad S/o T.Venkaiah, aged 49yrs, Occ: Building material supplier, R/o H.No.8-3-231/B/378-379, Sri Krishna nagar, Jubilee Hills, Hyderabad, N/o Chagollu (V), Ulavapadu (M), Prakasham Dist, A.P

The accused Malle Venkata Krishna is Building material supplier, but his earnings are not sufficient to meet his family expenses. At the same time one person by name Thanneru Venkata Prasad is met him hatched a plan to organize Cock fight betting, for which he accepted to organize Cock fight betting and they both organizing cock fight betting directly from the punters at the residence of H.No. 8-3-231/B/378-379, (Pent House) Sri Krishna nagar, Jubilee Hills, Hyderabad. On 07-01-2018 he along with other persons are running Cock fight betting in an organized manner **Premises. No. 8-3-231/B/378-379, (Pent house), Sri Krishna nagar, Jubilee Hills, Hyderabad by Prepared the roof of the 5th floor for this Cock fighting purpose and prepared a ground with sand and covered the place by raising the railing walls with tin sheets and accepting Cock fight betting amount directly and indirectly.**

The apprehended accused persons along with seized property were handed over to the SHO, Jubilee PS, Hyderabad for further action.
