

**TWO HELD – WHO USED TO THREATENED CALLS TO THE SOFT WARE  
EMPLOYEE IN HYDERABAD**

On 07-10-2018 the sleuths of Commissioner's Task Force, Central Zone team apprehended Two-persons Kokkiligadda Venkateswara Rao @ Venkateshwar and Thatikonda Naveen Reddy @ Naveen who were threatening one Software employee over Phone in Saidabad, Hyderabad and demanding money from him and Seized (01) Two Wheeler make Activa, **(03) Cell phones and sim No. 9848265271 and 8897602350** which was used in the commission of offence from their possession.

**Details of the accused:-**

1. Kokkiligadda Venkateswara Rao @ Venkateshwar S/o Late K. Eshwarudu, age: 51 years, Occ: Party worker of Unity Center of Communist Revolutionaries of India (Marxist Leninist) (UCCRIML) near Charmas, Malakpet, Hyderabad R/o near Maruthi Nagar, Chaithnyapuri Colony, RR Dist. N/o near Ramalayam, Santhnagar, AutoNagar, Vijayawada, Andhara Pradesh.
2. Thatikonda Naveen Reddy @ Naveen S/o Thatikonda Biksham Reddy, age: 23 years, Occ: Student (B.Tech) from Druva Institute of Engeneering and Technology, Tuppranpet R/o near Basham School, Dilsuknagar, Hyderabad N/o H.No. 7-91/2, Pulgamvari Gudem, Suryapet Mandalam, Balemla, Nalgonda, Telangana.

**Brief facts of the Case:-**

On 06-10-2018 received a complaint from one Software Employee by name Aditya Reddy who is resident of Saidabad Colony, Hyderabad stating that he is working in one of the Software companies in Hyderabad from last few years and he has also builder. On 05-10-2018 unknown two persons came on Two wheeler to the complainant house acting as a party workers of Unity Center of Communist Revolutionaries of India (Marxist Leninist) (UCCRIML) and met his father in his absence and threatened his father and left from there and called him over his phone and threatened with dire consequences and demanded amount to him for party work and he should meet them immediately, if he did not respond to their demands or informed this matter to anyone he threatened that he will kill him.

Basing on the complaint registered a case in Cr.No.299/2018 U/s 385, 507 IPC at Saidabad Police Station.

Considering the seriousness and sensitivity of the issue, the Central Zone Task Force team apprehended the accused Kokkiligadda Venkateswara Rao @ Venkateshwar and Thatikonda Naveen Reddy @ Naveen on 07-10-2018.

**Brief about the Accused:-**

The accused Kokkiligadda Venkateswara Rao @ Venkateshwar is native of Guntur. Since ten years he is working as a party worker in Unity Center of Communist Revolutionaries of India (Marxist Leninist) during which he came in contact with Thatikonda Naveen Reddy @ Naveen who is also working for the same party and actively participating in the activates of the party and he is active member of DSO (Democratic Students Organisation). They collected names of business/rich persons who are financially very strong like contractors, builders and Software companies Directors, managers and employees. Since they are facing financial crisis and debts and not meeting their expenses, then they hatched a plan to threaten few contactors and builders using their party name and earn easy money. As per their plan on 05-10-2018 started threatening calls to Software employee from phone by demanding huge money and threatened him that, if he informed this matter to Police they will eliminate him.

Both the accused along with seized cell phones, Two-Wheeler Communist literature and list of persons/Business/Builders who are financially sound and their phone numbers and addresses was handed over to SHO, Saidabad PS, for taking further action against the accused.

The arrest was made under the supervision of Sri. P. Radha Kishan Rao, Deputy Commissioner of Police, Commissioner's Task Force by Sri Sayini Srinivasa Rao, Inspector of Police, Central Zone Team Task Force and SIs Sri B. Kantha Reddy & Sri G. Thimmappa along with the staff of Central Zone Team, Commissioner's Task Force, Hyderabad.

### **SURPRISE CHECKINGS ON PUBS IN THE LIMITS OF JUBILEE HILLS PS – APPREHENDED (6) RESPONDENTS WHO WERE RUNNING THEIR PUBS BEYOND TIME LIMITS**

On 06/07-10-2018 the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad City conducted surprise checks on Pubs in the limits of Jubilee Hills PS and booked (6) cases against the owners of the following pubs.

#### **Particulars of respondents:-**

1. "Ari Live Pub", Road No.36, Jubilee Hills, Hyderabad.
2. "Karma Pub", Road No.2, Jubilee Hills, Hyderabad.
3. "Dock 45 Pub", Road No.45, Jubilee Hills, Hyderabad.
4. "Amnesia Lounge Pub", Road No.36, Jubilee Hills, Hyderabad.
5. "788 Avenue Pub", Road No.36, Jubilee Hills, Hyderabad.
6. "Vapour Pub", Road No.36, Jubilee Hills, Hyderabad.

#### **Facts of the case:-**

As per the guidelines, the concerned authorities of pubs have to run their pubs up to midnight 12 AM in week days i.e. Monday to Thursday and up to midnight 1 AM in the weekends i.e. Friday and Saturday nights. But the above said managements of the Pubs run their pubs beyond time limits and created lot of nuisance in the area. The same was photographed.

Hence booked (6) cases against the above said pub owners and handed over them to SHO, Jubilee Hills PS for further action.

#### **Note:-**

*Those who were running the Pubs without following the guidelines, stringent action will be initiated against the owners of the Pubs i.e. a special report will be submitted to Excise Department for cancellation of Pub License.*
