

**SIX PERSONS HELD – IN SEXUAL JEALOUS MURDER CASE OF PS
FALAKNUMA (Cr.no.46/2018 U/s 120 B, 302 r/w 34 IPC).**

Brief facts of the case:

on 02.03.2018 received complaint from Syed Abubakar s/o Late Syed Jaffar, aged about 31 years , R/o Jahanuma, Falaknuma, Hyderabad who is brother of the deceased Syed Esa. Inwhich the complainant stated that on 1-3-2018 at about 10 pm his brother Esa went out from the house to bring Chocolates for children. After 20 minutes local people informed the complainant that his brother Esa was attacked by someone at Mamu Ka Hotel, Bibi ka Chashma. Immediately complainant rushed to the spot and found his brother Esa lying on the road in a pool of blood with multiple stab injuries over his chest, neck and other parts of the body, he shifted his brother Esa to Osmania General Hospital for treatment where the duty doctor declared brought dead. Later the complainant came to know that, Naveed Khan, Javeed Khan, Hyder Khan, wajid Khan, Sajid Khan, Lateef (Maternal Uncle) and Aziz (Brother-in-law) hatched a plan to eliminate Esa, upon which they called Esa to Mamu Ka Hotel and picked up a quarrel with Esa for leaving the illegal intimacy with the Raziya @ Taha Fatima wife of Waheed Khan who is elder brother of Naveed Khan. While arguing Naveed Khan took out a knife from his pocket and stabbed the complainant's brother Esa over the chest, neck and stomach, due to which his brother Esa collapsed.

Motive:

The Deceased Esa (Rowdy Sheeter of PS Falaknuma) is maintaining illegal intimacy with the Raziya @ Taha Fatima wife of Waheed Khan who is elder brother of Naveed Khan (**A1**) and also threatened Waheed Khan by sending audio messages through Whats aap "**Tera biwi k uper ab mere huq hai tera nahin.**" Upon which the accused persons bore grudge against Esa and hatched a plan to eliminate.

Today i.e. on 08-03-2018 Accused persons A1, A4 and A6 were arrested at Maddanapet (A6 Wajid's house) and A2, A5 and A7 at Golkonda (A7 Aziz's house) The above arrest were made by SIs Sri L. Narendar and Sri. M. Ramakrishna and staff of PS Falaknuma and this case investigated by SHO of Falaknuma Sri P.Yadagiri, under the supervision of ACP Falaknuma Sri. Syed Fiaz, and Sri. Ghouse Moinuddin, Addl Dy. Commissioner of Police.

ONE PERSON HELD - SEXUAL ASSAULT WITH MINOR BOY.

Brief facts of the case:

On 05-03-2018 received Complaint from Zia Ur Rahman S/o Aziz Ur Rahman age 42 yrs Occ: Cab driver R/o Madina colony, Jahanuma, submitted that 2nd son by name Abdul Aziz Madani age 9 yrs, studying in 2nd Class in Good Faith School. Since 1 month his two sons are going to study Arabic Noorani Khaida at Masjid-e-Yousuf, Madina Colony. On 05-03-2018 at 1830 hrs his 2nd son by name Abdul Aziz Madani returned home in a uncomfortable condition, and stated that his Arabic teacher Molvi an Imam Irfan took the child into toilet and opened pant zip and kept the child's penis in the Molvi's Mouth for 3-5 minutes after that Molvi gave 10 rupees and also threatened not to reveal. Earlier also the Molvi open child's pant zip and kept his hand inside pant when all the student left the Mosque.

Motive:

The accused person Mohammed Irfan is an Imam of Masjid-e-Yousuf, Madina Colony and also teaches Arabic to the students during the evening hours, he behaved unnaturally with the victim involved in "**Oral sex**" with a minor boy.

The behaviour of Molvi with a minor student causes damage to the profession in the society. In the recent past Imams and Molvis involved in so many sexual assault cases with a minor child's.

Today i.e. on 08-03-2018 Accused person was arrested at Talab Katta (his house) by SI Sri. M. Ramakrishna and PC 1679, 9887 of PS Falaknuma with the assistance of SHO of PS Falaknuma Sri. P. Yadagiri and this case investigated by ACP Falaknuma Sri. Syed Fiaz under the supervision of Sri. Ghouse Moinuddin, Addl Dy. Commissioner of Police.
