Traffic Advisory

In order to make free flow of traffic through Tilak Nagar Railway Bridge, Nalakunta, Hyderabad. The Executive Engineer Div-16, Circle 16, GHMC, Hyderabad are sanctioned the work for laying VDCC road under the Tilaknagar Railway Bridge, Nallakunga, Hyderabad by constructing underground 33 KV electric line. Therefore, it is to hereby inform that, to avoid inconvenience to the general public some of the following traffic diversions and restrictions are imposed for a period of (30) days from 09-05-2018 to 08-06-2018. The commuters who intend to go towards RUB Tilaknagar, Nallakunta are advised to co-operate with traffic police and use the below mentioned alternative routes designated for them to avoid congestion.

Traffic diversions and Restrictions:

- 1) The RTC buses and heavy vehicles coming from Fever hospital and intend to go towards Tilaknagar Bridge will be diverted towards Shakermutt – Hindi Mahavidyalaya - Vidyanagar ‘Y’ Junction – NCC Junction – Right Turn – Shivam Temple – Tilaknagar Junction.
- 2) The RTC buses and heavy vehicle coming from No.6 Junction and Shivam Road intend to go towards Tilankagar Railway Bridge will be diverted at Tilaknagar Junction towards Shivam Temple, NCC Junction – Left Turn – Vidaynagar ‘Y’ Junction – Hindi Mahavidyalaya – Shankermutt.

**CRICKET BETTING BUSTED – APPREHENDED ONE PERSON
& SEIZED (1) T.V, (5) CELL PHONES AND NET CASH OF
RS.78,000/-.**

On 07-05-2018 the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad, generated actionable information after making sustained efforts and apprehended one cricket betting organizers by name K.Srikanth, while he was accepting cricket betting in the limits of SR Nagar Police Station from the known and unknown punters directly and indirectly i.e., over cell phones. **Seized 1) (1) Sony T.V., 2) (1) Setup Box, 3) (2) Remotes, 4) (5) Line Cell Phones, 5) (1) Pen, 6) (1) book which was used to write cricket betting amounts and 7) Net cash of Rs.78,000/-.**

Details of the Accused:

1. K.Srikanth S/o K.Satyanarayana Chowdary, aged 31 yrs, Occ: Cricket Bookie, R/o H.No.8-3-676/1/2, Engineer colony, Yellareddyguda, Yousufguda, Hyderabad N/o H.No.4-166, Opp. High School, Someshwaram, East Godavari, A.P.

Modus Operandi:-

The accused K.Srikanth hatched a plan to organize Cricket betting and to collect the betting amounts directly and indirectly i.e. through cell phones from the punters in Hyderabad as well as in his native place. He started organizing cricket betting from the year 2012 to earn easy money and also to meet his lavish expenses. For every IPL he used to come to Hyderabad and take shelter in their relatives houses as well as in his friend's houses and used to organize Cricket betting in Hyderabad. He is collecting and distributing the amounts of betting from nearly 25 to 30 punters in twin cities. On 07-05-2018 the said accused is running Cricket betting in an organized manner at **premises No.8-3-676/1/2, Engineer's colony, Yellareddyguda, Yousufguda, Hyderabad** and accepting Cricket betting amount directly and indirectly i.e. over cell phones from them by watching in T.V. on ongoing IPL-2018 Cricket Match in between Sunrisers Hyderabad Vs Royal Challengers Bangalore teams playing at Hyderabad on 07-05-2018.

The apprehended accused along with seized property was handed over to the SHO, SR Nagar PS, Hyderabad for further action.

The accused K.Srikanth previously arrested in Cr.No.257/2016 U/s 4 of AP Gaming Act-1974 (Cricket betting) of Kakinada II Town PS, AP, and also in the year 2013 he was arrested by Mandapeta PS in Cricket betting case.
