NOTIFICATION

WHEREAS, reports have been received indicating that consumption of liquor in public places has become rampant and unhindered in several areas of the City of Hyderabad, resulting in to a menace to the common members of the public, especially women and children in particular.

AND WHEREAS, such reports have been indicating that, persons consuming liquor in public places have been exhibiting abrasive unruly and indecent behavior on the streets of Hyderabad City towards law abiding citizens especially women and children in particular endangering their modesty and safety in addition to causing disturbance to public tranquility resulting in annoyance and obstruction to road users in general and women and children in particular.

WHEREAS, such unruly and indecent behavior has been instilling a sense of fear psychosis in law abiding citizens, especially women and children resulting in restriction of their free movement on the streets of Hyderabad, thereby affecting public safety at large and safety and security of women and children in particular.

AND WHEREAS, it is considered necessary to take speedy measures in this regard to prevent danger to human life and safety and security of women and children or for preventing any affray and disturbance of public tranquility.

Now, therefore, in exercise of the powers conferred upon me under Section 144 of Criminal Procedure Code 1973, I, V.V. Srinivasa Rao, IPS Commissioner of Police, Hyderabad City, do hereby make this written order and notify the same to the General Public **prohibiting Consumption of liquor in public places in the City of Hyderabad.**

This order is published for the information of public through the media and through the public address system in the areas affected with drunkenness in public places.

This order shall come into force from 0600 hours on 11-03-2018 and shall remain in force for a period of one week i.e. upto 0600 hours on 17-03-2018 (both days inclusive) unless withdrawn earlier.

Any person violating this order shall be liable for punishment under Section 188 of the Indian Penal code and as per the provisions of Hyderabad City Police Act, 1348 Fasli.

PRESSNOTE

The sleuths of Bowenpally police nabbed the notorious property offender Robbery/Automobile by name Md. Ahmed Pasha on 08-03-2018 and recovered 07 bikes all W/Rs. 2.5 lakhs and detected total 09 cases of various police stations.

The Bowenpally Police arrested the prime accused A1. Md. Ahmed Pasha, S/o Anwar Hussain, Age: 21yrs, Occ: Labour, R/o H. No. 9-3-26/D, Near NallaPochammaTemple, Harjanbasti, Hasmathpet, Alwal, Cyberabad on 08-03-2018 in Cr. Nos 55/2018 U/S 394 IPC, Cr.No.26/2018 U/S 379 IPC, 77/2018 U/S 379 IPC of Bowenpally PS and recovered 07 bikes all W/r around 2.5 lakhs.

The prime accused Md. Ahmed pasha is the residence of Hasmathpet Alwal, Cyberabad District. He is notorious property offender and previously he committed nearly 22 property offences and he was arrested 03times and went to Jail. The accused previously arrested by Bowenpally Police station and various police stations of Hyderabad and Cyberabad districts and he involved in Crime number 1. Cr.no: 305/13 U/s 457, 380 IPC of Bowenpally PS 2. Cr.no: 311/13 U/s 457, 380, 511 IPC of Bowenpally PS 3. Cr.no: 490/14 U/s 457, 380 IPC of Bowenpally PS 4. Cr.no: 492/14 U/s 457, 380 IPC of Bowenpally PS 5. Cr.no: 493/14, U/S 380 IPC of Bowepally P.S 6. Cr.no: 108/2016 U/s 457, 380 IPC of Bowenpally PS.

Lastly the accused was arrested by Balnagar Police Station, Cyberabad and sent him to Jail and on 15-07-2017 and he was released from chanchalguda jail on 05-12-2017.

After releasing from the jail, the accused kept quiet for some days and again committed the above property offences. Today i.e. on 08-03-2018 while he was available at open ground opposite to NIMH, Manovikas nagar, Old Bowenpally, the police apprehended him as per credible information and recovered 07 stolen bikes from the places where he shown in the presence of mediators and detected 09 cases of various police stations.

The accused person is arrested on 08-03-2018 and he is being produced before the Honorable XI ACMM court at Secunderabad on 09-03-2018 in this case.

The case is under investigation with DSI Sri: M. Srinivas under the supervision of Sri S. Sudheer Kumar Detective Inspector of Police Bowenpally PS and Sri: P. Vijay Kumar, Inspector of Police, Bowenpally P.S, under able guidance of Sri S. Ranga Rao, Asst. Commissioner of Police of Begumpet Division and Smt. B. Sumathi, IPS, Dy. Commissioner of Police, North Zone, Hyderabad City.

NOTIFICATION

With a view to maintain public order, peace and tranquility in the twin cities of Hyderabad and Secunderabad, I, V.V. Srinivasa Rao, IPS, Commissioner of Police, Hyderabad City, in exercise of the powers vested in me under section 22(1) (a) to (f) and 22 (2) (a) and (b) of Hyderabad City Police Act, 1348 Fasli (No.IX), do hereby issue the following prohibitory orders.

- I Prohibit to hold any kind of public meetings, and processions within the Hyderabad City, without obtaining prior permission of Zonal Dy. Commissioners of Police, Law and Order concerned, Addl. Commissioner of Police, Law and Order or Jt. Commissioner of Police, Co-ordination & Security or Commissioner of Police, Hyderabad.
 - a) Prohibit carrying of arms such as swords, spears, knives, sticks with or without flags bludgeons, guns, explosives, and other offensive weapons in the above mentioned areas.
 - b) Prohibit gathering of persons on the public roads or public places disturbing peace and order or causing inconvenience, annoyance or danger to public.
 - c) Prohibit collection, carrying of stones or other means of casting missiles.
- II Prohibit use of mikes/public address system by different Organisations around the Secretariat premises, including Burgula Rama Krishna Rao Building, Greater Hyderabad Municipal Corporation Building, Commissioner of Fisheries building, Mint Compound, Nizam College and its surroundings, Telangana Legislative Assembly premises and surrounding roads, Public Garden Nampally, Upper Tankbund, I-MAX, Rotary and NTR Marg roads also fly-over road leading from Secretariat to Visweswarayya statue, Khairatabad.
 - a) Prohibit music, singing or speeches or broadcasting through loud speakers in the above mentioned areas.
 - b) Prohibit use of mikes/public address systems, use of horn through vehicles by any organisation, members of public etc., in the above mentioned areas.
- III The public are here by informed that any person violating the above orders shall be liable for prosecution under the Hyderabad City Police Act, 1348, Fasli (No. IX).
- IV **The following are exempted from the operation of this order**
 - (i) Police Officers on duty,
 - (ii) Military personnel on duty,
 - (iii) Home Guards on duty,
 - (iv) Bonafide funeral processions.

This order shall be in force with effect from 0600 hours on 12-03-2018 to 0600 hours on 18-03-2018.

NOTIFICATION

In exercise of the powers conferred upon me under section 21(1) (b) of the Hyderabad City Police Act, I, **V.V. Srinivasa Rao**, IPS, Commissioner of Police, Hyderabad, do hereby notify that in view of Million March by TS JAC in Hyderabad City and in order to maintain security, Traffic on the **Upper Tankbund will be closed** from 11 A.M to 5 P.M on 10-03-2018 and to ensure the free flow of traffic in Hyderabad City the following restrictions and diversions are imposed in Hyderabad City from 11 A.M to 5 P.M on 10-03-2018.

Traffic diversions and restrictions.

1. Traffic coming from Secunderbad to Hyderabad will not be allowed beyond Karbala Maidan towards Upper Tankbund will be diverted towards sailing club-Kavadiguda X Road-DBR Mills-Kattamaisamma-Ambedker Statue- Telugu Tally-Ravindra Bharathi.
2. Traffic coming from Necklace Rotary & Telugu Tally will be not be allowed towards Upper Tankbund will be diverted towards Gaganmahal-Indira Park.
3. Traffic coming from Nirankari-Old PS Saifabad-Iqbal Minar will be diverted towards Mint compound or Secretariate Slip road-NTR marg-Necklace Rotary- Necklace Road-Sanjeevaiah park-Nallagutta-Secunderabad.
4. Traffic coming from Liberty will be diverted towards BRK Bhavan-IT-Telugu Tally-Necklace Rotary-V.V. Statue or Necklace Road-Sanjeevaiah Park- Secunderabad.
5. Traffic coming from Basheerbagh or under the Basheerbagh fly over will be diverted towards More Medical Hall-Balaji Grand Bazar- Crystal-I.T-Telugu Tally-Left turn-Iqbal Minar- U turn-Telugu Tally Flyover or Mint compound or Ravindra Bharathi.
6. Traffic coming from Secunderabad will be diverted at Karbala Maidan towards Buddh Bhavan -Sajeevaiah Park-Necklace Road- Necklace Rotary-V.V. Statue or Telugu Tally.

Therefore, Public are requested to start early, take alternate routes to reach their destination and also cooperate with the Traffic Police.
