The Marketing Intelligence Team of Cyber Crimes PS, DD, Hyderabad City have arrested an accused person by name Mohammed Shamshoddin S/o Khamruddin Age:27 years Occ: Telecaller R/o H.No 8-4-155 Mominan Bazar, Near Rathidarwaza, Khammam Dist, Telangana N/o Jannaram, Adilabad Dist, Telangana who impersonated as Human Resource manager of the complainant Company i.e Gemini Edibles and Fats India Pvt. limited marketing in the brand name as Freedom oil and posted advertisement in olx that there were 800 vacancies in the said company and grabbed money from unemployed youth in the name of job in Freedom Oil company in Cr. No. 181/2018, U/sec 66 D ITA Act 2008 & Sec 419, 420 IPC of PS Cyber Crimes. Three mobile phones have been seized.

### **FACTS OF THE CASE:**

Facts of the case are that on 12-06-2018 at 1700 hours received a complaint from Sri P.Ravi, S/o late C.Narayanaswamy, Occ.Business of Manufacturing and trading of Edible Vegetables etc. O/o M/s Germini Edibles & Fats India Pvt.Ltd Road No5, Banjarahills, Hyderabad wherein he stated that , they, M/s. Gemini Edibles & Fats India Private Limited, are into the business of manufacturing and trading of Edible Vegetable Oils and Vanaspati & its products. They market their products under various brand names such as "Freedom", "FirstKlass", etc. in the states of Andhra Pradesh, Telangana, Karnataka, Tamil Nadu, Orissa, etc. They have found that, fraud Job Offers in the name of their brand "Freedom" are being posted in the OLX Website and monies have been collected from the innocent people who have applied for the jobs. Hence, they requested to kindly investigate and punish the culprits as per law.

The accused person used to post the advertisements in OLX impersonating as Human Resource manager of the Gemini Edibles and Fats India Pvt. Limited, Hyderabad marketing in the name of Freedom Oil and in the name of Employment the accused insisted the un employed youth to deposit the money by citing different reasons like Documents Verification, Security deposit etc and looted money from them. There after he used to avoid the calls of victims and switch off his mobile phone.

In this regard the general public are once again requested not to believe any fraudulent Job vacancies offers and deposit money for getting any Job. No employer will ask you to deposit money for getting Job for any reason. M/s. Gemini Edibles & Fats India Private Limited marketing in the name of Freedom Oil Company also never ask the candidates to deposit money for appointment for any position in their company.

The team headed by Inspector of Police Sri. B. Madhusudan consisting of team members S.I's B. Parmeshwar, T. Vinay Kumar, HC's: Hanuman Prasad, K. Thakur, under the direct supervision of Asst. Commissioner of Police, Cyber Crimes Sri. G.Chakravathy has cracked the said case.
