RAID ON SPA - APPREHENDED TWO PERSONS BY WEST ZONE TASK FORCE TEAM

On 09-08-2018, the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad conducted raid at one Spa on the name of "SREE VENUS UNISEX SALON" situated at Plot No.127, Anitha Enclave, 3rd Floor, Road No.10, Jubilee Hills, Hyderabad in which the owner G.Shankar is arranging "Cross massage" illegally to customers and also running brothel house in his salon (Spa). Apprehended (2) persons and seized **net cash of Rs.1,200/-, (6) Un used Condoms, (1) Used Condom and (3) Cell phone** from their possession.

- 1) G.Shankar S/o G.Veeraiah, aged 35 yrs, Occ: Owner of "Sree Venus Unisex Salon", at Plot No.127, Anitha Enclave, 3rd Floor, Road No.10, Jubilee Hills, Hyderabad, R/o West Marredpally, Sec'bad.
- 2) M.Bindu D/o Sudershan, aged 32 yrs, Occ: Beautician, R/o Puppalaguda, Manikonda, Cyberabad.

BRIEF FACTS :

The accused G.Shankar who is owner of "SREE VENUS UNISEX SALON" is engaging young girls & doing Cross Massage at "SREE VENUS UNISEX SALON" situated at Plot No.127, Anitha Enclave, 3rd Floor, Road No.10, Jubilee Hills, Hyderabad. He is attracting known/unknown customers by providing Cross massage in the guise of Spa by engaging the Beautician by name M.Bindu and also running the brothel house in the above said premises and earning huge amount illegally.

On reliable information, West Zone Task Force Team conducted raid on the said Spa and apprehended the above accused persons and seized the above property.

The accused persons along with seized material were handed over to the SHO, Jubilee Hills PS for further investigation.
