Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued P.D. Orders against Mohd. Ayub @ Baada Ayub S/o Late Khan Mohammed, Cattle theft Offender of Chilkaiguda Police Station on 9.10.2018.

Mohd. Ayub @ Baada Ayub S/o Late Khan Mohammed, aged about 57 years, Occ: Auto Driver, R/o. Plot No. 131, Nabeel Colony, Salala, Barkas, Hyderabad N/o Quthbuddinguda (V), Chevella (M), Ranga Reddy District, has been indulging in theft of cattle under the limits of Hyderabad, Cyberabad and Rachakonda Police Commissionerate to make easy money and lead a lavish life.

The accused has committed **15 offences** of theft of Cattles under the limits of Hyderabad, Cyberabad and Rachakonda Police Commissionerates and has been creating large scale fear and panic among the general public by committing such offences, thereby adversely affecting the public order, apart from disturbing the peace, tranquillity and social harmony in the society.

Chilkaiguda Police made strenuous efforts and arrested Mohd. Ayub @ Baada Ayub S/o Late Khan Mohammed, on 18.6.2018 in Cr.No.315/2018 U/s 379 r/w 34 IPC of Chilkaiguda PS and remanded him to judicial custody. The Preventive Detention order was executed on him on 2.11.2018 and was lodged in Central Prison, Chanchalguda, Hyderabad.

**TRAFFIC HOME GUARD OFFICER HIT BY MOTOR CYCLE  
AND INJURED WHILE PERFORMING DUTY**

On 08-11-2018 at about 1600 hours Traffic Home Guard officer Sri M. Narsimha met with road accident while performing his duty at P&T Junction Fly over, Begumpet and sustained fracture to his left leg.

The facts of the case are that on 08-11-2018, Sri M. Narsimha, HG No. 7101 of Traffic PS Begumpet, Hyderabad was performing duty at P&T Junction Fly Over, Begumpet. At about 1600 hrs after arranging barricades in a proper manner and crossing the road towards Manohar Hotel, an unknown two-wheeler came in a high speed and dashed him, resulting in injuries to his body and left leg got fractured. He was shifted to hospital and now he is undergoing treatment at KIMS hospital.

During this year (2018) so far (04) Home Guard officers of Hyderabad Traffic Police had been hit by running vehicles due to which they received injuries while regulating the traffic.
