NOTIFICATION

With a view to maintain public order, peace and tranquility in the twin cities of Hyderabad and Secunderabad, I, M. Mahendar Reddy, IPS Commissioner of Police, Hyderabad City, in exercise of the powers vested in me under section 22(1) (a) to (f) and 22 (2) (a) and (b) of Hyderabad City Police Act, 1348 Fasli (No.IX), do hereby issue the following prohibitory orders.

- I Prohibit to hold any kind of public meetings, and processions within the Hyderabad City, without obtaining prior permission of Zonal Dy. Commissioners of Police, Law and Order concerned, Addl. Commissioner of Police, Law and Order or Jt. Commissioner of Police, Co-ordination & Security or Commissioner of Police, Hyderabad.
 - a) Prohibit carrying of arms such as swords, spears, knives, sticks with or without flags bludgeons, guns, explosives, and other offensive weapons in the above mentioned areas.
 - b) Prohibit gathering of persons on the public roads or public places disturbing peace and order or causing inconvenience, annoyance or danger to public.
 - c) Prohibit collection, carrying of stones or other means of casting missiles.
- II Prohibit use of mikes/public address system by different Organisations around the Secretariat premises, including Burgula Rama Krishna Rao Building, Greater Hyderabad Municipal Corporation Building, Commissioner of Fisheries building, Mint Compound, Nizam College and its surroundings, Telangana / A.P. Legislative Assembly premises and surrounding roads, Public Garden Nampally, Upper Tankbund, I-MAX, Rotary and NTR Marg roads also fly-over road leading from Secretariat to Visweswarayya statue, Khairatabad.
 - a) Prohibit music, singing or speeches or broadcasting through loud speakers in the above mentioned areas.
 - b) Prohibit use of mikes/public address systems, use of horn through vehicles by any organisation, members of public etc., in the above mentioned areas.
- III The public are here by informed that any person violating the above orders shall be liable for prosecution under the Hyderabad City Police Act, 1348, Fasli (No. IX).
- IV **The following are exempted from the operation of this order**
 - (i) Police Officers on duty,
 - (ii) Military personnel on duty,
 - (iii) Home Guards on duty,
 - (iv) Bonafide funeral processions.

This order shall be in force with effect from 0600 hours on 11-03-2017 to 0600 hours on 17-03-2017.

NOTIFICATION

In exercise of the powers vested in me Under Clause (d) of Sub-Section (1) of Section 22 of the "Hyderabad City Police Act", I, M. Mahendar Reddy, IPS Commissioner of Police, Hyderabad City do hereby prohibit.

1. Throwing colour or coloured water on persons, places and Vehicles or smearing people with colour, on public roads and public places in Hyderabad City, causing annoyance
2. Prohibit movement of two wheelers and other vehicles in groups on streets and public places disturbing peace and order and or causing inconveniences, annoyance or danger to public

This order shall be in force from 0600 hours on 11-03-2017 to 0600 hours on 13-03-2017 in connection with celebration of "**Holi Festival**".

The Public are hereby informed that any person violating the above order shall be liable for prosecution for violation under Sec. 76 of "The Hyderabad City Police, Act 1348 Fasli."

The Cyber Crime Police, CCS, DD, Hyderabad City arrested one more government official namely accused Gangula Purushottam Reddy S/o Indra Sena Reddy who is involved in scam of misuse of Government scholarships and diverted the funds to the tune of 71 lakhs into private organisation accounts through online.

Details of the accused:

1.Gangula Purushottam Reddy S/o Indrasena Reddy, Age: 42 years, Occ:- Sub-Treasury Officer, Dist. Treasury Office, Collectorate, Nalgonda, Employee I'd No. : 1905587, R/o. H.No 6-7-39, Shivaji Nagar, Near Shivaji Nagar Park, Nalgonda Dist. N/o. Wanaparthy (Village), Lingala Ghanpur (Mandal), Dist: Janagam, Ph: 7995572293, 9866019393

Facts of the case:

Facts of the case are that, received a complaint from Treasuries and Accounts Department, Telangana State,4th Floor, Insurance Building, Tilak Road, Abids, Hyderabad there is a doubtful claim which has been Uploaded for an amount of Rs.71,13,000/- in favour of Sai Vikas Degree Colege, Kodad Bank A/c No.032911100000098 of Andhra Bank, Kodad Branch. The culprits who has uploaded the file into treasury department server with a motive to wrongful gain and causing wrongful lost to government and requested to take necessary action. A case was registered in Crime Number in Cr No: 46/17, U/s 66 r/w 43, 66(C) I.T.A. Act-2008 & Sec.420 IPC

Modus Operandi

The Modus Operandi of this case that, the accused person is working in District Treasury Office, Nalgonda as a STO (Sub Treasury Officer). He colluded with some other suspected persons (previous arrested persons) and misusing the government funds for their personal gain. According to their plan, he has validated/authorized the illegal e-cheque transfer, through which accused persons is tried to benefit the private collage to the tune of 71 lakshs. To this illegal authorization of e-cheque, he has demanded the money from the college management. Further investigation into the matter is on.

The Cyber Crime Police, CCS, DD, Hyderabad City arrested one accused namely Uppuluri Mani Ratnam S/o U.Sathyanarayana, Age: 23 years, Occ:- Agricultural, R/o:- H.No 3-141, Main Road, beside Panchayat Office, Nandamuru village, Kovvur Mandal, West Godavari District who chatting with girls/ladies through WhatsApp and facebook in very objectionable/abusive way by collecting the girls/ladies mobile numbers by making use of internet and hacking the facebook account.

Details of the accused:

1. **Uppuluri Mani Ratnam S/o U.Sathyanarayana, Age: 23 years, Occ:- Agricultural, R/o:- H.No 3-141, Main Road, beside Panchayat Office, Nandamuru village, Kovvur Mandal, West Godavari District**

Facts of the case:

Facts are that the received a complaint from M.Shoban Babu, Sub-Inspector of Police, She Team Hyderabad City and stated that a received a complaint in his office through Hawk eye about complainant getting wrong WhatsApp messages from three months from mobile No.8466888721. So he called that number but he/she didn't received his call after some time he received some threatening messages in his WhatsApp. To-day morning his facebook account was using by unknown person like accepting all his friend requests and sending request to girls and chatting with them by asking for personal details, phone numbers and photos etc., Hence he requested to take necessary action. A case was registered in Cr No: 48/17 U/s 66(C) & (D) I.T.A. Act-2008 and Sec. 506 IPC.

Modus Operandi

The Modus Operandi of this case that, the accused person collects the girls/ladies mobile numbers by making use of internet. After collection of the mobile numbers, he created a group as "**Romantic thoughts sharing**" in WhatsApp with his number 8466888721 for chatting with girls/ladies in very objectionable/abusive way. In the above group he posted abusive/unparliamentary messages, nude pictures and romantic. On 22-02-2017 he received call and WhatsApp message from phone No.8374754789 and found that that number belongs to Shoban Mog and he is working in Police Department by making use of internet. Subsequently, he sends abusive and threatening messages to the complainant. He also hacked the complainant facebook and send friend requests to unknown girls/ladies and chatting with them as a complainant and also taken their personal details, phone numbers and photos etc. by asking them.

ARRESTED THREE HOUSE BURGLARS - DETECTED 08- CASES OF SHUTTER LIFTING.

On 10-03-2017, the Commissioner's Task Force, South Zone team along with Charminar Police, on credible information, apprehended three members gang of HB night (Sutter lifting) namely 1) Shaik Nissar, 2) Syed Azam and 3) Faran Ahmed and **detected (08)** cases of shutter lifting in the limits of Charminar, Afzalgunj, Begumbazar, Shahinayathgunj, Langerhouse and Ramgopalpet Police Stations of Hyderabad City and recovered **cash of Rs 1,00,000/- 2) One Passenger auto bearing no TS-11-UA-7092 and 3) Two Samsung Cell phones** at the instance of accused persons.

Name of the Accused Person apprehended :-

1. Shaik Nissar S/o. Shaik Qayyum, aged: 30 yrs, occ: auto driver R/o. HNo. 19-4-7/A/69, Aljubail Colony, Chandrayangutta, Hyderabad.
2. Syed Azam S/o. Syed Akbar, aged: 22 yrs, occ: wall painter R/oHNo. 18-13-9/69, Errakunta, Hyderabad
3. Faran Ahmed S/o. Abdul Gaffar, aged: 23 yrs, occ: auto driver R/o. Vattepally, Fathimanagar, near Mosque, Hyderabad.

Brief Facts :-

Recently on the intervening night of 08/09-3-2017, some unknown culprits forcibly open the shutters of one cloth shop bearing H.No.21-2-740, situated Kesra Complex, Near Agarwal School, Ricob Gunj, Charminar wheirin some unknown offenders entered into the shop and committed theft of cash Rs 1500/- from the cash counter by broke open the lock. On the above complaint of Kamalesh Agarwal, owner of the said shop, registered a case in CrNo. 27/2017 U/s. 457,380 IPC at Charminar PS. And investigated into.

Prior to this in the duration of 3 months similar shutter lifting cases with same MO were reported in the limits of Hyderabad City.

South Zone Task Force Team made efforts, verified CCTV footages, earth out clues and on 10-03-2017, on credible information apprehended the above mentioned three offenders and recovered the above mentioned cash, two Samsung cell phones and one passenger auto which was used in commission of offence at the instance of accused persons. During the course of interrogation, the accused persons confessed 3 shutter lifting cases of Charminar, one case each in Afzalgunj, Begumbazar, Shahinayathgunj, Langerhouse and Ramgopalpet Police Stations.(total 8 cases). The accused persons have committed these shutter lifting offences along with another two offenders namely Shaik Ansar and Dhananjay @ Chinna who are absconding. The accused Shaik Nissar and the absconding accused persons are having past criminal record in various Police Stations of Hyderabad viz. Lalaguda, Langerhouse, Charminar, Mahankali, Chandrayangutta and Afzalgunj.

Modus Operandi:-

The accused persons used to conduct recce in the day time and identifies the shops which are not having centre lock system. In the mid night they moves in the auto and after reaching the selected target one person in the guise of Auto driver sits in the auto and watches the surrounding area and remaining offenders lifts the shutters forcibly with hands and after partial opening of the shutter one among them enters into the shops and commit cash thefts from the cash counters.

The arrested accused persons are being produced before the Honble Court for their Judicial custody.

The arrests were made under the Supervision of **Sri. N. Koti Reddy, Addl. D.C.P., Commissioner's Task Force**, Hyderabad city by **Sri. A. Yadagiri, Inspector of Police, Task Force, South Zone**, with the assistance of **SI's**. Sri. G. Mallesh, SK Jakeer Hussain, Sri. N.Srishylam and Sri. G. Venkata Rami Reddy and staff.
