NOTIFICATION

With a view to maintain public order, peace and tranquility in the twin cities of Hyderabad and Secunderabad, I, D.S. Chauhan, IPS Addl. Commissioner of Police, (Law & Order) I/c Commissioner of Police, Hyderabad City, in exercise of the powers vested in me under section 22(1) (a) to (f) and 22 (2) (a) and (b) of Hyderabad City Police Act, 1348 Fasli (No.IX), do hereby issue the following prohibitory orders.

- I Prohibit to hold any kind of public meetings, and processions within the Hyderabad City, without obtaining prior permission of Zonal Dy. Commissioners of Police, Law and Order concerned, Addl. Commissioner of Police, Law and Order or Jt. Commissioner of Police, Co-ordination & Security or Commissioner of Police, Hyderabad.
- a) Prohibit carrying of arms such as swords, spears, knives, sticks with or without flags bludgeons, guns, explosives, and other offensive weapons in the above mentioned areas.
- b) Prohibit gathering of persons on the public roads or public places disturbing peace and order or causing inconvenience, annoyance or danger to public.
- c) Prohibit collection, carrying of stones or other means of casting missiles.
- II Prohibit use of mikes/public address system by different Organisations around the Secretariat premises, including Burgula Rama Krishna Rao Building, Greater Hyderabad Municipal Corporation Building, Commissioner of Fisheries building, Mint Compound, Nizam College and its surroundings, Telangana Legislative Assembly premises and surrounding roads, Public Garden Nampally, Upper Tankbund, I-MAX, Rotary and NTR Marg roads also fly-over road leading from Secretariat to Visweswarayya statue, Khairatabad.
- a) Prohibit music, singing or speeches or broadcasting through loud speakers in the above mentioned areas.
- b) Prohibit use of mikes/public address systems, use of horn through vehicles by any organisation, members of public etc., in the above mentioned areas.
- III The public are here by informed that any person violating the above orders shall be liable for prosecution under the Hyderabad City Police Act, 1348, Fasli (No. IX).
- IV **The following are exempted from the operation of this order**
- (i) Police Officers on duty,
(ii) Military personnel on duty,
(iii) Home Guards on duty,
(iv) Bonafide funeral processions.

This order shall be in force with effect from 0600 hours on 11-04-2018 to 0600 hours on 17-04-2018.

NABBED THREE PERSONS WHO ARE SELLING INDIAN LIQUOR AS FOREIGN BRANDED LIQUOR - SEIZED 22 FOREIGN BRANDED LIQUOR BOTTLES.

On 10-04-2018, the sleuths of Commissioner's Task Force, South Zone Team, Hyderabad and Charminar Excise Police jointly apprehended three persons who are selling Indian liquor as foreign branded liquor and **seized 22 foreign branded liquor bottles** with Indian liquor at the instance of accused persons.

Details of accused persons:-

- 1) Vijay Kumar Bhatiya S/o Babul al Bhatiya, age 52 yrs, Occ: jewellery work, R/o Near Lal Darwaja Temple, Chatrinaka, Hyderabad.
- 2) Harish Keswani S/o late. Eswar Lal, age 60 yrs, Occ: pvt. Employee, R/o Kingkoti, Hyderabad.
- 3) Mukesh Agarwal S/o Om Prakash Agarwal, age 54 yrs, Occ: Business, R/o West Maredpally, Secunderabad.

Brief History of accused persons:-

The above three accused persons are different localities of Hyderabad and Secunderabad. All the three know each other for the past few years. As they are facing financial problems, they conspired together to make easy money in less time. In pursuance of their plan, they procured empty foreign liquor bottles of various brands from five star hotels, bars and pubs and filled them with Indian made liquor. They took every precaution in sealing the bottle, as the foreign branded bottles have peculiar seal when compared to Indian liquor bottles. They are selling the same to needy innocent customers at fashionable prices under the guise of foreign branded liquor.

Some of the customers are knowingly purchasing these bottles from the above and gifting them to their near and dear ones, friends, officials and others to show off themselves in the high profile society.

The apprehended accused persons along with seized bottles are handed over to the SHO Charminar PS (Excise) for taking further action against him.

2) APPREHENDED THREE SATTA AGENTS - RECOVERED Rs.31,160/- SATTA CHART, SATTA BOOK AND (04) CELL PHONES.

On 10-04-2018, the sleuths of Commissioner's Task Force, South Zone Team, Hyderabad apprehended three satta agents and recovered **Rs.31,160/-, Satta Chart, Satta book and (04) Cell Phones** at the instance of accused person.

4) Abdul Feroz Khan S/o Late. Abdul Muneer Khan, aged: 45 yrs, occ: auto driver R/o. Kishanbagh, Hyderabad **(Absconding)**

Brief History of accused:-

The above three accused persons are accepting satta betting through their cell phones from the punters which is a game of chance. They are luring the innocent public with high profits/returns and collecting betting amounts from them. The above persons are collecting the betting amount on behalf of one Abdul Feroz khan R/o Kishan Bagh, Hyderabad, who pays them commission on daily basis. The accused persons have also created a **Whats App** group among themselves and taking every precaution to evade apprehension by police. Seized cash of Rs 31,160/-, (04) cell phones and satta chart, book at their instance. The said Abdul Feroz khan found absconding.

The above arrests are made under the supervision of **Sri. K. Madhu Mohan Reddy**, Inspector of Police, South Zone, and **SIs S/Sri K.N. Prasad Varma, G. Venkata Ramireddy, N. Srishylam & Staff** of South Zone Task Force, Hyderabad City.

The Cyber Crimes PS, DD, Hyderabad City have arrested two accused by names Thotakuri Naga Karthik @ Vasu Deva & Thota Sathish Goud @ Pavan who have been running a brothel house by procuring sex workers & publishing online female escorts/call girls advertisements with obscene/porn pictures in Cosmohotties.com, locanto etc websites and rescued a female sex worker by name Yasmeen Kamal Khan in Cr. NO. 93/2018, U/s 370-A IPC, Sec 67(A) ITA Act & Sec 3,4 of PITA Act and seized 4 mobile phones, 4 condoms.

FACTS OF THE CASE:

Facts of the case are that on 09-04-2018 at 1800 hrs, When Sri B. Chand Basha, Inspector of Police, Cyber Crime PS, Hyd along with his staff were browsing online to track the suspected advertisements, he happened to see advertisement regarding call girls (call girls and escort services in Hyd) i.e., https://hyderabad.cosmohotties.com/e/call-girls-9705419119-in-hyderabad-escorts-services-independent-hyderabad-escorts_i2550552 with obscene photographs of women offering for call girls and escort services with mobile No. 9705419119. When contacted the caller for call girl, he quoted Rs. 3,000/- for one turn asking to come to Venkatagiri, near ICICI Bank ATM. Then, he along with staff went to Venkatagiri, Jubilee Hills and conducted Decoy operation and apprehended one brothel house organizer & office boy along with a female sex worker at H. No. 8-3-229/D/51, 3rd Floor, Al-Omer Residnecy, Venkatagir, Near ICICI ATM, Jubilee Hills, Hyderabad. He also seized incriminating material.

MO. OF THE OFFENCEDER

The accused Sathis Goud publishes call girls/female escort advertisements in online websites like Cosmohotties.com, locanto etc with obscene/porn photos of women by providing his mobile number 9705419119. The accused procures poor women from different sources and trap them into prostitution by offering commission. Whenever, any person contacts him by noticing his advertisement in online, the accused with the help of other accused Karthik send the customer to the sex worker and organizing the brothel house at R/o H. No. 8-3-229/D/51, 3rd Floor, Al-Omer Residnecy, Venkatagir, Near ICICI ATM, Jubilee Hills, Hyderabad by charging Rs. 3,000/- at once.

The team headed by Inspector of Police Sri. Chand Basha consisting of team members Ramesh, Inspector of Police, S.I. K. Madhusudan, ASI Dileep & PC Prashanth of PS Cyber Crime under the direct supervision of Addl. DCP Cyber Crimes Sri. K. C. S. Raghu Vir has cracked the said case.

The Cyber Crime Police, CCS, DD, Hyderabad City apprehended two African nationals namely accused **A-1**: Prince Kanyinda(from Congo). **A-2**: Marwan Abdul Kareem(from Sudan), who are involved in online crimes i.e hacking Emails and sending phishing mails to the various mail IDs on the contacts list of emails and asking to deposit money as pretending to be original one requesting them for money as if original person in some medical/ other emergency towards hospital expenses and providing bank accounts to earn Easy money.

Details of the accused:

A-1: Prince Kanyinda S/o James Kanyind, Aged 35 Years, Occ: Student of Technical Networking and Coding courses, R/o. Madhavapuri Colony, Neredmet, Secunderabad, N/o. Congo, [Democratic Republic of the Congo](#), Africa.

A-2: Marwan Abdul Kareem S/o Abdul Kareem Abdullah, Aged 25 Years, Occ: Student of Technical Networking and Coding courses, R/o. Defence Colony, Neredmet, Secunderabad, N/o. Sudan.

Facts of the case:

The brief facts of the case are that; on 07-04-2018 received a complaint from Sri. Chandra Sekhar in which he stated that his mail ID has been hacked by hackers and it being misused. The mail was and many of his clients have received mails from the hacker asking to deposit money in provided bank accounts details. The complainant got alert and got mail into his control. In the mean time one of his client has deposited Rs. 50,000/- through SBI to the hackers Bank account. Further, the hacker has created one dummy email in [hotmail domain](#). Hence he requested to block this mail account immediately and do the needful.

Basing on the above contents of the complaint B.Chand Basha, Inspector of Police, PS Cyber Crime registered a case in Cr. No. 90/2018, U/Sec 66 (C) & (D) ITA Act 2008 and Sec. 420 IPC and took up investigation.

Modus Operandi: -

A-1 Prince Kanyinda, A-2 Marwan Abdul Kareem came to Hyderabad, India for further studies. To earn easy money, they learnt hacking skills from various institutes. In this process, they formed a gang with one Mr. David Davido Eiji, N/o Nigerain. During course of time, accused cracked into few yahoo mail accounts and after gaining access into multiple yahoo accounts accused have sent phishing mails to the various mail IDs on the contacts list of emails, as pretending to be original one requesting them for money as if original person in some emergency. For diverting this money, accused have opened multiple bank accounts with different banks. Likewise A1 got the ILLEGAL access of one email pertaining to Yahoo domain and sent a request to all his contact list for requesting money towards hospital expenses and provided his cousin bank account.

As such A1 has sent bulk e-mails from yahoo domain to all his contact list e-mails, one person by name ABC has responded to this fake e-mail, and he has deposited 50,000/- (Fifty thousand rupees only) money into bank account. During course of Investigation, IO has arrested both African Nationals and seized multiple bank account passbooks, ATM Cards & Mobile phones etc.

The above operation was carried out by Sri. B Chand Basha, Inspector of Police, SI Sri. Madan, PCs Sri. Chandra Mohan, & H. Shekher and team under the direct supervision of ADDL.DCP Sri. KCS Raghu Vir.

Attempt to Murder case
in Cr. No. 195/18 U/s 307, 120 (B) r/w 34 IPC of Jubilee Hills

The Jubilee Hills Police have arrested five persons who are involved in an attempt to Murder of a retired IAS Sri. Ponnekanti Dayachari vide Cr.No. 195/2018 U/s. 307, 120 (B) r/w 34 IPC

The accused lady Manjula is daughter of complainant's brother. She along with complainant purchased some properties in their native place i.e. Guntur and Patancheru. Thereafter some financial disputes arosed between them. The accused lady Manjula and her brother Karunakar tried to sort out the dispute and there has been many meetings held in presence of family members but the dispute has not been resolved, and they are warned to complainant to see his end.

The accused Manjula & Karunakar hatched a plan to eliminate the complainant and disclosed the same to their business partner Venkateswar Rao, about 45 days back Venkateswar Rao introduced Naresh N/o. Vijayawada to Manjula and Karunakar and they disclosed about their plan to eliminate complainant and gave Rs. 15000/- as advance and promised to give more money after the work is done. About one month back, Venkateswar Rao and Karnukar came to Hyderabad with Naresh has shown the house and also sent the image of complainant to Naresh for identification.

On 03-04-2018 Naresh along with his associates Ashok, Sagar, Ayyappa and Rajesh came to Hyderabad and stayed in Hotel Minerva at Kondapur. Later Naresh showed the house of complainant to his associates. In order to attack the complainant, they purchased a cricket wicket on 04-04-2018 at a sports shop at Kondapur.

On the date of incident i.e, on 05-04-2018 at about 0700 hrs, Sagar, Ashok, Ayyappa and Rajesh came to Prashasannagar, Jubilee Hills on two bikes. They made rekey in the area by roaming and observed the complainant having his morning walk. The accused Sagar drove the bike slowly from behind the complainant and Ashok who was on the pillion bet on complainant's head with the wicket and all of them fled away from there.

These arrests were made under supervision of Sri K.S. Rao, ACP Banjara Hills Division, Hyderabad, Sri. P. Chandra Shekar, Inspector of Police, Sri. K. Srinivas, Detective Inspector of Police, SI Sri. P. Naresh and other staff of P.S. Jubilee Hills.

NOTIFICATION

WHEREAS, reports have been received indicating that consumption of liquor in public places has become rampant and unhindered in several areas of the City of Hyderabad, resulting in to a menace to the common members of the public, especially women and children in particular.

AND WHEREAS, such reports have been indicating that, persons consuming liquor in public places have been exhibiting abrasive unruly and indecent behavior on the streets of Hyderabad City towards law abiding citizens especially women and children in particular endangering their modesty and safety in addition to causing disturbance to public tranquility resulting in annoyance and obstruction to road users in general and women and children in particular.

WHEREAS, such unruly and indecent behavior has been instilling a sense of fear psychosis in law abiding citizens, especially women and children resulting in restriction of their free movement on the streets of Hyderabad, thereby affecting public safety at large and safety and security of women and children in particular.

AND WHEREAS, it is considered necessary to take speedy measures in this regard to prevent danger to human life and safety and security of women and children or for preventing any affray and disturbance of public tranquility.

Now, therefore, in exercise of the powers conferred upon me under Section 144 of Criminal Procedure Code 1973, I, D.S. Chauhan, IPS Addl. Commissioner of Police, (Law & Order) I/c Commissioner of Police, Hyderabad City, do hereby make this written order and notify the same to the General Public **prohibiting Consumption of liquor in public places in the City of Hyderabad.**

This order is published for the information of public through the media and through the public address system in the areas affected with drunkenness in public places.

This order shall come into force from 0600 hours on 10-04-2018 and shall remain in force for a period of one week i.e. upto 0600 hours on 16-04-2018 (both days inclusive) unless withdrawn earlier.

Any person violating this order shall be liable for punishment under Section 188 of the Indian Penal code and as per the provisions of Hyderabad City Police Act, 1348 Fasli.
