

**CRICKET BETTING BUSTED – APPREHENDED TWO PERSONS  
& SEIZED (1) T.V, (3) CELL PHONES AND NET CASH OF  
RS.80,000/-.**

On 09-05-2018 the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad, generated actionable information after making sustained efforts and apprehended two cricket betting organizers by name Manoj Kumar @ Thothla Manoj and Vishal Kumar, while they were accepting cricket betting in the limits of Narayanaguda Police Station from the known and unknown punters directly and indirectly i.e., over cell phones. **Seized 1) 1-Samsung T.V, 2) 1-Setup Box, 3) 2-Remotes, 4) 1-MI cell phone which is having "Cricket exchange" app, 5) 2-Cell phones, 6) 1-Calculator, 7) 1-Pen, 8) 1-book which was used to write cricket betting amounts and 9) Net cash of Rs.80,000/-.**

**Details of the Accused:**

1. Manoj Kumar @ Thothla Manoj S/o Radheshyam, aged 35 yrs, Occ: Sarees business at Badi chowdi, R/o H.No.3-4-610/2, Flat No.301, Dewdrops Apartments, Street No.12, Narayanaguda, Hyderabad.
2. Vishal Kumar S/o Suresh Kumar, aged 29 yrs, Occ: Cricket betting punter, R/o H.No.4-9-101, Bahadurpura, Hyderabad.

**Modus Operandi:-**

The accused persons Manoj Kumar @ Thothla Manoj and Vishal Kumar hatched a plan to organize Cricket betting and to collect the betting amounts directly and indirectly i.e. through cell phones from the punters in Hyderabad. Since two years they were organizing Cricket betting. They were collecting and distributing the amounts of betting from nearly 30 to 35 punters in twin cities. On 09-05-2018 the said accused persons are running Cricket betting in an organized manner at **premises No.3-4-610/2, Flat No.301, Dewdrops Apartments, Street No.12, Narayanaguda, Hyderabad** and accepting Cricket betting amount directly and indirectly i.e. over cell phones from them by watching in T.V. on ongoing IPL-2018 Cricket Match in between Kolkata Knight Riders Vs Mumbai Indians teams playing at Kolkata on 09-05-2018.

The apprehended accused persons along with seized property were handed over to the SHO, Narayanaguda PS, Hyderabad for further action.

The accused Manoj Kumar @ Thothla Manoj previously arrested in Cr.No.465/2015 U/s 3 & 4 of AP Gaming Act-1974 (Cricket Betting) of Shahinayathgunj PS and Cr.No.102/2017 U/s 3 & 4 of AP Gaming Act-1974 (Cricket Betting) of Shahinayathgunj PS, Hyderabad.

**PD ACT INVOKED AGAINST SHAIK OBAID, S/O SHAIK AZAM, BURGLAR OF SAIDABAD POLICE STATION, EAST ZONE, HYDERABAD**

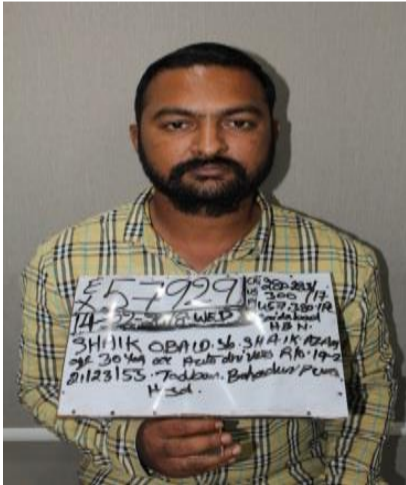

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City invoked P.D.Act against Shaik Obaid, S/o Shaik Azam, **Burglar** of Saidabad Police Station on 3-5-2018.

On 4-5-2018, Saidabad police executed the preventive detention order on Shaik Obaid, S/o Shaik Azam r/o Tadban, Bahadurpura, Hyderabad at Central Prison, Chanchalguda, Hyderabad.

Shaik Obaid is a notorious rowdy sheeter of Kalapathar Police Station and was earlier involved in 17 offences including attempt to commit murders, riotings, robberies and criminal intimidation. He was bound over by the Special Executive Magistrate u/s 107 Cr.P.C. to keep good behaviour in 2010 and 2011 but he violated the bond and continued his prejudicial activities. While in prison, he developed friendship with a notorious burglar Manthri Shankar and he along with Manthri Shankar committed 11 burglaries in the limits of different Police Stations of Hyderabad and Rachakonda Police Commissionerates, thereby adversely affecting the maintenance of public order.

Saidabad Police along with sleuths of Commissioner's Task Force, South Zone, Hyderabad made sincere efforts and arrested him on 13-2-2018. In pursuance of his confession police recovered the stolen gold ornaments weighing about 370 grams, cash Rs. 3,20,000/- and Bajaj Avenger vehicle all W/Rs. 15 Lakhs.

**PD ACT INVOKED AGAINST SHAIK OBAID, S/O SHAIK AZAM, BURGLAR OF SAIDABAD POLICE STATION, EAST ZONE, HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City invoked P.D.Act against Shaik Obaid, S/o Shaik Azam, **Burglar** of Saidabad Police Station on 3-5-2018.

On 4.5.2018, Saidabad police executed the preventive detention order on Shaik Obaid, S/o Shaik Azam r/o Tadban, Bahadurpura, Hyderabad who was under judicial custody in Central Prison, Chanchalguda, Hyderabad in Cr.No. 283/2017 of Saidabad PS.

Shaik Obaid is a habitual offender and committed as many as 36 offences like attempt to murder, snatching, robbery, dacoity and bodily offences in the last 10 years in the limits of Hyderabad and Rachakonda Commissionerates. In the recent past he has committed 11 burglaries in the limits of Hyderabad and Rachakonda police Commissionerates.

He created panic in the minds of the inhabitants of different localities in the two Police Commissionerates due to his nefarious activities. Due to his prejudicial activities, the inhabitants of the localities scared to leave their houses even after locking the doors fearing burglaries.

Saidabad police made sincere efforts and on 13-2-2018 arrested the accused in Cr.No.283/2017 of Saidabad PS and remanded to judicial custody through separate remand reports in 10 cases of Saidabad PS. The accused Shaik Obaid moved bail petitions in the 10 cases and the Hon'ble Magistrates concerned have granted bails to him, but he continues to be in judicial custody as he has not furnished surieties. However, he did not move any bail petition in Cr.No.19/2018 of Meerpet PS. Now, PD Act has been invoked on him.

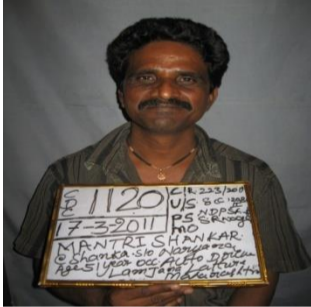
