

## **TWO PERSONS HELD – SEIZED (1500) OXYTOCIN INJECTION BOTTLES AND OTHER INCREMINATING MATERIAL**

On 10-07-2018 the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad City conducted raids on "Banwarilal Suresh Kumar Bansal, Chunni Bhoosa Shop, #11-1-987/D, Near Jet Café, Mallepally, Hyderabad and at premises No.18-13-132/I/124, Ismail Nagar, Bandlaguda, Hyderabad (**Manufacturing unit**), apprehended (2) persons by name 1) Shaik Abdul Khaled and 2) B.Suresh Kumar Gupta, who were found in the possession of Oxytocin (which were banned by the Government for veterinary use) steroid liquid and selling the same to the needy persons and earning easy money. Seized **Oxytocin liquid bottles – 1500 (200 ML, 180 ML, 140 ML), (3) Oxytocin Injections (Human use only), (2) bottles of Phenol I.P. (Carbolic Acid Crystal I.P.), (3) Sealing machines, and 180 ML Empty bottles with caps** from their possession.

### **Accused:-**

- 1) Shaik Abdul Khaled S/o Late Shaik Abdul Khaleq, aged 33 yrs, Occ: Real Estate Business at premises No.18-13-132/I/124, Ismail Nagar, Bandlaguda, Hyderabad, R/o H.No.17-1-120, Edi Bazar, Hyderabad.
- 2) B.Suresh Kumar Gupta S/o Late B.Banwarilal, aged 65 yrs, Occ: Cattle feed shop Business (Banwarilal Suresh Kumar Bansal, Chunni Bhoosa Shop, #11-1-987/D, Near Jet Café, Mallepally, Hyderabad, R/o H.No.5-5-915, Near bus stop, Goshamahal, Hyderabad.

### **Modus Operandi:-**

In the year 2001 the accused Shaik Abdul Khaled started surgical items supplying business in Hyderabad. He used to purchase surgical items from the market at Koti, Hyderabad and supplying the same to the hospitals, medical shops etc., on commission basis. At that he is also supplying Oxytocin amples to the needy customers. In the year 2003 the Government banned the Oxytocin amples/liquid manufacturing and selling for veterinary use.

In the year 2009 he started business on the name of "SK Medical Agency" at Edi Bazar, Hyderabad and supplying generic medicines and also surgical items. In the year 2015 he came into contact with one person by name Mosir R/o UP, and he informed him that he is supplying Oxytocin injection bottles in Hyderabad illegally and asked to purchase from him. On which the accused Shaik Abdul Khaled

agreed and started purchasing from Mosir for Rs.25/- per 1 bottle and selling the same for Rs.50/- per bottle to the needy persons and also the accused B.Suresh Kumar Gupta as he was running Cattle feed shop Business and earning money illegally. He also learned the process of making Oxytocin steroid from Mosir. In this process on 01-03-2016 the accused Shaik Abdul Khaled was apprehended by Drug Inspector, Charminar Zone, on 05-03-2016 he was arrested by Madannapet Police in Cr.No.35/2016 U/s 273, 420 IPC and 18(c) of Drug & Cosmetic Act-1940 and also he along with accused B.Suresh Kumar Gupta were arrested by Begumbazar Police in Cr.No.209/2016 U/s 420, 336 IPC and remanded them to judicial custody. After one week they released from Jail.

In the month of October-2017 the accused Shaik Abdul Khaled again started business on the name of "Arruba Travels" at Champapet main Road, Hyderabad. But his earnings are not sufficient to meet his family expenses. As such he again hatched a plan to sell the Oxytocin liquid/steroid to the dairy farms to earn easy money. To make Oxytocin steroid, the accused Shaik Abdul Khaled used to mix water with Oxytocin Injection (Human use only), Phenol I.P. (Carbolic Acid Crystal I.P.) and crystal salt. He used to purchase Oxytocin Injection (Human use only) from different medical shops in Hyderabad and used to purchase Phenol I.P. liquid (Carbolic Acid Crystal I.P.) from Medical agencies in Boggulakunta area.

He used to mix 300 ML Oxytocin Injections (Human use only), 1200 ML Phenol I.P. (Carbolic Acid Crystal I.P.) and 1 KG crystal salt in 160 Liters water at the premises No.18-13-132/I/124, Ismail Nagar, Bandlaguda, Hyderabad. Later the mixture becomes Oxytocin steroid. After manufacturing Oxytocin steroid the accused Shaik Abdul Khaled seals the injection/steroid liquid into 140 ML, 180 ML and 200 ML bottles by using the sealing machine. After packing the bottles he is supplying to the needy persons and dairy farms for Rs.80/- per one bottle and earning money illegally. The accused B.Suresh Kumar Gupta is purchasing Oxytocin injection/steroid from the accused Shaik Abdul Khaled for Rs.80/- per bottle and selling the same for Rs.120/- in his shop at Mallepally, Hyderabad.

Today i.e. on 10-07-2018, on the tip off, the West Zone Task Force team along with Drug Inspectors Mehdiapatnan Zone and Charminar Zones raided on "Banwarilal Suresh Kumar Bansal, Chunni Bhoosa Shop, #11-1-987/D, Near Jet Café, Mallepally, Hyderabad and apprehended the accused B.Suresh Kumar Gupta along with Oxytocin injection/steroid bottles and on the information given by the accused B.Suresh Kumar Gupta apprehended the accused Shaik Abdul Khaled at premises No.18-13-132/I/124, Ismail Nagar, Bandlaguda, Hyderabad (manufacturing unit) and seized the above materials.

The accused persons along with seized materials were handed over to Drug Inspectors, Mehdiapatnam Zone and Charminar Zone for further investigation.

**EFFECTS OF OXYTOCIN:-**

- Oxytocin helps cattle to produce more milk, has severely harmful effects on not just the health of the animals, but human who consume milk that comes from them.
- It also reduces the life span of cattle.
- Drugs & Cosmetics Act-1940 banned for veterinary use sale of the drug without a prescription from a registered medical practitioner.
- If the practice of administering injections twice a day continues, the drug stays in the milk and causes serious ailments like breast cancer and prostate cancer, also impotency in men.
- Oxytocin or growth hormones can lead to disruption of the endocrine system, which would lead to cases of gynaecomastia (breast enlargement) in male and weight gain and pubertal disturbance in girls.

A victim approached “SHE Teams” with a complaint that Her daughter aged.20 yrs is receiving vulgar messages from unknown person. Immediately the petitioner called back the received phone number. The respondent was using abusive and vulgar language on phone. Immediately the petitioner reported the matter to SHE Teams office for taking suitable action on the respondent.

Based on the complaint, the SHE Teams personnel apprehended the respondent from Musheerabad at his house and brought him to SHE teams office and the respondent admitted his guilt. On enquiry he revealed that he and his another friend Vineeth were making phone calls to the victim and while the parent called back to the victim phone No. He said his name is Vineeth. Both the respondent harassed the complainant and victim.

The respondents disclosed their names as 1).Eerpula Veeneeth @Bunti S/o.Subhash (Late) age.20 yrs r/o.Habeeb Nagar, Hyderabad 2). B.Susheel S/o.B.Kamalesh age.22 yrs r/o.Musheerabad, Hyderabad.

Both the respondents admitted their guilt and as per the instructions of superior officers, they were handed over to Musheerabad P.S for taking further necessary action and a case is registered U/s.509, 506 IPC.

2). A victim approached “SHE Teams” with a complaint that on 22-06-2018 she did register marriage in the presence of elders. Earlier to her marriage, she alongwith her parents stayed at Laldarwaza, where her neighbour Mr.Ankit used to follow her and trouble her. Since two years they shifted to Gudimalkapur. Yet, he did not give up and started harassing her mentally and making phone calls and text messages. The respondent did not change his behaviour and even after her marriage, he started threatening that he would make her husband suspect her and she is getting more difficulties because of his behaviour. Therefore, she requested to take necessary action.

Based on the petition, the SHE Teams apprehended the victim. On enquiry he disclosed his identity as Aniketh Raj, S/o.Shyam Raj, age.25 yrs, Occ.Web Designer r/o.Lal Darwaja, Hyderabad. The respondent admitted his guilt. As per the instructions of superior officers, the respondent was handed over to Tappachabutra P.S and a criminal case is booked against him U/s.354D, 506 IPC and further investigation is in progress.

3). A victim approached “SHE Teams” with a complaint that in the year 2015 she joined Intermediate in Rao’s Jr.College, Kukatpally. There she met one Narender and he was her classmate. They moved closely after that. Once he made a love proposal to marry her but she rejected his proposal. Later he started harassing to marry him by showing some pics. After that she completed her intermediate and joined in B.Tech in CMR College at Medchal but he failed in Intermediate and did not change his behaviour and continued harassing her regularly by following her. He abused her in filthy language and also harassed through phone and misbehaved with her. He threatened to kill her if she wont accept his proposal. He also stated that he will kill her once he returns from jail. On 4<sup>th</sup> July, 2018 at about 12.00 PM the respondent came to her house and knocked her house doors from outside and threatened her with dire consequences and sat outside her house with a knife till evening 4.00 PM. Due to fear, the same was informed to her parents. On 5<sup>th</sup> July, 2018 in the morning hours, she again received abusive messages from his phone and approached SHE teams office.

Based on the petition, the SHE Teams made discreet enquiry and apprehended the respondent. He disclosed his identity as S.Narender S/o.S.Narsimhulu age.20 yrs, r/o.Sanathnagar, Hyderabad. On enquiry, he admitted his guilt and is produced before the superior officers.

As per the instructions of superior officers, a criminal case is booked against the respondent U/s.354D, 451, 506, 509 IPC and handed him over to Bowenpally P.S for further necessary action.

4). A victim approached "SHE Teams" with a complaint that on 04-07-2018 one known person who is her Ex-friend is harassing her by phone and speaking unparliamentary language. Based on her petition, the SHE Teams made enquiry and apprehended the respondent Md.Javeed Abdul Mazeed Akbani s/o Abdul Mazeed Akbani, Age. 19, occ.pvt Emp R/o:12-1-922/2/1,Gandhi statue,Asifnagar,Hyderabad. On enquiry he admitted his guilt. As per the instructions of superior officers he is liable to punish U/s 70 (C) City Police Act Hyderabad.

5). A victim approached "SHE Teams" with a complaint that on 4<sup>th</sup> June,2018 at 0900 hrs that one known person by name M.Ram Babu aged.31 yrs is harassing her. Previously they both worked together in Panjagutta for (4) yrs. She took money from the respondent and given back his money two months ago. But he started calling her continuously and says that he had received the money back and he needs something from her. He is giving her phone number to others and abusing from different numbers. He is defaming her character and disturbing her family life.

Based on the contents of the petitioner, the SHE Teams made enquiry and collected calls details of the respondent phone numbers who is making calls. On credible information, the SHE teams apprehended him while he was moving near Times of India Office at Punjagutta, Hyderabad. He is brought to SHE Teams Office. On oral enquiry he disclosed his identity as M.Rambabu S/o.Satyanarayana age.31 yrs, Occ.Office boy in Times of India, Rahmathnagar, Yousufguda, Hyderabad. He admitted his guilt and as per the instructions of superior officers a case is filed against the respondent U/s.70 (C) of C.P act.

6). A victim approached "SHE Teams" with a complaint that since last six months one unknown person is sending morphed photos of victim to her phone number and sending messages and making whatsapp calls with abusive language. He posted morphed pics of the victim with his pic on whatsapp display and posted many pics of the victims to her whatsapp number.

As per the instructions of superior officer, the She Team immediately put the CDR to collect the particular respondent phone number who had made the calls in abusive messages with morphed pics for the last six months. On credible information, the respondent was moving at DLF, Gachibowli, Hyderabad. The SHE Teams personnel apprehended the respondent and brought him to SHE Teams office for enquiry.

On oral enquiry he disclosed his identity as Hanif Khan S/o.Chada Khan age.28 yrs, Occ.Hotel Business r/o.King Koti, Hyderabad. He voluntarily accepted his guilt. As per the instructions of superior officers, the offender is liable to punish U/s.70 (C) of CP act and produced before XI Spl.MM court, where he is given punishment for (6) days imprisonment and Rs.50/- fine.

7). As per the instructions of Superior officer, SHE Teams alongwith staff reached out Hot Spot area at St.Francis College, Abids, Hyderabad. At that time, some unknown boys were found creating nuisance and teasing the girls. Immediately, the SHE Teams staff caught hold of (3) minor boys. On oral enquiry they disclosed their identity as 1).Vinay S/o. Mahender age.17 yrs Occ.Student r/o. Mangalhat 2).Vishnu Singh S/o.Yudveer Singh age.17 yrs

r/o.Mangalhat, Hyderabad 3). Kuldeep Kumar S/o.anand Kumar age.17 yrs, Occ.Student  
r/o.Begum Bazar Hyderabad.

The apprehended respondents were brought to SHE Teams office and produced before the superior officers for interrogation. On enquiry they admitted their guilt and since the respondents were minors, they were counselled along with their parents and warned against indulging in eve teasing in future.

8). As per the instructions of superior officer, the SHE Teams and its staff went to Mehdiapatnam R.T.C Bus stop and St. Ann's College premises on 7-7-2018 at 11:30 AM in front of College gate. While observing, they found two person moving on scooty vehicle repeatedly and commenting on girls and teasing them.

Immediately, the SHE team personnel captured the movement on camera and apprehended them. They were brought to SHE Teams office. On enquiry they disclosed their identity as 1). Abdul Moiz S/o.Mohd Shoukath Ali age.20 yrs 2).Mohd Hassan, S/o.Mohd Hanfa, 19 yrs. Both are the residents of Kamatipura, Hyderabad.

The respondents were minors and were counselled, warned and let off.
