

**NABBED INTERSTATE GANJA SMUGGLING GANG – 04-HELD,  
SEIZED 420 KGs of GANJA, NET CASH OF Rs.11,10,000/-.**

On 11.03.2017, the Commissioner's Task Force, East Zone Team, Hyderabad along with O.U. Sity police, apprehended interstate Ganja smuggling gang consisting of 04-members namely viz., **1) Ch.Pavan, 2) V.Naresh, 3) Y.Narsaiah, and 4) K.Srinivas** along with **03-four wheelers containing 420 KGs of Ganja, 01-TVS Apache Bike**, at Street No.8, Habsiguda, O.U. Sity, Hyderabad.

**Modus Operandi:** -

The accused Nagaraju is the kingpin of Ganja smuggling racket and hails from Khammam Dist, Pavan is nephew to Nagaraju, belongs to Mahaboobabad Dist. Naresh, Narsaiah and Srinivas are working as transporters of Ganja for eking their livelihood and all are close friends.

In the year-2016 accused Naresh and Srinivas are arrested by Sanga Reddy police and Narsaiah was arrested by Kotavurutla police of Vizag while transporting the Ganja. After releasing from jail, all the accused met **Nagaraju**, R/o Habsiguda, Hyd, who is smuggling Ganja from Annavaram agency of A.P. State to Maharashtra and hatched a plan to join him in this illegal Ganja Trade.

For this purpose they purchased 3-four wheelers for transporting Ganja and modified the vehicles so that Ganja can be concealed under the base and later load the truck with empty plastic crates of vegetables to mislead police.

In the first week of March-2017, as per the instructions of Nagaraju, all the accused went to Annavaram from Hyderabad in 03-four wheeler vehicles and met a known tribal contact of Nagaraju at Annavaram and purchased huge quantity of Ganja and returned by loading the same in their vehicles. The accused Pavan used to inform about police checking in their enroute by piloting on his bike.

The accused Nagaraju is used to purchase the Ganja for Rs.1500/- per 1 KG and used to sell the Ganja for Rs.6000/- per 1 KG to the needy customers. They used to sell Ganja to the needy and known customers of Hyderabad and Nanded, Mumbai of Maharashtra state secretly and earned easy money illegally.

On 11-03-2017, on credible information the Commissioner's Task Force, East Zone Team, Hyderabad City and O.U. Sity police apprehended 04-accused namely **Pavan, Naresh, Narsaiah and Srinivas** along with 03-four wheeler vehicles containing Ganja and seized **420 KGs of Ganja, Net cash of Rs.11,10,000/-, 03-four wheeler vehicles, 01-TVS Apache Bike and 05-Cell phones**, from their possession.

Efforts are continued to apprehend the absconding accused Nagaraju R/o Habsiguda, Hyd.

## **COCAINE DRUG PEDDLER NABBED – ONE NIGERINA NOTAIIONAL HELD**

SEIZED (20) GRAMS OF COCAINE, ONE CAR, (02) CELL PHONES

On 10-03-2017 in the joint operation, the Commissioner's Task Force, North Zone team and Police Marredpally PS, nabbed one Narcotic drug peddler Gabriel Aja O (**Nigerian National**) at Secunderabad Club, near Vivekananda Statue, Marredpally, who is in illegal possession of Narcotic substance drug "Cocaine" in order to deliver to customers. **Seized (20) grams of Cocaine, (02) Cell phones, (01) Car (Chevrolet)** from the possession of accused.

### **Details of apprehended Accused :**

Gabriel Aja O S/o. Aja Micheal , age. 25 yrs, Occ. Business, R/o. Sainikpuri, R.R.Dist, N/o. H.No. 11, Chinda Street, Port Harcourt, Nigeria County.

### **Modus operandi:**

The Drug peddler Gabriel Aja O S/o. Aja Micheal , age. 25 yrs is a Citizen of Port Harcourt, Nigeria Country. He came to India on business VISA and doing Garments export business. He use one of their local dialects to communicate with one another and deliver drug to the consumers, Customers from Pune through drug peddler Emeka N/o. Nigeria Country R/o.Pune. The accused is purchase Cocaine Drug for Rs. 3,000/- to 3,500/- from drug peddler and sell the same Rs. 4500/- to 5,000/- each gram to the consumers, Customers at Hyderabad to gain easy profit. The accused developed contacts with potential customers, consumers and supplying cocaine drug at Hyderabad and surrounding area. Drug peddler also built chain system in-between Drug customers, seller to hide their identity and to escape from the police surveillance.

### **Brief facts of the case:-**

The accused Gabriel Aja O, age 25 yrs, is native of Port Harcourt, Nigerian Country. In the month of October-2016 he came to India ( Delhi) on business VISA. He use to stay at Delhi and Hyderabad at his Nigerian Country friends. In the month of Jan-2017 he came to Hyderabad. Presently staying at Sainikpuri, R.R.Dist. Often he used to visit his Nigerian friends and taking shelter at Flat No 302, 3<sup>rd</sup> floor, Mini Gulshan Colony, Shaikpet, Hyderabad. Due to financial problems as per the advise of his friends, he use to supply Narcotic drug from Pune to other cities on commission basis to the needy customers, Habitual consumers. He came to know that there is huge demand for Drugs by the youth , High Society peoples in Hyderabad and he hatched a plan to transporting, selling drugs in Hyderabad from Pune though Drug peddler by name Emeka N/o. Nigeria Country. The accused developed contacts with potential customers, consumers and supplying cocaine drug. He also built-up chain system in-between Drug customers, seller to hide his identity and to escape from the police surveillance. The accused is use one of their local dialects to communicate with one another and have established a drug net work in Hyderabad and other Cities and became part of an already existing network of operatives of Drug suppliers from Pune . The accused is supply Cocaine Drug for Rs. 4,500/- to 5,000/- per one gram to the Drugs selling agents, Consumers at Hyderabad and gain easy profit. He is transporting Cocaine drug in the car bearing no. MH04DW- 6671 ( Chevrolet) and deliver to needy customers.

Accordingly on 10-03-2017 the drug peddler Gabriel Aja O reached at Secunderabad Club, near Vivekananda Statue, Marredpally in order to deliver the Cocaine to customer, meanwhile on tip off apprehended him along with the narcotic drug "**Cocaine**". Seized Cocaine Drug : 20 Grams, 02 Mobile phones and one Car Reg No. MH04DW6671 (Chevrolet) from the instance of accused.

**NABBED ONE NOTORIOUS HOUSE BURGLARY, AUTOMOBILE THEFT OFFENDER WHO HAS ESCAPED FROM LAWFUL CUSTODY OF CHIKKADAPALLY PS,**

The sleuths of Commissioner's Task Force, **Central Zone Team** apprehended one notorious habitual H.B burglary and Automobile theft offender Pulijala Chinna Yellaiah @ Chinna Yellaiah @ China Mallaiah who indulged in HOUSE BURGLARY/THEFT cases, in the limits of Hyderabad and Cyberabad. Last month he was escaped from lawful Custody of Chikkadapally PS. Recovered **Gold ornaments** weighing about **50 grams**, (03) Four Wheel Vehicles, (03) Two wheeler vehicles, (01) Samsung LED TV (40 inch), one Acer Laptop, and one apple I-pad. Total worth of the recovered property is around **Rs. 14 Lakhs**.

**Modus Operandi:-**

The accused Pulijala Chinna Yellaiah @ Chinna Yellaiah @ China Mallaiah , age. 49 yrs, is native of Nagarkurnool Town & District. He is Habitual Notorious HB Night and four/Two wheeler theft offender. He used to move in Hyderabad, Mahaboob Nagar on the stolen vehicles. He commit theft of Four wheeler, Two wheeler vehicle from parking places and moves in the Posh Colonies, and "Racee" the house which are locked from out side and commit theft in the locked houses. He carries Screw driver or Iron rod along with him. He break open the lock or latch of door with the help of Screw Driver or Iron rod and commit theft of Gold, Silver ornaments, Cash etc. After that he will fled away with the stolen property and spent the money for his lavish expenses. He also commits theft of two wheelers and four wheelers by breaking the locks of vehicles and fled away from

the spot and he will use for his personal convenience and also use in commit theft of H.B by Night.

Since 1992 he was arrested by the police about 22 times in several occasions in night HB cases/Theft cases. In the year of 2015 he was arrested by Panjagutta Police and was sent him to judicial custody and invoked PD Act against him on 25-07-2015. After one and half year he was released from Chanchalguda Jail. After release from the jail he again committed (04) house burglaries/theft cases in Hyderabad and the following cases were registered.

On 08-01-2017 Chikkadapally police apprehended him in early hours and arrested in Cr. No. 11/2017 U/s 379 IPC. The said arrested accused Chinna Yellaiah who escaped from the lawful custody of Chikkadapally police. On above incident a case was registered against him in Cr. No. 12/2017 U/s 224 IPC of Chikkadapally PS. Earlier he was also escaped from TB hospital, Erragadda in the year 2013 and NIMS hospital, panjagutta in the year 2015 while he was undergoing treatment during his judicial remand period in Charlapally Central Prison. He is having the habitual of escaping from the lawful custody.

After escaping from the lawful custody of Chikkadapally Police, he again committed (07) house burglaries & Automobile theft cases and the following cases were registered.
