

**FIRE ACCIDENT OCCURRED IN THE GODOWN OF SHADES COLOURS,
GUNDA GALLI, DISTILLERY ROAD, RANIGUNJ ON THE NIGHT OF
8.06.2018 DUE TO THE NEGLIGENCE OF THE PROPRIETOR –
ARREST OF ACCUSED**

Details of the accused

Kalpesh Bhogani s/o Deepak Bhogani, 44-years, Business Managing Partner at M/s Shades Paints Shop, Ranigunj, Secunderabad r/o Flat No. 302, Coral Treasure Apartments, new Gurumurthy Lane, Begumpet, Hyderabad

On the night of 08.06.2018 a huge fire erupted in the godown of M/s Shades Paints Shop, Ranigunj, Secunderabad belongs to the accused Kalpesh Bhogani damaging the stocks and engulfing the nearby buildings into flames endangering to the public lives and private properties.

On receipt of information the local Police rushed to the spot, secured the assistance of the Fire Service Department and controlled the fire.

On a complaint of Mr. Venkateshwar, SFO, Secunderabad a case in Cr.No. 91/2018 u/s 336, 285, 286 IPC r/w Sec. 9 (B) (1) (b) of Explosives Act, 1884 and Sec. 4 of Explosive Substance Act-1908 has been registered against the Proprietor at Mahankali Police Station for the following lapses.

- Rashly or negligently as to endanger human life or the personal safety others,
- Whoever does, with fire or any combustible matter, any act so rashly or negligently as to endanger human life, or to be likely to cause hurt or injury to any other person, or knowingly or negligently omits to take such order with any fire or any combustible matter in his possession as is sufficient to guard against any probable danger to human life from such fire or combustible matter,
- Whoever does, with any explosive substance, any act so rashly or negligently as to endanger human life, or to be likely to cause hurt or injury to any other person, or knowingly or negligently omits to take such order with any explosive substance in his possession as is sufficient to guard against any probable danger to human life from that substance,

The accused Kalpesh Bhogani, 44-years, is the Managing Partner, M/s Shades Paints Shop, Ranigunj, Secunderabad. It is in the name of his wife Smt. Jaya Bhogani. He is the owner of building bearing premises No.

5-4-1 to 16, Gunda Galli, Distillery road, Ranigunj, Secunderabad consisting of Ground, 1st, and 2nd and a temporary tin shed on the 3rd Floor; wherein he stocked the paints and varnish in unauthorized premises containing highly inflammable remnants in the entire building without taking any precautionary measures endangering to the lives and properties of others. On the night of 08.06.2018 a fire broke out in the godown due to electric short-circuit while mixing paints without taking any precautionary measures. The place of incident is surrounded by other shops i.e. M/s Somanath Traders deals in iron sheets, M/s South King Wires and Cables godown and M/s Commercial Trading Corporation, stockiest of machinery spare parts of Pharma Industries and Rice Mills etc. It took more than two days to control the fire and due to the fire incident the nearby shops were also damaged heavily.

To-day i.e. on 11.06.2018 the accused Kalpesh Bhogani has been arrested and being produced in the Honourable Court for judicial remand.

Appeal to the other traders

- Not to stock inflammable items in the godown without taking proper precautionary measures,
- Not to stock inflammable goods without any valid license,
- Obtain proper licenses from the authorities of GHMC and Fire Services,
- Stock fire fighting equipments at the godowns,
- Running establishments or stocking the goods in the godowns without obtaining Licenses from the concerned departments will entails to prosecution,

Brief facts :

Facts of the case are that on 12-06-2018 at 11.00 hrs received a complaint from D.Sai Kumar, PC: 1829 of Abid Road Police Station Hyderabad, in which he stated that on 12-06-2018 as per the instruction of superior officer while he was performing Patrolling Duty on BC-II in the limits of Abid Road P.S, Hyderabad, at about 10.00 hours he received a information from CC 100 Dial, through PS Abids, by stating that one male person lying Near RK Enterprises, back side Medwin Hospital, Chirag Ali Lane, Abids, Hyderabad. Immediately he rushed to the above said spot and found unknown male dead body, age about 39 yrs, seems to be Hindu, complexion: Medium, wearing clothes: Brown Colour Checks Shirt and blue colour jeans, Height about 5.6 fts and black colour hair, and he observed the above said person was died and he caused enquired near by people but no one came forward to speak about the unknown male dead body and he immediately with the help of nearby people shifted the dead body to OGH. Hence he request to take necessary action
