

PRESS NOTE:

APPREHENDED THE CRICKET BETTING & COLLECTIONS AGENTS, SEIZED NET CASH OF RS. 10,44,010/- & 6 Cell Phones

On 11.05.2018 at 16.00 hrs Police PS Shahinayathgunj received the credible information that one person by name **Sunil Tiwari** is collecting cricket betting amounts from punters by sitting at the house of one **Durgesh Yadav i.e. premises no 15-8-168, Fish Market, Begum Bazaar, Hyderabad for the ongoing IPL Cricket Matches.**

Immediately conducted the raid on the above mentioned premises and apprehended the two persons by name 1) Durgesh Yadav 2) Sunil Tiwari. On enquiry with Durgesh Yadav revealed that he was working under the Sunil Tiwari who was Cricket Bookie for collecting the betting amounts and also arranging the premises to sit the Sunil Tiwari for accepting the Cricket betting's. Sunil Tiwari was getting the betting line over phone from 1) Pavan R/o Nanded, 2) Prem Singh, Age about 33 yrs, R/o: Asif Nagar, Hyd.

Further Collected betting amounts will be sent to A3. Pavan R/o Nanded through A5 Milan Kothari & A6 Devesh Kothari

Seized Net Cash Rs. 90,000/- and 4 Cell Phones from the possession of A1 Sunil Tiwari & A2. Durgesh Yadav.

On 12-05-2018 on the leading of A2 Durgesh Yadav apprehended the A5. Milan Kothari & A6 Devesh Kothari at his residence i.e. SLV Apartments, Kacheguda, Hyderabad and seized the Net Cash of Rs. 9,54,010/-, & 2 Cell Phones from the Possession of A5 & A6.

A1. Sunil Tiwari & A2. Durgesh Yadav were arrested and produced before the honourable court on 12-05-2018 for Judicial Remand
