**NOTIFICATION**

With a view to maintain public order and tranquillity I, M. Mahendar Reddy, IPS, Commissioner of Police Hyderabad City, in exercise of the powers vested in me, under Section 22(1) (a) to (f) and 22 (2) (a) and (b) of Hyderabad City Police Act, 1348 Fasli (No.IX), do hereby prohibit every kind of assembly or public meeting or procession that has potential to cause disturbance to the public peace and safety within a radius of four kilometres of the Telangana State Legislative Assembly Building in connection with Telangana State Legislative Assembly / Council Monsoon Session.

This Order shall come into force with effect from 0600 hours on 14-11-2017 to 0600 hrs on 20-11-2017.

**ONE ABSCONDING DRUG PEDDLER NABEED – BY WEST ZONE TASK FORCE TEAM,  
HYDERABAD CITY**

On 13-11-2017, the sleuths of Commissioner's Task Force, West Zone team, Hyderabad apprehended one drug peddler Shashikanth Cherla @ Bobby who was absconding in **Cr.No.679/2017 U/s 21(B), 22(C) 27(A) & 29 of NDPS Act-1985 of Banjara Hills PS** since commission of offence. Seized net cash of Rs.1660/- and (1) I-Phone from his possession.

**Details of the Accused:**

1. Shashikanth Cherla @ Bobby S/o CH.Praveen Kumar, aged 34 yrs, Occ: Tiffin Center Business at Kasol (V), Manikarn, Kullu (District), Himachal Pradesh, N/o Pent House, H.No.24, Ganesh Nagar Colony, West Marredpally, Sec'bad, Presently residing at Kasol (V), Manikarn, Kullu (District), Himachal Pradesh.

**Brief about the accused & Modus operandi:**

The accused Shashikanth Cherla @ Bobby is born and brought up into Hyderabad. He is having one sister. His father is staying at USA. He completed his Intermediate studies from St.Mary's College, ECIL, Sec'bad. After completion of his Intermediate studies he joined in B.Com Degree studies in Distance Education, Andhra University and discontinued from Degree 2<sup>nd</sup> year. Later he joined in Base Ball coaching center and learned Base ball game after completion of his training he worked as Base ball coach in Osmania University from the year 2000 to 2012.

In the year 2012 he went to New Delhi for business purpose and stayed with his friend who is doing Hotel Business. Later his friend informed him that he is having one restaurant at Kasol (V), Manikarn, Kullu (District), Himachal Pradesh and asked him to run the same on commission basis. On which in the ending of 2013 he went to Kasol and took all ID proof and address proofs to stay there and in the year 2015 he started Restaurant business on the name of "Som Tiffin Center" at Kasol (V), Manikarn, Kullu (District), Himachal Pradesh. When he was visit to Hyderabad he used to stay at Pent House, H.No.24, Ganesh Nagar Colony, West Marredpally, Sec'bad. From the year 2004 he started consuming Ganja. He used to purchase Ganja from unknown persons in Secunderabad area and used to consume the same.

In the year 2007 he was visited Goa and where he was addicted to consume MDMA drug. Later he started purchasing Ganja & MDMA drug from unknown persons and selling the same to needy customers and earning money. He used to search for drugs by browsing internet and used to purchase MDMA drug, Cocaine etc by using "**Tor Browser**" and selling the same to other needy customers on higher rates and earning illegal money.

He along with his friend Abhinav Mahender used to sell MDMA and other drugs to the needy customers in Hyderabad and other areas. In the month of July-2017 his friend Abhinav Mahender was arrested by West Zone Task Force in drugs case and sent to jail by Banjara Hills PS, in this case the accused Shashikanth Cherla @ Bobby was absconding.

Today i.e. on 13-11-2017 on credible information the accused Shashikanth Cherla @ Bobby was apprehended by West Zone Task Force team at Marredpally and handed over to SHO, Banjara Hills PS, for further action.

The arrest was made under the supervision of **Sri P.Radha Kishan Rao**, Dy.Commissioner of Police, Commissioner's Task Force by **Sri L.Raja Venkat Reddy**, Inspector of Police, West Zone Task Force Team, with the assistance of SI's Sri P.Mallikarjun, Sri M.Prabhakar Reddy, Sri V.Kishore, Sri L.Bhaskar Reddy and staff of West Zone team, Commissioner's Task Force, Hyderabad City.

**SREE RAM CITY UNION FINANCE LIMITED, SHAH ALI BANDA BRANCH SWINDLED THE NEEDY PEOPLE WHO TOOK LOAN BY MORTGAGING GOLD ORNAMENTS.**

On 09/11/2017, B. Harish Yadav R/o Gowlipura, Hyderabad reported Moghalpura PS that he took loan of Rs. 1 Lakh on 15/02/17 from Sree Ram City Union Finance Limited, Shah Ali Band Branch situated at Shah Ali Banda X Road on mortgaging 72.5 grams of golden ornaments. Sree Ram City Union Finance Limited was allotted a Customer ID NO 1602150007 to the petitioner B. Harish Yadav.

To clear off the loan amount he meet with the G. Sudhir Goud the then Branch Manager of Sree Ram City Union Finance Limited and to release his mortgaged golden ornaments from Sree Ram City Union Finance Limited.

The Manager of the Firm/company informed the petitioner that the claim was in the name of some Ms. Vandana and the Manager was also told that as per the top Management orders, he acted upon it.

The Petitioner B. Harish Yadav was also meet with the Vandana, enquired about the subject and upon that she informed him that She has not took any loan from Sree Ram City Union Finance Limited, Shah Ali Banda.

The petitioner came to know that many other customers were also deceived by the Management of the company and its staff and requested to take legal action as per law.

On his request, Moghalpura Police registered a case in Cr. NO. 132/17 U/s 406, 420 r/w 34 IPC on the Chairman of M/s Sree Ram City Union Finance Limited and two other staff members.

### **ON E-PETTY CASES OF PS CHILKALGUDA**

On 12.11.2017 PS Chilkalguda has booked e-petty case against Syed Javed s/o Md. Dasthagiri, age 35 years, and Syed Parvez S/o Dasthagiri, age 37 years owners of "FAMOUS PAN SHOP" for violation of CP, act ( 21 hyd CP act); who doing business at late night at Chilkalguda.

Before this, four e-petty cases were booked against the above persons for late night business, in which they were fined rupees by Hon'ble court.

On 12.11.2017 one e-petty case No 720/2017 has been booked against the same persons for repeatedly violation of CP act (for late night running business) and filed charge sheet against them by mentioning previous cases and convictions in the e-petty case charge sheet, after heard by the Hon'ble X Addl Chief Metropolitan Magistrate, they were convicted and sentenced for one day jail & fine Rs 100/- vide STC No. 2651/2017, dated 13.11.2017. Previously, in front of FAMOUS PAN SHOP a case has been booked for gathering and beaten to the complainant by AN unknown persons, it was caused by running late night business by the above PAN SHOP OWNERS.

This above conviction is warned for those who running late night businesses by repeated violating of Hyderabad city police Act, and they should be jailed by the Hon'ble court.
