

NOTIFICATION

In exercise of the powers conferred upon me under section 21 (1) (b) of the Hyderabad City Police Act, I, Anjani Kumar, I.P.S., Commissioner of Police, Hyderabad, hereby notify, for information of the general public, that, in order to relieve congestion, to maintain smooth flow of traffic and to ensure public safety and order, in connection with the Ganesh immersion processions, from 15-09-2018 to 22-09-2018 the following traffic restrictions will be imposed from 1500 hours onwards till late night every day.

1. **At Hotel Marriot (Viceroy) 'T' Jn:** General traffic coming from Karbala Maidan will not be allowed towards the Upper Tankbund and will be diverted towards Kavadiguda X-Roads. Public who are intending to go towards Liberty may take the route via Kavadiguda X-Roads, Gandhi Nagar T Jn, DBR Mills, Indira Park and Domalguda. Those intending to go towards Khairatabad and Panjagutta may take the route via Ranigunj, Nallagutta, Sanjeevaiah Park, Necklace Road and Khairatabad flyover.
2. **At Necklace Rotary:** General traffic coming from Khairatabad flyover will not be allowed towards the NTR Marg, and will be diverted towards Necklace Road or the Mint Compound Road.
3. **At Telugu Talli Statue Jn :** Traffic will not be allowed towards NTR Marg and will be diverted towards Iqbal Minar at Telugu Talli Junction and the traffic going towards Secunderabad will be directed to Telugu Talii Flyover and will go to Katta Maisamma Temple, DBR Mills and then proceed via Children Park, Sailing Club, Karbala Maidan.
4. **At DBR:** Traffic coming from Goshala and going towards upper tankbund will not be allowed and will be diverted at DBR towards Lower Tankbund.

Further it is informed that the above restrictions will be imposed depending on the traffic congestion of Ganesh idols for immersion at Tankbund and NTR Marg.

Citizens are requested to take alternate routes to their destination and cooperate with the Traffic Police.

**HELD ONE CHILD CONFLICT WITH LAW AND TWO ACCUSED – DETECTED
ROBBERY CASE AND RECOVERED NET CASH Rs. 400/-, ONE CELKON MOBILE
AND ONE BAJAJ PLATINA TWO WHEELER**

On 13/14-09-2018 intervening night at about 00.05 hrs the sleuths of Commissioner's Task force, **Central Zone Team**, Hyderabad along with Ramgopalpet police, apprehended one child conflict with law and two accused and detected robbery case and recovered net cash Rs. 400/-, one celkon mobile and one bajaj platina two-wheeler from their possession.

DETAILS OF THE ACCUSED:

1. MD Amer S/o; Md Omer, Age: 20 years, Occ: Watchman @ TS Secereteriate, R/o: Near Yellamma Temple, DBR BMills, Lower Tank Bund, Hyderabad.
2. Birru Nikhil S/o: Chandraiah, Age: 18 years, Occ:Electrician, R/o: Rajgopal Residency, Lower Tankbund, Gandhi nagar, Hyderabad.
3. One Child conflict with Law

BRIEF FACTS OF THE CASE:

Today i.e., On 13/14-09-2018 intervening night at about 00.05 hrs our PC Sri. B. Vidya Sagar was in patrolling duty in the limits of Ramgopalpet PS and passing Sanjeevaiah Park, Necklese Road mean while one person was shouting with hues and cries with bleeding head injuries. On enquiry he reveals his name is Y. Thimmappa aged about 22 years working in Necklese View Hotel as Room boy and informed that three persons are obstructed and beat with Brick and robbed his cell phone and Rs. 400/- cash. Immediately PC chased them and at little distance stopped their vehicle and caught two persons with stolen Mobile and Cash and called mobile of Ramgopalpet PS and handed over them and shifted injured person to Hospital.

In this case recovered net cash Rs. 400/-, one celkon mobile and one bajaj platina two-wheeler from the possession of accused. In this regard a case was registered in Ramgopalpet PS wide Crime No. 200/2018 U/s 392 IPC.

Today Shri. Anjani Kumar IPS, Commissioner of Police, Hyderabad city personally appreciated and Cash reward was given to PC 8220, Sri. B. Vidya Sagar of Commissioner's Task Force, Central Zone team for his good work.

PERSON INDULGING IN MURDER CASE WAS APPREHENDED
BY PS MOGHALPURA.

On a tip off for working out clues, Moghalpura Police apprehended the persons by name **A-1. Mohd Ilyas Idris @ Ilyas, A-2. Mohd. Rahmath Hussain @ Rahmath,** who are involved in Cr.No. 95/2018, U/Sec 302 r/w 34 IPC of PS Moghalpura, Hyderabad.

Brief Facts of the Case:-

The brief facts of the case are that on Smt. Ayesha Sultana, W/o: Md Khaja Moinuddin, aged: 25 yrs, Occ: House wife, R/o: H.No.13-3-1111/2, Sabji Mandi, Puranapool, Hyd. Presently staying at Musthafa Nagar, Faluknuma, lodged a complaint that 10-09-2018 she was suffering from severe stomach pain, due to which she went to alpha hospital along with sister-in-law Faimida begum at 1600 hrs, after that her husband came to there and after completion of her treatment they came to parking area to go to home, meanwhile the above said accused persons A1 and A2 attacked her husband with knives, due to which her husband received stabbing injuries and died and same day while undergoing treatment at Osmania Hospital. The reason that the people attacked her husband was that her husband brother Khaja Nizamuddin marriage was performed one year back with Ifath Fatima, daughter of A1. After the marriage of four months the Ifath Fatima was died suicide herself. Since that Ifath Fatima family members developed bore grudges against the deceased family so that 10-09-2018 at 2000 hrs A1. Ilyas and A2. Rahmath Hussain who is the relative of A1 attacked her husband with knives and killed her husband brutally.

While the investigation is in progress on credible information regarding the presence of accused persons the Inspector Moghalpura A.Ganga Reddy along with staff apprehended the accused persons A1 and A2 at near Moosi river bed, out gate of MGBS.
