In exercise of the powers vested in me U/S 144 Cr. PC, I, M. Mahendar Reddy, IPS, Commissioner of Police, Hyderabad City, with a view to maintain public order and peace in the Twin Cities of Hyderabad and Secunderabad, do hereby prohibit assembly of 5 or more persons in a radius of 200 mtrs. from the Polling Stations within the limits of Hyderabad and Secunderabad on 19-03-2017 in connection with Fresh / Re-poll elections to the Telangana Legislative Council in respect of Teacher's Constituencies.

This order will remain in force from 0600 hours on 19-03-2017 to 0600 hours on 20-03-2017.

The public are hereby informed that any person violating the above orders shall be liable for prosecution under Section 144 Cr.PC.

LAKE POLICE RESCUED TWO PERSONS FROM COMMITTING SUICIDE

On 15 of March 2017, PS Lake officials have rescued **two persons** i.e., one male and one female persons and their particulars are 1) Smt. Mona kousar, 2) Sri. G. Anil, Were all rescued, while they were about to commit suicide by jumping into the Hussain Sagar Lake. The Details of the victims are as follows:-

First incident: Occurred on 15/03/2017 at 10:30 hours tried to jump into Hussain Sagar Lake at upper tank bund near Lepakshi.

Details of Victim: Smt. Mona kousar d/o Late. Sri. Mehamoodur Rehman, age:- 27 years, Occ:- housewife, r/o:- 16-2-835,flat no:105/A, green view apts, sankeshwar bazaar, Saidabad, Hyderabad.

Reason: On 15-03-2017 at about 10.30 hrs the victim came to upper tank bund near Lepakshi and tried to jump into Hussain sagar lake water, immediately the patrolling police noticed her stopped her by jumping into the Lake water and saved her life. On causing enquiry it came to know that the victim got marriage and blessed with one female child. Victim is suffering with psychiatric problem since 10years; the victim's husband got to know about her problem and took divorce from her. Due to which she decided to end her life. After counselling the victim was sent to Barosa counselling centre for further action.

Second incident: Occurred on 15/03/2017 at 16:15 hours tried to Jump into water at upper tank bund near Love Hyd.

Details of Victim: Sri. G. Anil s/o Sri. G. Bhoomaiah, age:- 25 years, Occ:- daily labour, r/o:- beside Sai vani hospital, domalguda, hyderabad.

Reason: On causing enquiry it came to know that the victim got married and leading conjugal life happily. The victim took 1 lakh of rupees as a hand loan from his known for his marriage by saying that he will refund that amount within one year. But due to his low income he unable to return the amount. Due to which he went into depression and tried to jump into water. Immediately our patrolling Lake police noticed him and saved his life. Inspector Lake Smt. K. Sreedevi counselled him and handed over to his brother.

As such Lake Police played a vital role in saving them spontaneously without giving any scope for untoward incidents for which they could saved the lives of people viz.,. 1) Smt. Mona kousar, 2) Sri. G. Anil these two incidents were occurred on 15-03-2017. Smt. K. Sreedevi, Inspector of Police, Lake Police Station had counselled them promptly and they were safely handed over to their relatives and concerned by taking their assurances that they will not repeat such things in near & future.

Thus, the patrolling Blue Colts of Lake PS viz., Sri. Mohd. Omer, Sri. F. Srinivas, PC 9720, Sri. Abdul Rasheed, HG 6110, Sri. C. Prathap reddy, HG 3356 have tactfully identified the above persons in a suspicious manner and rescued them from committing suicide which was done under the supervision of Smt. Sreedevi Inspector lake P.S.

**NABBED ONE CELL PHONE SNATCHER BY NAME MOHD AIJAZ WHO IS
ABSCONDING IN 16-CASES AND ALSO 06- NBWS PENDING AGAINST
HIM.**

On 15-03-2017, on credible information the Commissioner's Task force, South Zone Team apprehended one cell phone snatcher by name Mohd Aijaz S/o. Mohd Nawab, aged: 31 years, occ: Auto driver, R/o.HNo.19-03-538, Ali Nagar Gazi Banda, Bahudurpura, Hyderabad who is absconding in **16 Cell phone snatchings and 06- NBWs are pending against him** in the limits of Hyderabad & Cyberabad Commissionerates.

The details of accused apprehended:-

Mohd Aijaz S/o. Mohd Nawab, aged: 31 years, occ: Auto driver, R/o.HNo.19-03-538, Ali Nagar Gazi Banda, Bahudurpura, Hyderabad.

Modus Operandi of accused: -

The accused Mohd Aijaz is a notorious and habitual offender. He along with his associates Muzaffer @ Isa and others committed more than 30-cell phone snatchings in the limits of various Police Stations of Hyderabad and Cyberabad Commissionerates since 2011 by moving on motor cycles. On 24-06-2016, Mohd Aijaz was arrested by Banjara Hills Police and produced before the Hon'ble Court and sent him for Judicial Remand. Later, he jumped on bail before executing the PT Warrants from other Police Stations and since then he is absconding in other cases. South Zone Task Force team kept a close watch on his movements and apprehended him. During the course of interrogation it is came to know that, still he is absconding in **16-cases** in Hyderabad and Cyberabad Commissionerates and **06-NBWs** are ending against him.

The apprehended accused handed over to SHO SR Nagar PS for taking further action against him.
