**Apprehension of A.Pramod S/o Appu Aged 32 years, who attacked the victim Ms.Jisha Shaji, age 23 yrs, Occ: Nurse with Acid.**

On 10.05.2018 at about 05.30pm, while the victim Ms.Jisha Shaji, Nurse, Apollo Hospital was going to her hostel from Hospital the accused stalked her and poured acid on her from the back from a bottle. She was immediately admitted to the hospital and she identified the accused as one Mr.A.Pramod native of Kerala who earlier proposed to her for marriage, but she denied. Keeping this in mind he attacked her with acid.

Immediately many teams were pressed into service for apprehension of the accused. In pursuit of the accused the special team visited Palakkad District of Kerala and the accused was apprehended from a remote village (Attipadi) 80km from Palakkad district of Kerala.

The accused is being remanded in Cr.No.424/2018 U/sec. 326 (A) IPC of PS Banjara Hills, Hyderabad.

## **ONE PERSON HELD - WHO CHEATED INNOCENT PERSONS ON THE GUISE OF PROVIDING Jr. ASSISTANT (GROUP-II) JOBS**

On 15-05-2018 on credible information the sleuths of Commissioner's Task Force, West Zone Team, Hyderabad apprehended one accused Galla Prakash Varma @ Prakash, who cheated the innocent people on the guise of providing Jr. Assistant (Group-II) jobs in MRO offices in Hyderabad.

### **DETAILS OF THE ACCUSED:**

- 1) Galla Prakash Varma @ Prakash S/o Galla Premshyam Kumar, aged 27 yrs, Occ: Pvt. Employee, R/o H.No.49-53/A/B, Flat No.501, Sai Residency, Padma Nagar Ring Road, Suchitra, Hyderabad, N/o Near CSI Church, Medak District.

### **SEIZED PROPERTY:-**

- 1) Net cash of Rs.3.8 Lakhs.
- 2) Fake RDO Office Identity card on the name of accused.
- 3) Fake appointment letters for the post of Jr. Assistant (Group-II) – 8.
- 4) Cell phone – 1.

### **BRIEF HISTORY OF ACCUSED:-**

The accused Galla Prakash Varma @ Prakash is native of Medak District. His father was retired RTC employee and his mother was Govt. employee and worked in Health Department as CHO (Community Health Officer). About fifteen years back due to his mother's transfer all the family members shifted to Hyderabad and residing at Suchitra, Hyderabad. In the year 2013 his mother was expired. At present the accused along with his wife and daughter residing at above said address. At present the accused is working in AIRTEL office, Balkampet branch in verification department.

### **Modus operandi:-**

The accused Galla Prakash Varma @ Prakash, after the death of his mother he tried two years for his mother's job but he did not get any job. In this process he learned how to speak with the staff and officers in different government departments. Later he hatched a plan to cheat the innocent/unemployed youth on the guise of providing Jr. Assistant Jobs in MRO offices in Hyderabad basing on the Group-II notification of the year 2016. The accused is also created one Identity Card as Jr. Assistant, RDO Office, Koti, Hyderabad by attaching his photograph. The accused used to cheat the innocent people by showing the same ID card and make believe them that he is working in RDO office, Koti as Jr. Assistant and informed them that he had good contacts with the officials of Government offices and taken money of Rs.50,000/- to Rs.1 Lakh per job from the innocent people.

So far the accused have given fake appointment letters to eight members by collecting Rs.10 to Rs.12 Lakhs from them and informed them that to go to

MRO Office, Khairtabad, Hyderabad. By taking the appointment letters, the candidates approached MRO Office, Khairtabad, Hyderabad, where they came to know that the appointment letters were fake and they also came to know that they were cheated by the accused.

On complaint of Victims cases have been registered against the accused vide

- 1) **Cr.No.210/2018 U/s 420 IPC of Panjagutta PS.**
- 2) **Cr.No.292/2018 U/s 420 IPC of Pet Basheerbad PS, Cyberabad.**

On credible information, apprehended the above accused and recovered the above said property from his possession.

The arrested accused persons along with seized property were handed over to SHO, Panjagutta PS, Hyd, for taking necessary action.



Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City invoked P.D.Act against Mohd.Talha Ahmed @ Ahmed s/o Mohd.Jameel, property offender/robber of Golkonda Police Station on 5-10-2017.

The above offender was absconding from the date of issue of PD Orders and was concealing himself to avoid the execution of preventive detention orders, thereby obstructing the process of law. Therefore the proclamation requiring the appearance of the above accused was issued on 5-5-2018 and got the same published in local news papers. He was taken into custody on 9-5-2018, the P.D. orders were executed on him and was lodged in Central Prison, Chanchalguda, Hyderabad on 10-5-2018.

The above detainee was involved in 8 property offences including robberies in the limits of Hyderabad and Cyberabad Police Commissionerates. He has been creating fear and panic among the general public, especially women folk who constitute 50% of the population by committing such offences in public places and thus acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Golkonda Police made sincere efforts and arrested him 8-2-2017 in Cr.No. 31/2017 of Golkonda Police Station along with his associate. In pursuance of his confession, Police recovered the stolen properties i.e., 2 Motor Bikes (1 Passion Plus and q Hero-CBZ) and 68.85 grams of Gold Ornaments all worth Rs.3 Lakhs and was remanded to judicial custody on 9-2-2017. Subsequently, he was released from jail on bail in all the 7 cases on 31-5-2017. He went out of view till execution of Preventive Detention Orders on 10-5-2018.
