Hyderabad Traffic Police continuing its drive against the drunken drivers to ensure road safety. In the Month of November-2018 (**Upto 15th Nov**) caught (**1244**) drivers who were driving the vehicle in drunken condition. Charge sheets were filed against them and were produced them in the Hon'ble **3rd and 4th** Metropolitan Magistrate Courts, Nampally, Hyderabad. In this regard **3rd and 4th** Metropolitan Magistrate Courts has awarded imprisonment to the (**280**) respondents and Permanently Cancelled / Suspended Driving licenses of (**71**) Persons for a period as mentioned below. The Hon'ble Courts imposed fine amount of **Rs.26,95,500/-** on the remaining (**964**) Traffic violators. All the candidates who are sentenced for imprisonment were sent to Chanchalguda Jail.
