NOTIFICATION

With a view to maintain public order, peace and tranquility in the area known as Andhra Pradesh and Telangana Secretariats, Hyderabad in the limits of Saifabad Police Station, together with the offices located within the premises of the A.P. and Telangana Secretariats including the gates leading to the offices and also areas falling upto a distance of 3 KM s from secretariat building perimeter, I, M.Mahendar Reddy, IPS, Commissioner of Police, Hyderabad City, in exercise of the powers vested in me under Sec 22 of Hyderabad City Police Act, 1348 Fasli, do hereby make this written order and notify the same to the general public prohibiting the following matters :-

- i) holding of any public meeting;
- ii) Assembly of five or more persons;
- iii) Carrying the fire arms, banners, placards, lathis, spears, swords, sticks, brickbats, etc;
- iv) Shouting of slogans;
- v) Making of speeches, etc;
- vi) Processions and demonstration; and
- vii) Picketing or dharnas within the area specified in the schedule to this order without a written permission.

As the order cannot be served practicably on each individual and all concerned, the order is hereby passed ex-parte and the same is published for the information of general public through press and by affixing copies of this order on the notice boards of the offices of all the DCsP, ACsP and all Police Stations concerned and other places for conveying the information to the general public.

This order shall be in force with effect from 0600 hours on 19-05.2017 and shall remain in force for a period of two months i.e. upto 0600 hours on 18-07-2017 (both days inclusive), unless withdrawn earlier.

Any person violating the order shall be liable for punishment under section 188 of the Indian Penal code and as per the provisions of Hyderabad City Police Act, 1348 Fasli.

Traffic Advisory

It is inform that in view of laying paver blocks by the the GHMC on Karmika Nagar Main Road near Huts to Chilla in Rahamath Nagar it has been proposed to closed the road between Rahamath Nagar and Sriram Nagar at Karmika Nagar huts for period of 25 days and the general public are advised to take alternate routes in order to avoid inconvenience.

The following the traffic diversions which will come in to force from 18-05-2017 viz.,

- 1) Traffic coming from Rahamath Nagar intending to go towards Sriram Nagar will have to take diverted route towards GTS Colony, Rajeev Nagar Junction, Left turn and merge with the regular route at Prime Gardens Function Hall.
- 2) Traffic coming from Moti Nagar intending to go to Rahmath Nagar will have to take left turn at Prime Gardens Function Hall towards Rajeev Nagar Junction, take right turn towards GTS Colony and proceed towards Rahmath Nagar and merge with regular route.
- 3) RTC buses and heavy vehicles which ply via Karmika Nagar towards Borabanda shall take diverted route from Yousufguda Basti towards Krishnakanth Park, Kalyan Nagar Jn, Left turn towards GTS Colony, Rajeev Nagar Jn, left turn towards Prime Gardens Function Hall and merge with the regular route.
- 4) RTC Buses and heavy vehicles which ply from Borabanda to Rahamath Nagar stretch via Karmika Nagar will have to take left turn at Prime Gardens Function Hall, Sriram Nagar towards Rajeev Nagar Jn, take right turn towards GTS Colony, Kalyan Nagar Jn and proceed towards Yousufguda Basti and proceed further.

The general public is requested to co-operate with traffic police till the road restoration.
