### Press Note

City Police Commissioner Mr.CV Anand felicitated and presented appreciation certificate , cash reward to the police personnel who responded swiftly and arrested the offenders involved in chain and mobile snatching.

In the first incident, the perpetrator targeted a woman who was standing in front of a petrol bunk near Sangeeth X road, Secunderabad. He came by walk and snatched her gold chain and fled from the scene. The incident was reported around 10:45 am on 14-10-2022

The Gopalapuram PS team B.Saieashwar Goud, Inspector; B.Kotaiah, Addl.Inspector; R.Pandu raju; DSI; Ch.Kamalakar & K.Dhanraj(PCs) started the investigation and apprehended the accused on the same day.

In an another case, the Sultan Bazar PS personnel arrested two persons on the charge of snatching mobile from a pedestrian. J.Srikanth Reddy, SI; PCs Rakesh Kumar, Narender Kumar and Afroz probed the case and succeeded in nabbing the accused within four hours.

Inspectors Rajunaik, Sataiah and SIs Suresh Reddy, Niranjana and PC venuyadav of Saifabad PS teamed up with Nampally Inspector Khaleel Pasha and Begumpet PS SI Anusha and Shahgufta(PC-Ramgopalpet PS) played a keyrole in averting a communal tensions by tracing the antecedents, address and other details of the mentally retarded women who vandalised idols.

**HELD HABITUAL AUTOMOBILE OFFENDER– SEIZED (05) MOTOR CYCLES TOTAL WORTH OF Rs. 02 LAKHS**

The Commissioner's Task Force, South Zone Team, Hyderabad along with Banjara Hills Police apprehended one accused by name **Mohd. Khashif** who is a habitual motor cycle theft offender and committed theft of (05) motor cycles under the limits of Hyderabad and Cyberabad Police Commissionerates. Total seized **(05)** Motor cycles from the instance of the accused - Total worth of Rs. **02 Lakhs**.

**Details of the accused:**

Mohd.Khashif, age : 27 yrs, Occ: Labour, R/o Jhirra, Asif Nagar, Hyderabad

**Modus operandi:**

The accused Mohd.Khashif is born and brought up in Jirra, Tappachabutra, Hyderabad. He was dropped out from his school and worked as a labour in various places. Meantime, he got fascinated towards bike riding. As his earnings are not sufficient to fulfil his desires and unable to purchase motor cycle, he hatched a plan to commit theft of motor bikes to fulfil his desire. As of now he involved in more than (07) motor cycle theft cases in various police stations under the limits of Hyderabad, Cyberabad and Kareem Nagar **Commissionerates**.

Even after release from jail he didn't change his attitude and continued committing offences and involved in (5) motor cycle theft cases in the limits of Banjara Hills, Asif Nagar, Kulsumpura, Pet Basheerabad and Rajendra Nagar police stations.

On credible information, the South Zone Task Force Team, Hyderabad along with Banjara Hills Police apprehended the above said accused and recovered (05) motor cycles at the instance of the accused. The accused and seized property handed over to **SHO Banjara Hills PS** for further investigation.

(In Crime No: 366/2022, U/s 302 IPC of Asifnagar Police Station)

Asifnagar Police arrested the accused Rajkumar involved in murder case of Asifnagar P.S.

Sleuths of Asifnagar Police Station the murder of Sri Ranvijay Brijbihari Singh by arresting the accused person Rajkumar occurred on 16-03-2022 at Dilsad Nagar Colony, Mehdipatnam, Hyderabad.

### FACTS OF THE CASE:

On 17-10-2022 at 02:30 hrs, received a complaint from Sri. Rajesh Sahani, in which he stated that he is having labour contract for painting work at different places of Hyderabad City. Since last 3 months, he is having contract at site Dilshad Nagar Colony, Mehdipatnam, Hyderabad where he deputed 7 members. On 16-10-2022 he received a phone call from his worker informing that all his workers consumed alcohol and suddenly Rajkumar started quarrelling with Ranvijay Brijbihari Singh on a petty issue. Meantime Rajkumar beat Ravijay Brijbihari Singh with a construction stick resulting he sustained bleeding injury on his forehead. Immediately they shifted the injured to Medicover Hospital, Madhapur where the doctors declared brought dead.

### DETAILS OF DECEASED PERSON:

Sri Ranvijay Brijbihari Singh s/o Brijbihari Singh age 50 yrs occ Painter r/o Dilshad nagar colony, Mehdipatnam, Hyderabad. N/o **Gorakhpur, Uttar Pradesh**

### DETAILS OF ACCUSED PERSON:

Rajkumar s/o Ramamurat, age 47 yrs, occ: Painter, r/o Dilsad Nagar Colony, Mehdipatnam, Hyderabad. (N/o Jaswal, Rajabari(Post), Pepeeganj, **Gorakhpur, Uttar Pradesh-273165**)

### MOTIVE OF MURDER:

The accused after consuming alcohol he bore grudge against the deceased and beat the deceased with construction stick on his forehead, resulting he sustained head injuries and died.

#### SEIZED MATERIAL:-

1. Cell Phone
2. Accused cloths
3. Deceased cloths

### ARREST:-

The Asifnagar Police Station team received information that the accused is running away to his native place by train. Immediately Asifnagar team circulated the photographs and lookout notice of accused to Railway department and by coordinating with RPF Nagpur, identified and apprehended the accused Rajkumar and effected his arrest on 18.10.2022 and being produce before the Hon'ble Court.
