Harassing for sexual favours in the name of marriage, Man arrested.

A 23 yrs old woman was promised to be married by Shreekar S/o Janni Rao, 29 yrs pvt job, Gachibowli. He started harassing the victim to participate sexually with him as they will be tying the knot in future. When she requested him to wait till they get settled in career, he started showing his true colors blackmailing that he would share their photographs and to her family and friends if she doesn't satisfy him. Thinking to commit suicide, she wanted to check one chance with SHE Teams and would take extreme step if her problem doesn't get solved. SHE Teams apprehended the accused Shreekar s/o. Bujjirao, 29yrs, pvt employee, Gachibowli, gathered evidences and produced him in the court of law. Hon'ble XI Special Metropolitan Magistrate, Nampally has accorded 5 days of imprisonment.

Online Tutor who turned a traitor sentenced to Imprisonment.

A single working mother needed support for her child's education, hired an online tuition teacher from Suncity. Little did she know that he would turn into a traitor. He lured the girl promising a surprise for her mother. Tutor asked the girl to click pictures of her mother and share them to him without the mother's knowledge. And the innocent child followed her teacher's instructions. He later started blackmailing asking woman to marry him. When she denied, he threatened to share the photos to her ex-husband and convinced him by sending her pictures that she has affairs with other men who sent pictures inside her home, and that the child is no longer safe to stay with her. When informed and questioned by her ex-husband, she got to know that her girl was asked to send pics to the teacher. Shocked by the developments, Women approached SHE Teams and filed a complaint against teacher who lured the girl to act as per his wish.

SHE Teams collected all the relevant proofs against Rehman s/o Ibrahim, 50 yrs, online tutor, r/o Suncity and produced him before Hon'ble court. Hon'ble XIII Special Metropolitan Magistrate of Secunderabad sentenced the accused to undergo 8 days of imprisonment.

Two notorious men caught red-handedly, who were passing lewd comments and stalking women at NTR Gardens imprisoned

Two men were observed stalking and passing lewd comments on girls who were at NTR Gardens, Hyderabad. SHE Teams who were on duty in mufti vigilantly recorded the incident and arrested them. With the recorded evidence the two men Mohd. Hussain S/o Mohd. Shafiq, 20 yrs and Abdul Shaif S/o Abdul Aziz, 20 yrs were produced before the court of law. Hon'ble XI Special Metropolitan Magistrate, Nampally has sentenced 5 days of imprisonment to both of them.
