ARREST OF NOTORIOUS VEHICLE THEFT OFFENDERS

On credible information, the **South Zone Crime Team** apprehended vehicle theft offenders by name **1)** Syed Ahmed S/o late Syed Javeed aged 30 years, occ: Auto Driver r/o Near VIP School Shaheenagar, Balapur, Hyderabad who is involved previously in vehicle theft cases in the limits of Pahadishareef, Chandrayangutta, Hayathnagar, Vanastalipuram, Ibrahimpatnam, Machal, Yacharam, Kandukur and Boinpally PS, **2)** Syed Omer S/o Syed Jahangir aged 22 years, occ: Driver r/o Near Kalapather PS, Hyderabad who is involved previously in vehicle theft case in the limits of Rajendra Nagar PS and **3)** Shaik Ameer s/o Shaik Moosa, age 21 years, occ: Pvt Job r/o Near Rahamaniya Masjid Aliabad, Shalibanda, Hyderabad who in involved in vehicle theft in Market PS.& **4) Jaffar r/o Shaheenagar (absconding)**

**BUSTED HAWALA RACKET – HELD FOUR PERSONS –
SEIZED AN AMOUNT OF Rs. 1,10,73,400/-**

The sleuths of, Commissioner's Task Force, South Zone Team, Hyderabad along with Shainayathgunj Police apprehended four accused who operating Hawala in and around the Hyderabad city. Total seized unaccountable amount of Rs. 1, 10, 73,400/- and Four mobile phones from their possession.

Details of the accused:

- 1) Kamlesh, Age: 47yrs, Occ: Plastic Business, R/o Goshamahel, Backside Bachpan school, Shainyathgunj, Hyderabad.
- 2) Ashok Kumar, Age: 35 Yrs, Occ: Worker In Plastic Shop, R/o Goshamahel, Backside Bachpan school, Shainyathgunj, Hyderabad.
- 3) Rahul Agarwal, Age: 28 Yrs, Occ: Steel Business, R/o MehndiGalli, Ghansi Bazar, Hyderabad.
- 4) Ratan Sing, Age: 25Yrs, Occ: Worker In Plastic Shop, R/o Goshamahel, Backside Bachpan school, Shainyathgunj, Hyderabad.

Modus operandi :-

The main accused Kamlesh Kumar is resident of Chudibazar and doing plastic bag business at Begumbazar, Hyderabad. In his business he is not getting enough profit, so he hatched a plan to run Hawala in and around the city. For that, he shared his plan with Rahul Agarwal, he also agreed to do Hawala Business. Kamlesh Kumar arranged workers Ashok Kumar and Ratan Sing for collection and delivery to the customers.

Brief facts of the case:

Basing on credible information, on 20-10-2022, in the evening South Zone Task Force team along with Shainayathgunj Police conducted vehicle checking at M J Bridge, Jummerath bazaar. Meantime, stopped one Chevrolet spark car AP 09 BJ 9076 in a suspicious manner and checked the vehicle. While checking the vehicle found huge amount in a black polythene cover. On questioning they did not replayed any satisfactory answer with regards to the amount.

The apprehended accused and seized Unaccountable Cash handed over to **SHO Shainayathgunj PS** for further investigation.

**Cr No 273/2022 U/s 448,427,307 r/w 34 IPC, Sec 25(1)(A) of
Arms Act of PS Bahadurpura, S/z, Hyd city**

Brief facts of the case:

On 17th Oct 2022 at 2100 hrs Sri Pruthu Mehta, r/o. Plot No 57, Rail Enclave, Sikh Road, Bowenpally, Sec-bad complained that on 17th Oct 2022 at evening hrs the A-1 **Mohammed Iftekhar Ahmed @ Iftekhar** trespassed into complainant Indian Oil Petrol Pump at near Devibagh Temple, Bahadurpura and forcefully filling Rs. 500/- petrol in his **Honda Active vehicle vide bearing number TS 12 EV 5552** and didn't pay the amount and argued with complainant employees, mean time A-1's friends i.e. A-2 **Mohd Yousuf @ Nagesh** and his relative A-3 **Syed Suleman** were came to the petrol pump and A-1 & 2 shown the Toy pistol & Knives to complainant and his employees, threatened to Kill them and broken the petrol pump office glasses and damaged the furniture, then complainant and his workers were tried to stop A-1 to 3, but the accused persons didn't stopped and abused them in filthy languages, beaten to complainant and his employees with their hands and legs, due to fear the complainant and his employees were escaped from the Petrol Pump.

Motive:

The **A-1 Mohammed Iftekhar Ahmed @ Iftekhar** trespassed into complainant Indian Oil Petrol Pump at near Devibagh Temple, Bahadurpura and forcefully filling Rs. 500/- petrol in his Honda Active vehicle vide bearing number TS 12 EV 5552 and didn't pay the amount and argued with complainant employees, mean time A-1's friends i.e. A-2 Mohd Yousuf @ Nagesh and his relative A-3 Syed Suleman both were came to the petrol pump on Splendor plus two wheeler vehicle vide bearing number AP 13 J 1582. The A-1 & 2 shown the Toy pistol & Knives to complainant and his employees, threatened to Kill them and they broken the petrol pump office glasses and damaged the furniture, then complainant and his workers were tried to stop A-1 to 3, but the accused persons didn't stopped and abused them in filthy languages, beaten to complainant and

his employees with their hands and legs, due to fear the complainant and his employees were escaped from the Petrol Pump and brought to Bahadurpura Police person, after noticed the police person A-2 & 3 both were escaped from the Petrol Pump on A-2's vehicle. In this incident A-1 had received severe bleeding injuries to his right hand and Bahadurpura Police shifted him to Grace Hospital, Bahadurpura for treatment.

Criminal History of A-1 & 2

The **A-1 Mohammed Iftekhar Ahmed @ Iftekhar** is working in Uber & Ola as a Driver and residing at Falaknuma & Tappachabutra PS Limits. He always kept one Knife from his pant pocket which is used for himself protection from his rivals and also to extort money from the foot path vendors, shopkeepers of locality. He was committed property offences in the limits of Hyderabad & Cyberabad commissionerate police stations. In the year 2015 the Humayun Nagar & In the year 2020 Mailardevpally police person were applied PD (Prevention & Detention) Act proposal against him and remanded to judicial custody, after completion of PD Act period released from Jail, Though he didn't change his mind set.

The **A-2 Mohd Yousuf @ Nagesh** is working in petrol pump and residing at Bahadurpura & Tappachabutra PS Limits. He always kept Toy Pistol & Knife from his pant pocket which is used for himself protection from his rivals and also to extort money from the foot path vendors, shopkeepers of locality. He was committed property offences in the limits of Tappachabutra, Shahiyanathgunj, Manghalhut & Chaderghat PSs. In the year 2015 & 2021 the Tappachabutra police person was applied PD (Prevention & Detention) Act proposal against him and remanded to judicial custody, after completion of PD Act period released from Jail, though he didn't change his mind set.

The A-1 & 2 were arrested on 20th Oct 2022 and seized the above property from the SOC & possession of A-2 which were used in the commission of offence. The arrested A-1 & 2 are being produced before the Hon'ble Court for their judicial remand.
