The Cyber Crime PS, Hyderabad has apprehended an accused person name Jamsed SK R/o West Bengal who indulged in circulating / sharing the Child sexual abuse material in Facebook and other social media and it was become viral.

# FACTS OF THE CASE:

On 23.12.2020 at 1210 hours received a complaint from Inspector of Police, C.ID., T.S., Hyderabad, which reads as "with an aim to proactively gather information about circulation of Child Sexual Abuse Material (CSAM) in web space, National Crime Records Bureau (NCRB) on behalf of Government of India has signed a Memorandum of Understanidng (MOU) with National Centre of Missing and Exploited Children (NCMEC), USA on 26<sup>th</sup> April, 2019 to receive Cyber Tipline Reports as approved by Union Cabinet. These Cyber Tipline Reports contain details of circulation of CSAM as reported / alerted by different Organizations / Individuals. NCRB receives such reports from NCMEC and in turn forward to States/UTs in India basing on jurisdiction for taking action as per law.

As per the contents of the above complaint, a case in Cr. No. 2488/2020, U/Sec 67 B I.T. Act was registered at CCPS, D.D., Hyderabad and took up the investigation. Further a team was made strenuous efforts and preceded to Bangalore and apprehended the accused and brought him to CCPS, Hyderabad and sent for Judicial Remand.

#### PRESS NOTE ON FEDEX PARCEL FRAUD

Hyderabad Cyber Crime Police arrested a accused Lady person Aged about 31 yrs R/o Chennai, Tamilnadu, who providing the bank accounts to the cyber fraudsters on commission basis to cheat the innocent people.

# FACTS OF THE CASE:

Complaint received from victim R/o Asif Nagar, Hyderabad stating that the Cyber fraudsters gave him message through whatsapp & Telegram applications and cheated on the pretext of part time job to work from home where they have to like and subscribe the YouTube video's and made him to invest the money and collected an amount of Rs. 5,84,000/- and cheated.In this regard the Cyber Crime Police, Hyderabad registered a case in Cr. No. 2442/2023, U/s 66(C),(D) IT Act & Sec 419,420 IPC and investigated in to.

#### MODUS OPERANDI OF ACCUSED:

The accused lady aged about 31 yrs colluded with Cyber fraudsters and cheated the innocent people on the pretext of part time job to work from home where they have to like and subscribe the YouTube video's and made him to invest the money. For committing these cyber frauds, the accused provided bank accounts to the cyber fraudsters to cheat the innocent people. The accused lady aged about 31 yrs has opened Bank account on her name and provided same to one lady who got introduced with her in telegram on 10% Commission which was used for transaction of fraudulent amount. Similarly, the accused committed fraud about Rs. About 10 Lacks in single account, for which one more case was registered in other State.
