### ARMED ROBBERY ATTEMPT THWARTED BY BRAVE INMATES

On 21-03-2024 at about 01.00 PM, two accused persons by name Sushil Kumar & Premchandra who hails from Kanpur of Uttar Pradesh, made a vain bid to rob a family in the Begumpet P.S. limits. The duo hatched a plan to rob the house, made a recce prior to the attempt and selected the house. As part of hatched plan Sushil called Smt. Amita Mahnot (who is the house owner) and informed her that they brought a courier, the in the name of N.K.Jain. As such her servant went down to receive the courier, the duo who covered their faces one by (Susil) wearing helmet and another Prem Chandra was wearing face mask & Cap entered into the house forcefully with an intention to rob the house. Later the accused Premchandra directly went into the kitchen and threatened the maid servant by keeping the knife on her throat. As such there was a brawl that took place between the minor girl (who is daughter of the Amita) and Sushil, in the meantime Amitha also interfered in a bid to thwart the robbery attempt. During the brawl Sushil took out the country made Tapancha from his bag and tried to point out at both the mother and daughter, Amita who is well aware of the martial arts kicked sushil and snatched the Tapancha from the hands of Sushil. On receiving the blows & kicks, Sushil managed to flee away from the house. And the second person who was inside the house was not aware of the outside scene. As such, surrounding people who heard the hue and cry from the house, managed to catch hold of the second person who was inside the house.

## The property seized:-

- 1) Ropes,
- 2) One Tapancha weapon,
- 3) One Rubber Bullet shell,
- 4) Two Knifes and
- 5) One Gift paper box.

## **ACCUSED PARTICULARS:-**

The accused person **A-1 SUSHIL KUMAR**, N/o. Kanpur, U.P. and **A-2 PREMCHANDRA**, N/o. Faridpur, Uttar Pradesh, now residing at M S Maqtha being produced before the Honourable XI ACMM Court, Secunderabad for judicial remand.

It is pertinent to state that the bravery shown by both mother Amitha and her daughter are exemplary and but for their courage and confidence, they could thwart the robbery and could catch one of the accused red-handedly with the help of neibhour. I appreciate the mother and daughter for displaying such bravery.

On receipt of the complainant a case has been registered under various provision of IPC and Arms Act. The case is being investigated by Sri. M. Mallesham, Detective Inspector of Police, Begumpet P.S., under supervision of Sri. P. Gopal Krishna Murthy, Asst. Commissioner of Police, Begumpet Division and under the guidance and Smt. Rohini Priyadarshini, D.C.P. North Zone, Hyderabad City Police.

# BUSTED ADULTERATED GINGER GARLIC PASTE MANUFACTURING UNIT-SEIZED 1300 KG GINGER GARLIC PASTE, TITANIUM DIOXIDE & XANTHUM GUM WG 20 KG- ALL WORTH RS. 1.7 LAKHS.

On 22-03-2024, on credible information, the Commissioners Task Force, **East Zone Team** Conducted raid on Adulterated Ginger Garlic paste manufacturing unit at Lalapet, secunderabad and apprehended one person by name **Neela Venakateshwarlu** who was found in preparing Ginger Garlic paste by mixing Titanium Dioxide and Xantham Gum as ingredients- Seized 1300 KG of Adulterated paste, Titanium dioxide & Xantham gum wg about 20 KG.

### **ACCUSED DETAILS**

**Neela Venakateshwarlu,** S/o Rajaiah, age: 54 yrs, Occ: Business, R/o H.No. 12-1-514, Flat No. 210 Janapriya Apts, Lalapet, Secunderabad..

### SEIZED PROPERTY.

- 1) 1300 KG of Ginger Garlic paste.
- 2) Titanium Dioxide and Xanthum Gum wg about 20 KG.

All worth Rs. 1,70,000/-

#### **BRIEF ABOUT CASE:**

Respondent by name **Neela Venakateshwarlu** is a supplier of Ginger Garlic paste in an around Hyderabad City, he used to deliver branded company Ginger Garlic paste to various retailers in the market, the income earnings from this source is not meeting to his personal expenditures. So he hatched a plan to manufacture Ginger Garlic paste by using various components like Titanium Dioxide and Xantham Gum at H.No. 12-1-514, Flat No. 210 Janapriya Apts, Lalapet, Secunderabad. He is mixing these components as ingredients and making adulterated Ginger Garlic paste and selling in the open market by pretending the paste as original and more particularly natural. Likewise he is supplying the material to the petty vendors in an around Hyderabad and gaining money illegally. Earlier he was apprehended by Lalaguda Police and Food Safety officer, GHMC, Hyderabad for same violation.

<u>Mixture of Titanium Dioxide</u>: Titanium Dioxide chemically termed as TiO<sub>2</sub> generally it is used for a century in a range of industrial and consumer products, including paints, coatings, adhesives, paper, plastics and rubber, printing inks, coated fabrics and textiles, as well as ceramics, floor coverings, roofing materials, cosmetics, toothpaste, soap, water treatment agents. This chemical is being used by the accused person to bring brightness to the Ginger Garlic paste to attract the consumers.

<u>Mixture of Xantham Gum</u>: Xantham Gum is being using for stiffness of the Paste, this gum is act as bridge between paste and water released from the paste.

Exposure to the Titanium Dioxide and Xantham gum may causes harmful to the human body i. e Irritation of Eyes, Nose and throat since it has been shown to cause lung cancer in animals.

The above apprehended person along with seized property were handed over to **Food Safety officer, Circle No-29 GHMC, Hyderabad** for taking necessary action.

In this regard a case has been registered against respondent vide in 014/29/02321/GHMC/2024.
