NABBED THREE HEROIN DRUG PEDDLERS - SEIZED 07 GMS OF HEROIN, (03) CELL PHONES AND ONE BIKE

On 16-04-2024 on credible information the Commissioners Taskforce East Zone Team along with Gudimalkapur Police nabbed 03 drug peddlers who were found in possession of Narcotic substance i.e. Heroin near Cost to Cost Shoe shop, Rethibowli X Road, Hyderabad- seized 07 grams of Heroin Drug from their instances.

Facts Of The Case:

The prime accused **Man Singh Batala** is aged 30 years residing in Mehdiapatnam, Hyderabad and he studied upto graduation and started his carrier as a chef, he used to meet his college and school friends regularly and observed that his seniors were consuming Ganja and got attracted and started consuming Ganja, while so, he later was involved in 02 cases one Bodily and property case and lodged in Chanchalguda Jail, after releasing from Jail he came into contact with his Childhood friends namely **Syed Obaid** and **Shabbar Hussain** who were residents of Towlichowki and Langarhouse areas and hatched a plan to procure contraband to gain profits and spend income to their lavish expenditures. Accordingly they collectively accumulated amount of Rs. 10,000/- and started finding drug supplier. In this juncture Man Singh came into contact with one Nigerian National residing in Bangalore who is a supplier of Heroin, on 13-04-2024 Man Singh proceeded Bangalore and met Nigerian National in Yeshwanthpur and procured 07 gms of Heroin. In return he contacted Syed Obaid and Shabbar Hussain to collect drug near Cost to Cost shoe shop, Rethibowli X Road, Hyderabad.

Acting on the tip-off the Commissioners Taskforce East Zone team along with Gudimalkapur Police apprehended trio who were found in illegal possession of contraband i.e Heroin drug. The above apprehended persons along with seized property were handed over to **SHO Gudimalkapur PS** for taking necessary action.

Mohd Khaleel @ Kanna S/o. Mohd Mahboob, age: 23 years, Occ: Driver, R/o. Asad
Baba Nagar, Kishan Bagh, Hyderabad.

➤ Motive Behind Murder.

A petty meaningless skirmish which leads to this homicide. The
deceased, Mohd Khaleel @ Kanna, age: 23 years was a resident of Asad Baba
Nagar. The deceased and A1 to A5 were friends and resides in same locality of
side by side lanes of Asad Baba Nagar. On 15-04-2024, while the deceased and
A1 were consuming liquor in Musi Nala near Asad Baba Nagar, the deceased
abused and beaten to the Boy Juvenile (who is close friend of A1), upon which

A1 intervened into the matter and used filthy language against deceased person. They dispersed from the place, and A1 to A4, along with Boy Juvenile gathered at syntex water tank near Fakhiri Basthi corner. There, A3 instigated A1 & deceased to fight each other by teasing them, than A1 and the deceased got quarreled and beat each other. In the meantime, local people and deceased inmates were got interfered and breakup their fight and informed to police and the accused persons fled from the spot and gathered at the house of A5) Syed Akbar. As A1 felt humiliated in front of his friends, A1 along with A2 to A5 and BJ decided to eliminate the deceased person. A1 instructed BJ to get the knife from his house, and on instruction said BJ went to the house of A1 and brought the knife on A4's vehicle. A1 concealed the knife on his back and went on A4's bike near Zam Zam Hotel, Asad Baba Nagar and A2, A3, A5 and BJ followed A1. A1 noticed the deceased was lying on main road. There A1 and A2 quarreled with the complainant and A1 took out the knife from his waist and stabbed over the body of deceased with knife. As a result, the deceased received bleeding injuries and succumbed to injuries. After committing the offence the accused persons fled away from the scene.

➤ Arrest.

The Bahadurpura police team through their available sources identified the accused person and arrested.

Smt. P. Pushpa Latha, Honourable Special Sessions Judge for POCSO, HACA Bhavan, Nampally, Hyderabad, has convicted the accused person K. Nitish Singh, Aged 20 years, U/sec. 366, 376 (2)(n) IPC, Section 5 r/w 6 of PoCSO Act 2012 to undergo Rigorous Imprisonment for 20 years and to pay a fine of Rs.5,000/- and awarded compensation of Rs. 2,00,000/- to the victim girl through DLSA.

The parents of the victim have 3 children, and the victim girl aged 17 years is the youngest daughter. The accused resided in the same locality of the victim. He groomed her and gained confidence of the victim. Accused Nitish, inspite of knowing that the victim is minor, he sexually abused the victim forcefully several times by threatening her. On 5.03.2018, after school hours, victim came home late on questioning by the mother, she revealed that she revealed the above facts. Mother complained to Nallakunta PS and the case was brought to Bharosa for 161 CrPC statement recording.

Upon the receipt of this complaint, K. Mahender CI of Nallakunta Police Station registered FIR in Crime No. 44/2018 U/sec. 366, 376 (2)(n) IPC, Section 5 r/w 6 of PoCSO Act 2012 and Sri. J. Narasaiah, ACP, Kachiguda Zone, took up the investigation. After thorough enquiry, filed charge sheet accordingly.

The Bharosa Centre has facilitated the victim family in Counseling, Medical support, Legal support, financial support, Submission of documents for Compensations, apart from home visit by Bharosa staff. Bharosa team encouraged the victim for further studies during follow-ups. At the time of case registration, Bharosa team supported her emotionally & psychologically and she secured 8.7 GPA in 10th Standard. She has now completed her Degree and is aspiring for job.

During the 164 court briefing and court trials, the admin, counselor, support person, conducted mock court was also done so that the victim feels more comfortable while facing the judge. The concerned efforts by the Investigating Officers, K. Mahender CI of Nallakunta Police Station & J. Narasaiah, ACP, Kachiguda Zone, Sri. Prathap Reddy, Public Prosecutor, Smt. Kalpana, Legal Support Officer – Bharosa, Other Bharosa Team and Court Duty Officer by name Sri. B. Gopi, PC 9702 of Osmania University PS contributed immensely during the course of trial which ended in Conviction, being awarded by Smt. P. Pushpa Latha, Honourable Special Sessions Judge for POCSO, HACA Bhavan, Nampally, Hyderabad.

The concerted efforts of Police Officers and Officers at Bharosa Centre were closely monitored by Smt. D Kavitha, DCP, Women Safety, Prasanna Lakshmi, ACP, Women Safety, Hyderabad apart from T. Jyothsna, Inspector Bharosa and Mary Augustine, Centre Administrator.

Sri. K. Sreenivasa Reddy, IPS, CP Sir Hyderabad, appreciated the efforts of all the stake holders for their efforts and coordination.
