Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued P.D. Orders against Mohammed Mansoor @ Kala Kavva @ Deva S/o Late Mohammed Nazeer, Property Offender of Afzalgunj Police Station on 5.7.2018.

Mohammed Mansoor @ Kala Kavva @ Deva S/o Late Mohammed Nazeer, aged about 42 years, Occ: Auto Driver, R/o H.No. 16-62-1/2, Huba Colony, Shaheen Nagar, Pahadi Shareef, Ranga Reddy District has committed offences of **theft of mobile phones from the people travelling in RTC buses and sharing auto rickshaws in the limits of Hyderabad Police Commissionerate** to make easy money and to lead a lavish life.

The detenu has committed 13 **property offences** under the limits of Hyderabad Police Commissionerate and has been creating large scale fear and panic among the general public, thereby adversely affecting the public order, apart from disturbing the peace, tranquillity and social harmony in the society.

Afzalgunj Police made strenuous efforts and arrested the detenu Mohammed Mansoor @ Kala Kavva @ Deva on 29.12.2017 in Cr.No.445/2017 U/s 379 IPC of Afzalgunj PS and remanded him to judicial custody. The Preventive Detention Order was executed on him on 23.11.2018 and he was lodged in Central Prison, Chanchalguda, Hyderabad.

MODUS OPERANDI:-

The main accused **Karri Satti Babu @ Satish** is a habitual House Burglary offender. Frequently shifts his shelter from one area to another area to avoid Police surveillance. He identifies posh colonies and "**Recce**" the house, intended to commit theft. He carry screwdriver, Iron rod, Cutting player, Face cover mask, hand glove, Torch light along with

him which were used in the commission of offence. He remove the window bolt or grill screws with screw driver, cutting player and remove the grill of the window, in some cases break open the lock and commit theft of Gold ornaments, cash etc., and sometimes fled away in the car of house owner. While committing offence his associates Narender Naik accompany him during offence & Pacchapati Srinivas observe the surroundings in order to alert him and fled away with the car along with stolen property. The booty amount used to spend for luxurious life.

➤ **BRIEF HISTORY OF ACCUSED PERSONS :**

The main accused **Karri Satish @ Satti Babu** n/o Vishakhapatnam, AP. Presently residing at Nandanavanam, Meerpet, Cyberabad. He is offender of habitual H.B by night. Previously involved in **(48) H.B by night** cases including 4-Automobile theft cases i.e **1).Vishakapatnam -17, 2)Kakinada town-01, 3)Vijayawada-05, 4)Vijaya Nagaram town-01, 5)Hyderabad City-6 & 6)Suryapet Town-06 & Bangalore-02.**

Hyderabad City Police has invoked **PD Act** against him on 02-12-2016 and lodged in Central Prison, Chanchalguda. After completion of detention period and conviction period he released from Jail in the month of September-2017. During the imprisonment at chachaguda jail he came into contact with offenders Pacchapati Srinivas, Nunsavath Narendar Naik @ Nari and committed House burglaries.

The accused **Nunsavath Narendar Naik**, n/o Nalgonda Dist. Presently residing at Nandanavanam, Meerpet. Previously involved in (13) Cases i.e Ordinary theft & Chain snatching cases in the limits of Hyderabad, Cyberabad, Devarakonda and arrested by Hyderabad Police in the month of Feb-2017 and lodged in chanchalguda jail. In the month of Dec-2017 released from Chanchalguda Jail and associated with main accused Karri Satish.

The accused **Pacchapati Srinivas**, n/o Kadapa Town, A.P.State. Previously involved in **16 cases** in the limits of Hyderabad, Rachakonda & Kadapa Dist. Hyderabad City Police has invoked **PD Act** against him during September-2016, after completion of detention period released in the month of March -2018 from chanchalguda jail and associated with main accused Karri Satish.

The accused **Sudheer Kumar Reddy** n/o Kadapa Dist, Andhra Pradesh and friend of Pacchapati Srinivas. He used to receive stolen property from accused persons and dispose off on commission basis.

- The sending of inappropriate (vulgar) messages and prank video calls from several numbers; has landed a person by name Boyini Raju S/o.B.Ramesh, age.20 yrs, Occ.Labour r/o.Vikarabad; in jail for (2) days and with a fine of Rs.200/-. The victim is unknown to the accused but he has been harassing her for fun. The judgement was given by the Hon'ble court u/s 70(c) of Hyderabad City Police Act and 290 IPC ;in a case produced by SHE Teams on 26-11-2018.

- In another case, two culprits were produced before the court by the SHE Teams based on a complaint from a victim that they have been sexually harassing and threatening her over phone. The culprits have been calling the victim at odd hours in the night and talking incoherent things in a drunken state. INTERNATIONAL DRUG PEDDLER NABBED - SEIZED (20) GRAMS OF COCAINE

On 26-11-2018, the sleuths of Commissioner's Task Force, West Zone Team nabbed one Citizen of Sierra Leone, West Africa who found in possession of Narcotic substance/Drug i.e. **Cocaine** in order to deliver the same to needy customers. Seized **(20) grams of Cocaine, (1) Black colour bag, (1) Maestro Bike B.No.TS08FB 2693 and (2) Cell phones** from their possession.

Details of Accused persons:

1. Anold Martians Donlock @ Nwankwo S/o Anold @ Jeremiah, aged 28 yrs, Occ: Working in Cargo, Mumbai, R/o H.No.9-4-136/114, 3rd Floor, Jamali kunta, Quli Qutubshahi Colony, Golconda, Hyderabad, N/o Free Town, Sierra Leone, West Africa.

Brief about the accused persons:-

The accused Anold Martians Donlock @ Nwankwo is native of Free Town, Sierra Leone country. In the month of July-2016 he came to India on Tourist VISA and stayed at Mohammed Ali Street, Mumbai and doing Cargo Cloths business. In the month of October-2017 he came to Hyderabad and residing at Flat No.501, H.No.8-2-603/17, Road No.1, Zaheera Nagar, Banjara Hills, Hyderabad along with his friends. From there he changed his address to Quli qutubshahi Colony, Golconda, Hyderabad.

Modus Operandi:

On interrogation, it is revealed that Nigerians use one of their local dialects to communicate with one another and have established a drug network all over India, especially in metropolitan cities.

In the month of July-2016, the accused Anold Martians Donlock @ Nwankwo came to India on Tourist VISA and stayed at Mohammed Ali Street, Mumbai and doing Cargo Cloths business. He used to visit night pubs every weekend and consume drugs such as Cocaine. Also he observed that some of their Nigerian nationals are purchasing Cocaine from unknown persons on lowest price and selling the same to needy customers in Hyderabad on higher price and getting profits for their lavish expenses. As such he also hatched a plan to sell the Cocaine to the needy customers in Hyderabad. In the month of October-2017 he came to Hyderabad and residing at his friend's room at Flat No.501, H.No.8-2-603/17, Road No.1, Zaheera Nagar, Banjara Hills, Hyderabad and hatched a plan to sell the Cocaine in Hyderabad by purchasing from an unknown persons at Mumbai. In this process in the month of February-2018 he was arrested in Cr.No.107/2018 U/s 8(C) r/w 20(b) of NDPS Act-1985 and Sec.14(A) of Foreigners Act of Banjara Hills PS, Hyderabad. He was also arrested by Golconda PS vide Cr.No.Cr.No.182/2018 U/s 14(a) of Foreigners Act 1946 for his illegal staying in Hyderabad and sent to judicial custody.

After releasing from jail he changed his address to Quli Qutubshah Colony, Golconda, Hyderabad and he did not change his attitude and started selling the Cocaine in Hyderabad to the needy persons. He is purchasing Cocaine from unknown persons at Mumbai for Rs.2,000/- per 1 gram and used to sell the same in Hyderabad for Rs.6,000/- per 1 gram to the needy customers.

ARRESTED THE TATUL BAAJI GANG A1) KURSHEED AHMED @ RAHUL @ IMRAN AND A2) SALEEM @ SALEEM KHAN @ SALMAN AND SEIZED TWO MOBILE PHONES FROM A1 AND ONE MOBILE PHONE, FAKE GOLD WG. ABOUT 500 GRAMS AND SAMPLE SMALL GOLD PIECE FROM A2

A Police team of Central Crime Station arrested the accused A1) Kursheed Ahmed @ Rahul @ Imran and A2) Saleem @ Saleem Khan @ Salman, who are indulged in luring gullible public on guise of gold at cheaper rate explaining that they got gold bar while digging in their agricultural fields and stating that if they sell it in Rajasthan there would be police problems. Therefore they wanted to sell the same out of Rajasthan and asking them to come to their village with amount for taking delivery. After coming to their place they would rob them and threaten the victims not to complain to Police. There is information that accused have lured people from other states.

Brief facts of the case :

On 23-09-2018 at about 11.20 am the complaint received a call to his mobile number from the accused A1) Kursheed Ahmed @ Rahul @ Imran mobile number 8058392497 stating that he is a poor man and calling to this number because he is in possession of 5 KGs of gold and he is willing to sell at cheaper rate than the market price as he needs urgent money. On suspicion Sri Ali Mohammed Sarfaraz, S/o. Nawazuddin, aged 52 yrs, lodged a complaint for taking necessary action as per law. Basing on the complaint a case in Cr.No.166/2018 U/s.420, 511 IPC at CCS, DD and took up the investigation. As per the instructions of the Dy. Commissioner of Police, CCS, Sri G. Girsh Rao, Inspector, Sri B. Sravan Kumar, SI and staff proceeded to Rajasthan State to apprehend the accused. They arrested the accused on 23-11-18 at 7.15 P.M. at Kishangarh Bas Town of Alwar Dist of Rajasthan State and brought them to CCS, Hyd on transit remand on 26-11-18 and being produced before the Hon'ble Court at Nampally. These gangs are known as "Tatlu Bajis" and lure people in the name of buying or selling gold, electronics, vehicles, scrap etc at lucrative prices. When potential customers go to there areas, usually districts of Alwar (Rajasthan), Madhura (UP) and Nuh (Haryana) and other nearby districts, they are robbed of cash, belongings, ATM cards as even held for ransoms. Such gangs have been apprehended by CCS in the past.

The I.O. of the case Sri B. Sravan Kumar, Sub Inspector of Police of G Division, under the supervision of Sri M.A. Bari, Addl. D.C.P, Sri B. David, ACP and Sri G. Girish Rao, Inspector of Police, with a lot of efforts and with the assistance of staff HC.8222 Sri K.Ch. Naidu, HC.8748 Sri R.Praveen Kumar, PC.5961 Sri S.Achaiah Yadav of CCS, Hyd apprehended the above accused.

COCAINE:

It is also called coke, flake, Charlie and snow, is a crystalline alkaloid obtained from coco leaves. It resembles white powder and is usually divided into lines on a smooth surface and snorted using a rolled up currency note or a straw. It is a stimulant for the central nervous system. Cocaine is bad for anybody with high blood pressure or a heart condition. Price: Rs 5,000-10,000 for 1 gm. The international drug mafia brings cocaine into India from South America via Hong Kong.
